 - A. Executive Director attended the OPA meeting on Tuesday, May 24, 2016 and gave a report on the following items:
 - i. Discussed Office of Policy Analysis (OPA) 3-29, Policy on Policy, which used to be Policies and Procedures Review Board (PPRB) 3-65.

- ii. When 3-29 came to OPA, it was suggested that changes authored by Miriam Verploegh, be added such as data collection and best practices.
- iii. Bill Slausen with Albuquerque Police Department (APD) and Jenica Jacobi with City Legal will be attending the Police Oversight Board (POB) Meeting on June 9, 2016 to clear up any misunderstandings on policy.
- iv. Policy 3-29 was approved by the Department of Justice (DOJ) and will be open for review in six months.
- v. At the next OPA meeting, the Use of Force policy will be open for the first reconsideration.
- vi. OPA meetings will be open to the public for general comment and a public input form will be distributed. The citizen will get feedback if the policy was accepted, rejected and why it was rejected.
- vii. Director Harness recommended to OPA that the citizen give the input form on policy to the Citizen Policing Council (CPC). The Police Oversight Board (POB) will be cc'd of those policy recommendations. See Attachment "A" for Policy Recommendations to the Office of Policy Analysis form.
- viii. Celena Espinoza with APD will be handing out the public input forms at the next CPC meeting.
 - ix. An entire policy can be requested in a word version in order redline the revisions and then send it into them.
 - x. APD to hire a Deputy of Communications person in order to help Celena Espinoza in the facilitation of the CPC's. Otherwise, the DOJ may contemplate that the CPOA facilitate the CPC's.
- xi. Member Mohr suggested that we contact City Council between now and January to request a different flat percentage rate for the CPOA budget in order to allow for growth.
- **B.** Miriam Verploegh, CPOA Analyst gave her report on OPA.
 - i. OPA is allowing for stakeholders to come in and weigh in on the Use of Force policy. Ms. Verploegh to attend every OPA meeting and bring a list of stakeholders.
 - ii. There is spot at OPA for a POB member to be a stakeholder.

- vii. Ms. Verploegh discussed the need for data access from APD.
- viii. Ms. Verploegh and members discussed the potential variables to request data from APD. See Attachment "C."
- ix. Members discussed writing a memorandum or letter to give data access to Ms. Verploegh and to collect demographic data on traffic stops.
- x. Members discussed items 2 through 6 of the Ms. Verploegh's summary report.
- xi. Members discussed that Mark Baker set up a meeting with the City and the City Attorney's office before the September 27th review of the On Body Camera policy.

- A. Director Harness discussed that he has not received a response letter from the Chief of Police regarding the letter the POB on April 18, 2016 in reference to the Use of Force Policy.
- B. Members discussed that Director Harness and Attorney Mark Baker discuss the "feasible" at the POB Meeting.
- C. As next steps, Director Harness recommended that the POB address City Council if the Chief does not respond to their inquiries.
- D. Discussed that the POB do a follow up letter to City Legal and HR to clarify the drug testing policy for officers who are involved in firearm discharges.
- E. Director Harness recommended that the following be agenda items for the full board to act on, they are:
 - To do a follow up letter addressed to the City Attorney and Human Resources regarding substance abuse policy for officer involved firearm discharges;

Summary Report: Policy and Procedures Subcommittee Miriam Verploegh: Data Analyst CPOA

- 1. Potential Variables to request from APD
 - Document describes data the CPOA would like to have access to.
- 2. Policy on Policy:
 - The CPOA discussed the potential for a Policy on Policy with OPA
 - The CPOA drafted a document outlining the Policy on Policy which would:
 - work to incorporate best practices, model policy, state law, general guidelines, and research.
 - o provide policy writing process with an agreed upon template
 - o provide a space for assessment and revision on the back end.
 - Provide a description of mission and responsibilities of current policy writing bodies.
 - Draft document of Policy on Policy is enclosed along with two documents outlining important ideas for effective policy writing.
- 3. On Body Camera System Policy and Decision Tree
 - A draft decision tree was compiled with some potential ideas for when officers should use
 their camera, when they can use their camera, and when they should not use their camera.
 - Recommendations from the UNM OBCS study are summarized. Recommendations not in the current policy are highlighted.
 - · Copy of current OBCS policy is attached.
- 4. Collection of Demographic Data in Traffic Stops:
 - Why there is a need to collect demographic data: Over time, police leaders have come to recognize the existence of racially biased policing and the serious threat it poses to building strong relationships between police and the communities they serve. Police agencies have responded with a variety of strategies, including collecting and analyzing data on vehicle and pedestrian stops, targeted recruiting programs to increase diversity in recruit classes, accountability measures, training officers on implicit bias, mentoring programs, and community outreach units that focus on building relationships with every community in their jurisdictions. This paper addresses the possibility of collecting demographic data in pedestrian and traffic stops.

- 5. Recommendation for Use of Force Assessment
 - In accordance with the 6 month review from DOJ OPA is interested in looking into developing an assessment of UOF in the field rather than working to rewrite the policy. To address this need the CPOA has drafted a potential recommendation for assessment of UOF. This document includes:
 - The importance of assessment
 - o DOJ assessment requirements
 - Ideas for qualitative and quantitative assessment indicators that could be used to look at semiannual and annual assessment of use of force.

RE: After-Hours and Weekend Contact for Probation and Parole

Dear Chief Eden,
In order to facilitate the series in the series of the In order to facilitate the safe transfer of individuals for whom a warrant has been issued and given to the Albuquerque Police Department (APD) for transport back to a secure facility afterhours and/or weekends, the Police Oversight Board recommends the following:

1. APD maintains a liaison to the State of New Mexico's Probation and Parole office; the liaison would be APD's point of contact for field officers to report issues regarding the deployment of their duties with regard to executing warrants.

2. APD gets from the State of New Mexico's Probation and Parole office an after-hours and/or weekend contact number for APD field officers, which is staffed by an on duty employee (not automated or voice mail) in order to clarify orders or field officers to discuss the disposition of cases. The State of New Mexico's Probation and Parole office contact information should be kept current and given to APD's dispatchers who support

The issue of good communication and smooth transfer is especially critical in the case of juveniles for whom a warrant has been issued. The burden of completing the required paperwork and corroborating information on the orders for field officers is acute in the case of juveniles.

Overall field officers are doing their best to work cooperatively with probation and parole, but they are often faced with having to hunt for contact numbers, probation and parole officers, and/or a probation and parole employee who may take a call on behalf of the office. Gamering an empowered liaison and an agreement from the State of New Mexico's Probation and Parole office to be available after-hours and on weekends will benefit both APD field officers and the citizens they serve.
