

# 2020 ANNUAL REPORT

SOUTHWEST COMMUNITY POLICING COUNCIL



The Southwest Community Policing Council (SW CPC) began in 2020, on track to becoming an interactive meeting process to increase the communication and collaboration between the Albuquerque Police Department (APD) and Southwest Area Command (SWAC) residents and business owners.

The coronavirus pandemic prevented in-person meetings April through December. SW CPC held no meeting in April but planned an informal meeting via Zoom webinar for May to discuss with community leaders at the local level (*not a political forum*) problems the SW CPC faces in dealing with crime and fear in the far southwest corner of Albuquerque. The Next-Door app has constant chatter about the sound of gunshots, loud racing auto engines, “squealing” tires, speeding vehicles, and ATVs tearing up the neighborhood parks. In general, the residents do not feel APD is receptive to their concerns, do not believe APD does their job, nor do they think ABQ management cares about the SWAC residents and business owners.

The Lifeline Assistance smartphones with data packages are available to all low-income and homeless residents in ABQ. Many SWAC residents do not have transportation, fear driving in the dark, fear to leave their home after dark, have no childcare even though children are welcome at the meetings. The list goes on and on as to reasons residents do not attend the SW CPC meeting. A Zoom webinar would open attendance to all residents with a telephone. The goal was meetings with some people participating by webinars and asking questions as a part of the future in-person meetings.

Because of CPOA Executive Director Harness’s inaccurate statement that City Council Bill No. F/S O-17-55 applied to the SW CPC forbidding a “political forum,” he badgered the SW CPC Chairperson, Steve Schmidt, to cancel the May webinar. The fear of having his reputation tarnished by violating a city ordinance Mr. Schmidt, a religious leader, canceled the webinar. Mr. Schmidt found the new overseer, Edward Harness, to be suffocating, which would result in many disagreements about the role of the SW CPC. Mr. Schmidt’s resignation precipitated the resignation of Stephanie Griego and Teresa Marie Garcia. The result was SW CPC lost the most active members.

SW CPC was devastated by the loss of three members. The SW CPC had spent the previous eight (8) months building its membership

from two (2) members to six (6) members. SW CPC was the most diverse group in Albuquerque.

The SW CPC has endured two (2) years of turmoil, most of it not the council’s fault. That makes it exceedingly difficult to persuade APD to engage with the council to discuss constitutional community policing. This turmoil and constant “bringing new members up to date” on the policy and procedures made it feel like the SW membership had to hurdle a great wall during the year 2020. The result is SW CPC was unable to make any recommendations but did join in the citywide recommendation that the APD create a Standard Operating Procedure (SOP) for interaction between APD and CPCs.

The SW CPC goal remains to continue learning and growing into a group that bridges the chasm between the residents, business owners, and APD in the SWAC. Efforts to prevent domestic violence in all forms, including child abuse and sexual violence, to all peoples is a top priority for SW. SW is seeking resources for developing a message that will resonate with the mostly Hispanic residents in the SWAC. The council members want to demonstrate that constitutional community policing involves community members as active participants.

As the outreach advocate for the New Mexico Coalition Against Domestic Violence, **Teresa** can work with the Albuquerque Hispano Chamber of Commerce. This relationship resulted in networking and collaborations with active community members and sitting on several committees such as Health and Wellness Committee, Women To Be, S.A.F.E. House New Mexico fundraising, and the Albuquerque Sexual Assault Evidence Response Team (ASERT). Also, she is a Certified Pharmacy Technician.
