**MINUTES**

**1. Call to Order**

Vice Chair Estocin called the meeting to order with permission from Chairperson Poss and confirmed that a quorum was present.

**2. Approval of Agenda**

A motion to approve the agenda was made by Chairperson Poss and seconded by Commissioner Pontzer.

Motion approved unanimously.

**3. Approval of January 16, 2026 Meeting Minutes**

A motion to approve the January 16, 2026 meeting minutes was made by Commissioner Pontzer and seconded by Chairperson Poss.

Motion approved unanimously.

#### **4. Action on 2024 Indicators Progress Report**

Staff provided background on the 2024 Indicators Progress Report, noting that the current Commission did not participate in its development and expressed concerns about submitting the report without input.

The Commission agreed to submit the report to City Council with a statement clarifying that submission is to meet ordinance requirements and that the current Commission does not formally endorse the report's findings.

A motion was made by Vice Chair Estocin to authorize the Chair to submit the report with a cover letter. The motion was seconded by Commissioner Pontzer.

Motion approved unanimously.

#### **5. Discussion of Ordinance Update**

Chairperson Poss and staff provided an update on proposed ordinance revisions developed in collaboration with Results for America.

Key updates include transitioning to a dynamic public dashboard, providing flexible updates to Council, and allowing consultant support for reporting functions.

A motion was made by Vice Chair Estocin to affirm Commission support for staff efforts to advance the ordinance update. The motion was seconded by Chairperson Poss.

Motion approved unanimously.

#### **6. Discussion of 2026 Indicators Progress Report**

The Commission discussed its obligation to produce a 2026 report under the current ordinance. The Chair and staff will develop a draft work plan to present at the next meeting.
