 - i. Two year terms elected in October
 - ii. Subcommittees may operate without designated leadership and instead as a collective body
 - iii. Subcommittees do not have to comply with open meetings act unless it is going to meet quorum.
 - iv. Should specify that when quorum is met by the DVSA commission as a whole

- vi. Chair Garcia moved to approve new language about Subcommittees. Co-Chair Alipat seconded. Motion approved 7-0.

- g. Outreach to large employers for them to include DV prevention and education among their employees
- h. Survivor led groups and how to get funding for that
- i. Arthur Malone DVRC/CYFD talks about how we can improve accessibility for rural areas, specifically Tribal areas
 - i. APD, Shelters, ACS, CVRC, SANE, DVRC, RCC all have ability to assist with transportation barriers
 - ii. Can we bring in MaryEllen with the DV Coalition to assist with this?
