IV. Lodgers' Tax Board Quarterly Report Final Draft Review – Chair. City of Albuquerque Lodgers' Tax Advisory Board second quarterly report (FY'20).are required by ordinance to provide ongoing review and issue quarterly reports advising the Mayor and City Council on the expenditure of funds authorized by Section 3-38-15 NMSA 1978 for advertising, publicizing and promoting tourist attractions and facilities in the city. The report was included in the board packets and distributed in advance of the

meeting for edit and review. The example of successful use of previous incentive funds decided to use for the report was the current bookseller's conference.

• Opportunity Fund (Incentive Fund) Update Report. The LTAB recommends, with hospitality industry support, the creation of an incentive fund. The fund also referred to as a **Contingency for Promotions or Opportunity Fund** represents a portion of a two year estimate of revenue from the voluntary agreement between the City and Airbnb. The contingency is a new reserve intended to offset rental space, shuttle, and other incentive costs necessary to secure large convention bookings (defined as more than 650 rooms on peak hotel room nights) and hosted at the Convention Center. The most recent American Booksellers Association convention that occurred January 21-25<sup>th</sup> is an example of the benefits of the FY17 Opportunity Fund. Visit Albuquerque had been working the account for over a decade and the availability of the funds to help with shuttling and other competitive obstacles finally secured the group. The Convention Center alone brought in a direct spending impact of over \$1.1 million (determined on booking data) and upon arrival the group produced room nights far greater than expected in FY18.

- Welcome newest Lodgers' Tax Advisory Board member, Kara Grant. Ms. Grant's appointment to the Lodgers' Tax Advisory Board was confirmed by the Albuquerque City Council on Monday, January 7, 2019. Ms. Grant will serve as a Tourism Related Industry representative and her first term will expire August 1, 2021. She will replace Debi Owen, whose term expired August 2018.
