  - 2021 New Mexico Legislative Session Update
    - Paid Family & Medical Leave Act
      - 1. City working on developing a FAQs Document.
      - 2. Effective July 1<sup>st</sup>, 2022.
      - 3. 64 hours per 12-month period, 8 8-hour days.
      - 4. Technically, the 64 hours PTO can be rolled over but the employer is not required to give more than 64 hours in the 12-month period.
      - 5. Children school events is an acceptable reason to use PTO.

- 6. Notice Policy being developed by EDD.
- 7. If a business already covers the 64 hours in a 12-month period, that business is already in compliance.
- 8. If an employee is asking for 2 consecutive days off or more, business may ask for documentation.
- Liquor License Changes
  - 1. Delivery License Permitting: 3<sup>rd</sup> Party Delivery (UberEATS) but the establishment themselves can also apply for a delivery license to make their own alcohol deliveries. IF you are asking for one of these licenses, you cannot have a 3<sup>rd</sup> party deliver alcohol. Both are not allowed. Curbside is not considered delivery. The containers themselves are still required to be sealed.
  - 2. Miniatures are banned. Anything less than 3 fl oz of spirits, are banned.
  - 3. Everyone who received a license between 2017-2021 are exempt from the issuance or renewable fees that they have from 2022-2031.
- Other legislation effecting small businesses
  - 1. GRT
    - a. Starting March 1 June 30, 2021, some establishments don't have to pay GRT. You can either not charge or charge customers and not pay it.
  - 2. Unemployment Tax Rate
    - a. Most establishments and businesses will see an increase, probably 80 – 90% are going to see an increase going forward.
    - b. Governor has mentioned placing federal money into the unemployment fund, but nothing has been decided.
    - c. Matt Biggs: Governments are still spending money. The idea that there is no money to put into the unemployment fund is ridiculous to me. When it comes to paying the bill, it falls on small businesses. I've closed 5 businesses now.
    - d. Chair will draft a letter expressing SBRAC's opinion to then share with the commission.
