# III. Open Discussion - Counselor Benton -

- Changes proposed to new housing solutions, might have effects on Airbnb/short term rental (STR) bill.
- Tim gives a quick recap of his position on the STR bill. Myra askes the commission for ideas for future guest/ follow ups. Request made for a follow-up with the Planning Department.
- Counselor Benton joined the call at 10:30am. Commissioners gave quick introductions.
- Counselor Benton shares his priorities: to expand the affordability and availability of housing.
- Because managing a STR is a commercial business that is generally hosted in a residential area, conflicts, crime and loss of community might present itself.
- Counselor Benton sees problematic trends in other cities and worries Albuquerque might follow. He hopes to preserve local community with the new limits to STRs.
- Hopes to keep it small, and very limited.

- Tim asks if any other industries use "human registrant" as a means to limit business. Will it hold in court?
  - o Questionable.
- Caitlyn acknowledges Counselor Benton's concerns, but wonders what is the equivalent for hoteliers?
  - Hotels are also struggling. Their business model seems more accepted than the STR model. Counselor Benton believes this is affecting housing more than small businesses.
- Matt questions: what is the activity of institutional investors in ABQ? Any data to back up the Counselors concerns? Why is there such a limited supply of housing in ABQ?
  - o No data for the investors.
  - o No data for the concerns mentioned in Albuquerque.
  - o The cost of construction is through the roof.
- Caitlyn reminds the commission heavy handed regulations might set the tone for future regulations that might be harmful from a smaller entrepreneurial prospective.
  - o This is a constituent issue.
- Paulette shares her expensive experience with building a house. She makes the point that the stress put on contractors effects the end product. Asks, what is considered a STR? A: less than 29 days.
- Myra requests updates on the redevelopment in Downtown ABQ.
  - o Increasing housing in downtown is needed. Possible 200 dwelling on 2<sup>nd</sup> and silver. Conversion of office space is also a solution to down town housing.
  - o ACS is going 24/7.
  - o Hopeful for the gateway center on mountain and 3<sup>rd</sup>. 24/7 place to get the homeless off the streets.
