Hearing

In the matter of the Petition to amend 20.11.42 NMAC, *Operating Permits*, and submit amendment to EPA as an update to the Title V Program.

Hearing Officer Bill Grantham opened the hearing at 5:40 p.m. Mr. Neal Butt, AQD Environmental Health Scientist, provided testimony and answered questions regarding the proposal to amend 20.11.42 NMAC, *Operating Permits*. Hearing Officer closed the hearing at 6:22 p.m.

Minutes

CALL TO ORDER

The meeting was called to order at 6:22 p.m. on July 8, 2009 with six Board members present. Board Chairman Jens Deichmann presided.

Item #1 Approval of the Agenda.

A motion was made by Member Sullivan to approve the agenda, seconded by Member Grace. Motion was carried by a vote of 6-0.

Item #2 Approval of the June 10, 2009 Meeting Minutes.

Chairman Deichmann asked that the draft minutes be amended to correct the misspelling of Mr. Claude Morelli's name. He also asked that, under Item #10, second paragraph, 2nd line that "under State regulatory jurisdiction," be inserted after the word "open" and "located on State land" be deleted, to read "Bill Grantham, Board Attorney, responded to a question asked at the last meeting, that if Kirtland was located on State land under State regulatory jurisdiction, open burning could be covered under household waste or vegetative materials categories under NMED regulations." Additionally, in the third paragraph, 1st line insert "probably" into this sentence, to read "Chairman Deichmann acknowledged that AQD is probably following the Open Burning regulation, but stated that the regulation is inadequate."

A motion was made to approve the minutes as amended by Chairman Deichmann, seconded by Member Sullivan and the Motion was carried by a vote of 6-0.

Item #3 Decision on matter of Petition to amend 20.11.42 NMAC, *Operating Permits*, and submit amendment to EPA as an update to the Title V Program –Resolution #2009-3

Motion to approve AQCB Resolution #2009-3, Adopting Amendments to Albuquerque-Bernalillo County Air Quality Control Board Regulation 20.11.42 NMAC *Operating Permits*, and Submit Amendment To EPA As An Update To The Title V Program was made by Chairman Deichmann, seconded by Vice Chair Menache. Motion carried 6-0.

Item # 4 Petition for hearing to amend 20.11.47 NMAC, *Emission Inventory Requirements* and to submit to EPA for inclusion in the SIP – N. Butt, AQD

Neal Butt presented the Division's request for a hearing on their Petition to amend 20.11.47 NMAC, *Emission Inventory Requirements* and to submit to EPA for inclusion in the SIP. The petition included a request for a hearing officer and a court reporter.

A Motion was made by Chairman Deichmann to grant the request for a hearing on the petition. The Motion was seconded by Member Upson and carried by a vote of 6-0.

Item #5

Petition for hearing to Repeal Section 20.11.90.12 NMAC, *Breakdown, Abnormal Operating Conditions, or Scheduled Maintenance* and Replace with a New Rule, 20.11.49 NMAC, *Excess Emissions*. Also amending 20.11.65 NMAC, *Volatile Organic Compounds*, and 20.11.69 NMAC, *Pathological Waste Destructors*, to correct cross-referencing. Submit new 20.11.49 NMAC, and amended 20.11.90 NMAC, and 20.11.65 NMAC to EPA as a revision to the State Implementation Plan (SIP) – N. Butt, AQD

Neal Butt presented the Division's request for a hearing on their Petition to Repeal Section 20.11.90.12 NMAC, *Breakdown, Abnormal Operating Conditions, or Scheduled Maintenance* and Replace with a New Rule, 20.11.49 NMAC, *Excess Emissions*. Also amending 20.11.65 NMAC, *Volatile Organic Compounds*, and 20.11.69 NMAC, *Pathological Waste Destructors*, to correct cross-referencing, and submit new 20.11.49 NMAC, and amended 20.11.90 NMAC, and 20.11.65 NMAC to EPA as a revision to the State Implementation Plan (SIP). The petition included a request for a hearing officer and a court reporter.

A Motion was made by Chairman Deichmann to grant the request for a hearing on the petition. The Motion was seconded by Member Grace and carried by a vote of 6-0.

Item #6

Resolution #2009-4, Encouraging the Bernalillo County Commission to Re-examine Zoning in the Mountain View Area, and Encouraging the Bernalillo County Planning Commission to Continue Development of a Mountain View Sector Development Plan – AQCB Vice Chair, Dr. M. Menache

Vice Chair Menache moved to amend Resolution #2009-4 by inserting on page 1, line 17 the following: "Whereas, the AQCB as well as the Air Quality Division have worked with residents of the Mountain View neighborhood for a number of years about their concerns regarding air quality and public health resulting from the location and operation of industries in their community; and". The motion was seconded by Member Sullivan and Member Upson and the Motion was carried by a vote of 6-0.

Member Grace moved to amend the resolution on page 1, line 17 as follows: delete the word "often" and insert "sometimes" in its place. The amended sentence will read: "**Whereas**, the AQCB recognizes the challenge involved in balancing the <u>often sometimes</u> conflicting rights of businesses and private citizens; and". The motion was seconded by Member Upson and was carried by a vote of 6-0.

Member Grace moved to amend the resolution on page 1, line 23 as follows: after the word "other" delete "environmental", after the word "land" delete "policy tools" and insert "use policies". The amended sentence will read: "The Air Quality Control Board strongly encourages the Bernalillo County Commission to re-examine zoning and other environmental land policy tools use policies in the Mountain View area to protect air quality and public health while encouraging economic well-being." The motion was seconded by Member Upson and carried by a vote of 6-0.

Vice Chair Menache moved to amend the resolution on page 1, line 19 as follows: after "Whereas," delete "the Bernalillo County Planning Commission has recently withdrawn", and

after "(MVSDP)" insert "was recently withdrawn from consideration." The amended sentence will read: "Whereas, the Bernalillo County Planning Commission has recently withdrawn Mountain View Sector Development Plan (MVSDP) was recently withdrawn from consideration." The Motion was seconded by Member Grace and carried by a vote of 6-0.

Member Brinkman moved to approve Resolution 2009-3 as amended, seconded by Member Upson and was carried by a vote of 6-0.

Item #7 Monthly Air Quality website update – Isreal Tavarez

> Mr. Isreal Tayarez explained that AQD is in the process of creating a Public Information Hearing link on the AQD web page for dissemination of information on that subject.

OTHER BUSINESS

Item #8 Discussion of Open Burning of Explosives

> Chairman Deichmann stated that he spoke to Mr. James Bearzi from the Hazardous Waste Bureau of NMED regarding the program that regulates the burning of explosives, and he also spoke with Ms. Mary Uhl, from NMED and received documentation, which he forwarded to AQD. Mr. Bearzi will make a presentation during the August 12, 2009 meeting. Chairman Deichmann stated that he had toured Kirtland AFB, and was shown the location where open burning activities occur, which is in the Four Hills area, and would not have been visible from the Mountain View area.

Board Attorney, Bill Grantham expressed that he will have to recuse himself from any Kirtland AFB matters because of a conflict of interest with his NMED employment.

Item #9 Review of AQD policy and procedure for Public Information meetings

> Isreal Tavarez invited the Board to read the draft AQD Policy, which they were provided to better understand the Public Information Hearing process.
