Facts:

Air pollution is a threat to our health and our economy

Motor vehicles are the primary source of air pollution in the Albuquerque area. The emissions testing program was started in 1982 to reduce carbon monoxide, hydrocarbons and visible smoke from motor vehicles. The test and repair program was upgraded in 2012 to further reduce hydrocarbons and oxides of nitrogen as these both contribute to ground-level ozone or smog.

In calendar year 2014, over 25,000 vehicles failed an emission test. Most vehicles are repaired and pass a retest within 90 days. Albuquerque/Bernalillo County residents and fleets are required by the federal Clean Air Act to test and repair vehicles.

Facts:

All 1981 and newer vehicles up to 10,000 lbs. gvw must be tested

All vehicles manufactured since 1981, including government, public utility and private fleets must pass an emissions inspection to be registered in Bernalillo County.



The inspection for 1981 - 1995 model year vehicles covers the following:

- 1. Pollution control equipment** - Catalytic converter and connections.
- 2. Tailpipe exhaust analysis** - For excessive carbon monoxide and hydrocarbon levels.
- 3. Visible smoke** - For burning oil or poor fuel combustion resulting in toxic particulate emissions.
- 4. Gas cap(s)**- For gas vapor leaks.

The inspection for 1996 and newer model year vehicles includes: **Check Engine Light, Diagnostic Trouble Codes, Catalytic Converter, Gas Cap Leak test and Visible Smoke.**

Facts:

You will receive notification for testing from the MVD on your registration renewal card

Have the testing done immediately upon receipt of notification to allow sufficient time for repairs and retesting if necessary.

PASS certificates are valid for registration purposes for 90 days, and are automatically shared with MVD to allow online registration.

Facts:

The City offers a FREE Retest and Time Extension for repair

Motor vehicles that fail an emission test are eligible for a free retest. In order to receive the free retest, the vehicle owner must bring the vehicle and the failed test to 1500 Broadway Blvd NE, between the hours of 8:00 am and 4:30 pm, Monday through Friday.

Most failing vehicles can be brought into compliance with a tune-up. Vehicles which require repairs costing more than \$300 may be eligible for a time extension. To apply for the time extension, the vehicle, the failed test, repair receipts, and an estimate of repair costs must be brought to 1500 Broadway Blvd NE. The back of the failed test has a form and instructions for this purpose.

Approved time extensions are for the purpose of registering the vehicle for 1 year; however, the extension must be cleared within 90 days of the date it was granted. Extensions for vehicles that pollute over twice the emissions standards are limited to 90 days.

Emissions Inspections Required in 2015



- 1981 and Newer Vehicles up to 10,000 gvw:** vehicles must be tested every two years and following any change of ownership.
- Commuter Vehicles:** into Bernalillo County require a test every two years.
- Diesels:** 1998 and newer are required to be tested every two years.
- Fully Dedicated Electric Vehicles:** are exempt from testing.
- Hybrids:** require testing every two years.
- New Vehicles:** require testing after four (4) years from date of purchase.



All vehicles operating in Albuquerque are subject to smoking vehicle laws

Citizens may register a complaint regarding a smoking vehicle. If a complaint is filed against a vehicle, the owner must present the vehicle to the 1500 Broadway Blvd NE testing facility for inspection. Smoking vehicles will be given 60 days to take corrective action. If the vehicle is not brought in for an inspection, the owner may be fined up to \$500.
