VEHICLES UNAVAILABLE FOR INSPECTION APPLICATION FOR TIME EXTENSION INSTRUCTIONS

Please read and follow these instructions carefully so that we may expedite your request for a time extension certificate, which can be used for registration purposes.

- **If your vehicle is in another emission testing area it must be tested there.** A two-year time extension will be issued for vehicles that have received a passing emissions test. Once the original passed emissions test and other supporting documents (see check list below) are submitted to our office, they will be processed and forwarded to the NM Motor Vehicle Division for the final registration process. Keep in mind that the passing emission test is only valid within the 90 days.
- **If your vehicle is in an area where emission testing is not available** a one-year time extension will be issued when the attached *Affidavit of Vehicle Unavailability for Inspection* and the *Affidavit of V.I.N. Inspection* forms along with the supporting documents (see check list below) are submitted to our office. Once the documents are received, they will be processed and forwarded to the NM Motor Vehicle Division for the final registration process.
- **We will honor other state Motor Vehicle Department's Vin Inspection forms.**

All documentation must be submitted to Vehicle Pollution Management at the address below. If these documents are submitted directly to the NM Motor Vehicle Department, they will be rejected, and mailed back to you, and cause a delay of your registration.
