A. Education:

- Ed. Specialist continues to conduct weekly site visits to provide support to classroom staff and to observe classroom environments and interactions.
- My Teaching Strategies annual subscription was renewed.

B. Support Services (mental health and disabilities).

- Classroom staff continue to work with families on completing 45 day social-emotional (ASQSE2) and developmental (ASQ3) screens
- EHS Policies & Procedures Committee is developing and/or updating policies on services to children with special needs and/or disabilities.
- Division Manager was called on to participate as a panel speaker for Congresswoman Deb Haaland on the Impact COVID 19 is having on children's Mental Health and Social Well-Being.
- EHS Center-Staff and Home Visitors received training on Early Intervention Services from lifeROOTS, Inc. on 10/19/20.

C. Health/Nutrition:

- EHS Policies & Procedures Committee continues to develop and/or updating policies on health, safety and nutrition.
- Monthly Nutrition Activities are being completed in accordance with CACFP guidelines.
- Division Manager working on establishing the Health Advisory Committee
- Program received notification of CACFP Audit to be conducted the 20-21 program year. EHS Staff are reviewing the program for compliance.

D. Family and Community Partnerships:

- Division Manager developed a job description for the Parent, Family and Community Engagement Specialist and HR is currently reviewing the JD for approval
- All EHS Centers have begun providing Monthly Center Parent Committee Virtual Meetings
- All EHS Home-Visitors have begun providing Monthly Virtual
- Community Services Program Specialist II looking at Parent Curriculum Ready Rosie for program adoption and implementation.
- All centers have begun virtual family meetings with the 1st meeting scheduled in November to elect site President, Vice President and Secretary.
- Community Services Specialist II to attend the National Head Start Associations Parent & Family Engagement Conference December 1st-3rd.
- All Centers and Home Visitors have conducted Parent Committee meetings with center families nominating site officials for the 20-21 program year being on the agenda. Parent Reps who are elected as the Center President, will become seated members on the Policy Council

E. Program Design and Management (including operations, facilities, etc.)

- EHS Home-Visitors continue to provide services in the virtual format, however, the program option is in the beginning stages of providing in-person visits in open spaces (i.e. families front yard, public park etc.). The program option is developing a Home-Visitor's COVID Health & Safety Plan prior to in-person visits being approved.
- Division is working with Department the process to be followed in response to the required bi-weekly COVID testing requirements for early childhood providers in red, orange and yellow counties.
- Division is looking revamping Policy Council with intentions being to increase active participation.

E. Administration:

- Division Manager Participates in weekly ECECD meeting with Secretary Groginsky in efforts of staying abreast of state guidelines on COVID Health & Safety Practices
- MacArthur re-opening is contingent on ECECD approval of COVID Health & Safety Plan

There will be an operational impact to the three centers- total cost for all registered to attend is \$6,300.

- **Virtual Home visits are done on a weekly basis. We call and email our families if they don't answer our first initial call.**
- **I am scheduling times for 2 new infants to fill out paper to get enrolled at SOW EHS.**
- **On October 30th, we encouraged the children to wear their pajamas to school instead of a costume and it was a relaxing day.**
- **Was a challenging month, but we came together and pushed through.**

Center-Based Activities:

Infant Indoor Play - This month the teachers in the infant room did a lot of painting with the infants. The teachers helped the infants paint with cotton balls, leaves, balls, cars, and pipe cleaners. The infants got very messy this month with all of the painting they did. The infants also filled and dumped different colored stars into containers and they put cheerios in a bottle. Some of the cheerios did not make it into the bottle but made it into the infant's mouth. The teachers helped the infants use tongs to pick up cotton balls out of bowls. This month the teachers also did a lot of sensory stuff like putting water and balls in the sensory table, leaves and cotton balls in the sensory bottles, oil, water, and paint in sensory bags, and using a sensory box with different textures on it. The teachers helped the infants make owls out of paper bags and the infants crumpled papers and glued it on a bigger piece of paper.

Infant Outside Play – This month the infants balanced on the balance beam outside. They also did a lot of hopping and marching around the playground. The teachers took out empty water bottles and helped the infants fill them with sand and rocks to make water bottle shakers. The teachers sat with the infants and they watched the falling leaves from the trees. The teachers helped the infants walk backwards and that was very tricky and interesting. The teachers took the infants for a nature walk around the school then with the nature stuff they found they made nature bracelets.

Toddler Indoor Play – This month the teachers helped, the toddlers mix red and yellow paint to make orange and then they painted on paper. The toddlers did a lot of moving in the classroom by singing and dancing to the five little pumpkins song. The toddlers also used soft balls to throw and catch in the classroom. The toddlers sat at a small table and did string beading. The teachers used many colors to do different projects with the toddlers such as they colored a pumpkin, played in the housekeeping with different color of foods, counted the color bears, and matched the color bears to their right color. The toddlers connected the magnetic animal bodies together and used the magnetic art boards to draw on. The toddlers made a melted snowman using glue and paint. The toddlers put together 2-D and 3-D puzzles together. The teachers helped the toddlers read and act out the book "Row, Row, Row, your boat." The toddlers took out the farm animals, named them, and made the sound that they make. The teachers and toddlers really moved their bodies in the classroom by dancing to music.

Toddler Outside Play – This month the toddlers looked, for sticks and twigs on the playground and they used them to draw in the sand. The teachers and the toddlers bounced balls around the playground track. The toddlers read the letters that are on the playground play structure. The toddlers really got moving by running around the track trying to catch their friends and teachers. The toddlers took turns going down the slide. The toddlers named the colors that they saw outside on the playground. The teachers and the toddlers played follow the leader all around the playground. The toddlers found different colored leaves outside and they felt the textures of the leaves, sand, and water. The toddlers were active outside by kicking the balls, spinning around, and rolling the shopping carts around the playground.

Parent Center Committee Meetings: All teachers are doing virtual home visits once a week with families and children if they are not attending classroom instruction. Teachers give parents program updates and center updates. The parents receive individualized homework activity for their child. We ask the parents if they need any resources and help them get any resources they may need. Infants and toddlers who are due for ASQ's or ASQ – SE's parents receive them to fill out. If needed we contact parents by phone or email.

Center-Based Activities: Children and staff are practicing social distancing. Children are encouraged to wash their hand more often and after each activity. Teachers did their lesson plans on the fall season and hot air balloons. We made small hot air balloons to put up in the classroom. The nutrition activity in the toddler room included carving a pumpkin and allowing the children to explore what was inside of the pumpkin. The children got to explore the texture of the inside. Each child got their own bowl and got to touch, smell, see and some tasted it. They saw how the pumpkin changed form each day. We talked about the hot air balloons that we saw outside. We talked about the size and colors they saw. At the beginning of the month, both classrooms changed their environments by rotating books and toys. The teachers of both classrooms put up the children artwork. The children got to go outside one classroom at a time and explore the leaves falling and how they crunched at their feet.

Virtual Home Visits were challenging because some parent do not answer our calls or emails. Some parents are at work and email seem to work better. Some of our parent's call us back and are happy to talk to us and tell us about how their child is doing and how the activities we send are helping them at home.

I also sent out a Nutrition Activity to be done at home with families.

October's Nutrition Activity

Toddler No Bake Cookies

Ingredients

17.5-ounce box Graham Crackers

1/3 cup creamy peanut butter

1 ripe banana mashed

Option add-ins: raisins, miniature chocolate chips, dash of cinnamon.

Instructions

1. In a blender process graham until they are fine crumb.
2. In a large bowl, stir together graham cracker crumbs, peanut butter, and mashed banana with a wooden spoon until complete combined.
3. Using a teaspoon or a melon baller, scoop out dough and place on a parchment-lined baking sheet. Use your fingers to gently press down on each ball to flatten it into a cookie shape. These make very small bite-size cookies, which are perfect for little kids. If you prefer bigger cookies, you can use a tablespoon or a large scoop to measure out the dough.
4. Place cookies in the freezer to chill for 20 minutes. Store in refrigerator, freezer, or another cool place in an airtight container.
