# NOTICE OF 5-DAY PUBLIC COMMENT PERIOD

### PUBLICATION DATE: April 9, 2021

Notice is hereby given that the City of Albuquerque, New Mexico proposes to amend its 2020 Annual Action Plan, the third year of the 2018- 2022 Consolidated Plan. This Third Substantial Amendment proposes to allow the City of Albuquerque, Department of Family and Community Services (FCS), to utilize an additional allocation of Community Development Block Grant – Corona Virus (CDBG-CV) funding under the Coronavirus Aid, Relief & Economic Security Act (CARES). In response to the Coronavirus Pandemic (COVID-19) HUD has notified the City of Albuquerque that is will receive an additional \$3,269,040.00 in CDBG-CV funds to be used to prevent, prepare for, and respond to the coronavirus (COVID-19). This additional allocation was authorized by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136, which was signed by President Trump on March 27, 2020, to respond to the growing effects of this historic public health crisis. The CDBG-CV funding will be allocated to four projects:

### Foreclosure Prevention - \$200,000.00 CDBG-CV

Funds will be used to provide mortgage assistance to low to moderate income homeowners within the Albuquerque city limits in response to the Coronavirus pandemic.

### Public Facilities - \$1,915,232.00 CDBG- CV

Funds will be used to acquire and/or renovate various public facilities to prevent, prepare for and respond to the Coronavirus pandemic.

### Public Services - \$500,000.00 CDBG-CV

Funds will be used to provide Public Services to low to moderate income persons to prevent, prepare for and respond to the Corona Virus Pandemic.

Administration - \$653,808.00 CDBG-CV

Funds will be used for administrative costs to support the implementation of the City of Albuquerque's CARES funding.

A statutory, 5-day public comment period will begin on April 10, 2021 and end on April 14, 2021 at 5:00 PM. All residents, property owners, persons with disabilities, immigrants, seniors, low-income, children and youth, homeless persons, and other stakeholders of the City of Albuquerque are encouraged to submit written comments or questions regarding the proposed Third Substantial Amendment to the 2020 Annual Action Plan to Monica Montoya, Department of Family and Community Services, located at Old City Hall, 400 Marquette NW, 5<sup>th</sup> Floor, Room 504, Albuquerque, NM 87102, or email at mtmontoya@cabq.gov.

In response to the COVID-19 coronavirus outbreak in New Mexico and the mandated Social Distancing requirements, the City of Albuquerque has closed all City buildings to the public. Therefore, a copy of the 2020 Annual Action Plan, as well as the 2018-2022 Consolidated Plan, will not be available for public review at the office of the Department of Family and Community Services, as typically provided. # Summary:

The City of Albuquerque's 2020 Annual Action Plan, the third year of the 2018-2022 Consolidated Plan, requires that this proposed change to the Plan undergo a substantial amendment process. The substantial amendment must include public participation and a comment period of 5 days.

# **Fiscal Impact:**

In response to the Coronavirus Pandemic (COVID-19) HUD has notified the City of Albuquerque that it will receive an additional allocation of \$3,269,040.00 in CDBG-CV funds to be used to prevent, prepare for, and respond to the Coronavirus (COVID-19). The proposed change to the Annual Action Plan through this amendment allocates these funds.

### Background:

The City of Albuquerque is a HUD "entitlement" community. The funds are allocated from HUD directly to the City of Albuquerque and do not pass through the state government.

### **Public Participation:**

All Albuquerque residents, property owners, persons with disabilities, immigrants, seniors, low-income, children and youth, homeless persons, and other stakeholders in Albuquerque are invited to review this proposed Third Substantial Amendment to the 2020 Annual Action Plan and comment on it in writing, until 5:00 PM on April 14, 2021. After receipt of public comments from the 5-day public comment period, the City of Albuquerque will address each comment in writing and will submit all comments and responses in its formal Third Substantial Amendment to HUD.
