VI. NEW BUSINESS

a. Amiodarone and Solumedrol for RRT

Mara Ortiz:

- Amiodarone, Solu-Medrol are being used in rapid response at UNM, but are not in the ABCEMS protocols.
- Requesting that these medications be added to the guidelines so an addendum is no longer required for UNMH rapid Response, they will not be removing these from their formulary.
- Not a super urgent need, it is more of a convenience for them. Also willing to have it listed as a rapid response only skill, the same as Ketamine is listed.

Motion: To add Solu-Medrol & Amiodarone to the BCEMS Protocol for all agencies. Motion by: Mike Cross 2nd: A. Ortega. With no opposition, the motion passes.

Dr. Pruett: If rapid response can get the information to the MCB by Friday 4/15, the protocol changes can be made and rolled out at the MCB on 4/20.

Dr. Medoro: What protocols need to be amended and how urgently does this need to be accomplished?

b. COE Guideline

COE discussion:

Per Chief Ortiz-COE-Written by Psych Physician, Law enforcement item, gray area for EMS, strictly law enforcement order.

Dr. Crook:

- States the hospitals did not know about ACS and their ability/use of writing COE. There is a discussion about having a quarterly meeting with the psych team from UNM and Pres regarding COE. Trying to cover a better way to better define EMS role in the COE process, essentially a COE is a health arrest warrant. Guideline needs to be updated.
- Whole blood products prehospital on the trucks. Readdress how the EMS system would possibly be involved in it.

Dr. Pruett: Time to make a black and white guideline for EMS providers.

Chief Ortiz gave an overview of how AFD process for COE handling. Requesting recommendations from this committee for a guideline/protocol for COE handling, request to have these to Chief Ortiz before the MCB meeting on 4/20.

Motion to propose a guideline for COE: Motion by: J. Hackett 2nd: D. Chapek, Approved with no opposition.

Dr. Medoro: Please use your own experiences when sending in the recommendations. This SOG can be built around the common issues regarding the COE.

Capt. R. Laprise: Handling more calls every shift for these issues. Requesting a guideline to assist the crews in the field to help them handle calls, consensus is that there a 50/50 understanding of what a COE is and how to

handle it.

D. Chapek: Recommends adding a question to Image Trend for 25B, so we can look at DATA for the requesting of COE.
