- AFR and AAS are looking into he uptick on provider assault. AAS and AFR numbers are being tracked on Image trend. AAS has also developed a violent reporting guide with attached NM statute to get the assailant charged with a felony. Chapek can send it the guide out to the group. AAS working with a contractor for verbal de-escalation and self-defense.
- Rapid response- UNMH rapid response is looking for a medical director to merge the in hospital and the EMS treatments. If anyone has a reference please pass it along
- Benzodiazepine- AAS experiencing a shortage with Versed. There are not many viable options for sedation. There is a band aid fix working with AFR, but we are looking at antipsychotics (Driperidol and Haldol) use with a special skill to be able to sedate pt.'s. Is there anything the PAC needs to do for this to go forward?
- Opens up questions-Know that the guideline will be vague in order to deal with any shortages in the future. Case out of Denver: Autopsy said the death was due to a Ketamine overdose. Look up Driperodol and agencies using it. No questions voiced.

- AFR- ECMO being rolled out again and training will be recorded and sent out agency wide.
- BCFD- Carrying Pitocin. Starting to see an uptick in Covid with their providers
