Lovelace- Dr. Lahr: Director for downtown and Heart hospital working on her license in NM. No real change for updates. No information on drop times.

Protocol Updates/Discussion- Go through all of them 1 by 1

- **Alcohol/Benzodiazepine Withdrawal-** CIWA will be used to treat withdrawal of alcohol and Benzo's. Wanting to start on the lower side of the medication and increase as needed. This will be emphasized in the education and training. Add in precaution with pain meds.

- **Pediatric Cardiac Arrest/Physiocontrol Letter:** Some electricity is better than no electricity going to change Joule administration and increasing the respiratory rate to be consistent with PALS.
- **Adult Medical Hypothermia** ECMO patients have good survival rates with hypothermia so added statement to the Key Points box
- **Adult Pain Management** add in a ceiling for a single max dose of 100 mcg.
- **Naloxone Formulary** Clean up the wording for EMTB's so that it matches the adult overdose.
- **Adult Ventricular Assist Device** All VAD patients should be transported to the only VAD hospital being Heart Hospital. Also added Coordinator number. Chief Ortiz recommended word change to manual CPR.
- **Adult Seizure** Added in actively convulsing on arrival suspect true status and upped the dose to start with 10mg Midazolam. Recommendations by Dr Lahr as to when IV is established decreasing the dose by half.
- **Adult Medical Hyperkalemia** allow for providers to think about when giving Bicarb.
- **Synchronized Cardioversion** Can be used for mothers in all stages of pregnancy.
- **SANE Update** Name change to add in domestic violence. Change from cab to ride share. Received by an advocate as well as nurse.

Motion to approve the guideline changes with recommendations by Dr. Medoro and seconded by Dr. Khalsa.
