**VA-** EMS radio has been down, ED been advised to not divert unless it is a trauma. Requesting feedback loop for diversion of patients. Most concerned with brain bleeds second to trauma. Telestroke up and running for a while, trying to steam line the process.

**Presbyterian-** Construction completed in the triage, working on the triage process to improve the handoff process with AAS and triage.

**UNM-** nothing to report other than increased patients in all the ED's.

## **Old Business**

**Stroke metrics-** Metrics shared; Consistent contacts with all the hospitals are being made, follow ups are behind for gathering all the data. Scene times are too long for the metrics and are meeting the metrics 90% of the time.

**IGel Update:** Trial has gone well.

**ECMO-** UNMH and Pres are accepting patients. A couple were transported to Pres and went well. Quick cannulation process. Training will go out for AFR this summer with the goal of rolling out Mobile ECMO by Aug.

**911 Diversion-** Pres Admin helping with the billing of this system. ImageTrend has a module for a cost to help make this a reality. Still moving forward and should be up by Aug.

**Mossimo Project-** A video has been put together for the equipment. Training going out this training session.

**Pediatric Transport guideline-** Cleaned up the guideline to make it consistent. Transfers for parents if they are adamant about a certain hospital.
