# **DIVISION UPDATES**

### ALARM ROOM / TECHNICAL SERVICES

**Communications Division** reported 9,362 emergency calls and 7585 non-emergency calls created for the month of August. Jan.-Aug. emergency call totals are 59,257. **Technical Services Division** is working with City IT and will be starting work to complete the AFR VOIP Phone Project that started a couple of years ago. AFR will be working with City IT and the vendor to develop a timeline for this project. The completion of this project will allow AFR to eliminate all of the aging Nortel phone equipment.

### FIRE MARSHAL'S OFFICE / ARSON / PUBLIC AFFAIRS OFFICE

**FMO** reported 448 inspections and 159 re-inspections for the month of August. A total of 1450 adults and children were reached through fire prevention classes and outreach programs. **Public Affairs** reported over 30 units were involved in the National Night Out in Albuquerque neighborhoods on 8/7/2018.

### FLEET MANAGEMENT / LOGISTICS / CAPITAL IMPROVEMENT

**Capital Improvement** reported 122 requests for service. Work is still in progress to complete the interstitial spacing on all stations and integrating building management software.

**Logistics** is transitioning to a new PPE management software. Gear assessment is 90% complete. In August, there have been

89 supply and service requests. In August, inventory all small engine equipment has been completed. SCBA service requests total was 59. Annual maintenance is in progress including hydrostatic testing of the SCBA bottles. There were 51 uniform requests this month.

### TRAINING / EMS / HAZMAT / WILDLAND / HTR



**AFR Academy** started a 92nd and 93rd Cadet Class in August. The Academy facility also hosted a press conference to demonstrate the LUCAS device and announce its placement on all AFR Rescues. Suppression refreshers for all members are currently being held.


