IV. MCB REPORT-Dr. Kimberly Pruett had nothing significant to report because Medical Control Board hasn't meet in 2 months.

V. EMS GUIDLINES-Battalion Chief Chris Ortiz now temporary Acting Deputy Chief of EMS temporarily replacing Deputy Chief Emily Jaramillo introduced Battalion Chief Santos Garcia who is temporarily replacing him. Attendees of the meeting introduced themselves to Battalion Chief Santos Garcia.

Acting Deputy Chief Chris Ortiz talked about having the Joules setting on the Physio (Life Pak 15) system recalibrate when the pads are put on a Pediatric patient. He will put something together when using the device on a Pediatric patient once that information is received from Physio. Because presently the Life Pak 15 system does not calibrate a change when the pads are put on an Adult or Pediatric patient. This conversation is taking place because of a situation that AFR encountered using the Physio system on a Pediatric patient.

Dr. Kimberly Pruett mentioned Inter-Hospital Transports, No Black Diverts, Changing the language of Defibrillation for Pediatrics along with Pediatric Needle Decompression needle size and depth. She also mentioned that hospitalization volume is still high.

VI. **Fire Service Reports (AFR/BCFD/KAFB):** *Acting Deputy Chief Chris Ortiz* explained the purpose of the Provider Advisory Committee to new participants and that the committee meets every other month.

Kurt Silva from Bernalillo County Fire mentioned running on calls along with Law Enforcement for Psych patients. That these calls come from the Alarm Room but Law Enforcement should be initiating the call out. So a trained Therapist and the Facility is ready to accommodate this type of patients.
