DIVISION UPDATES

ALARM ROOM / TECHNICAL SERVICES

Communications Division reported 10,848 calls were created for the month of July. So far this year, there has been an increase of over 2,200 calls since January compared to last years data.

Technical Services Division reported intermittent problems with the Zetron alerting system that is utilized in sending tones to dispatch units within the stations. Tech Services is currently

working with Tritech to determine why this is occurring. This recent problem has led to various stations being on radio standby until services are restored.

FIRE MARSHAL'S OFFICE / ARSON / PUBLIC AFFAIRS OFFICE

FMO reported 504 inspections and 180 re-inspections for the month of July. Also a total of 838 citizens, both adults and children, have been trained in fire prevention. **Public Affairs**

FLEET MANAGEMENT / LOGISTICS / CAPITAL IMPROVEMENT

Capital Improvement reported 105 requests for service/maintenance for July at all AFR facilities. Efforts are continuing to complete the interstitial spacing for all stations. Logistics is implementing a building management software to better track progress and spending.

Logistics is transitioning to a new PPE management software. Turnout gear assessment is now being done by Honeywell starting 7/30/2018 and will be completed in August. There were

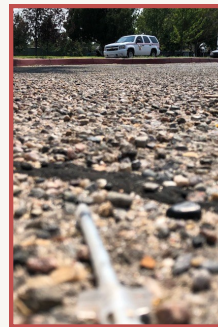
89 supply and service requests. New soap and hand sanitizers have been installed at all facilities. There were 32 air-pak service requests for July. Annual SCBA maintenance and bottle hydrostatic testing is in progress.

TRAINING / EMS / HAZ-MAT / WILDLAND / HTR

AFR Academy completed EMS Day 2 refreshers for all members of AFR and is now beginning Suppression refreshers.

EMS and Emergency Management Division launched the SHARP program (Safe handling and routing of paraphernalia). This is a team effort incorporating six City divisions to tackle the aftermath of a growing heroin epidemic. that Hundreds of improperly disposed needles are left in public spaces every month. BLS 11 was put into service this month and will be housed at Fire Station 11. This unit will respond to lower acuity calls involving primarily ETOH and unknown status calls on and near Central Ave. This unit will reduce the call volume and allowing for better response to true emergencies for Engine and Rescue 11. The LUCAS Device has also been implemented on a few AFR units and will soon be placed on every single Rescue.

Wildland Division reports AFR Wildland crews have worked very hard over the past month and have had the opportunity to extend their services to areas outside of Albuquerque. AFR currently has personnel assigned to the Carr Fire and the Mendocino Complex Fire in Northern California. The crew assigned to the Mendocino Complex fire deployed as part of a Strike Force comprised of several crews from New Mexico, they should be returning next week. The crew assigned to the Carr fire just swapped out personnel, AFR will continue to be assigned to the Carr Fire. AFR just had a crew return after being assigned to two fires in the Mount Taylor area. The Wildland Division would like to thank both City and Fire Administration for their continued support.

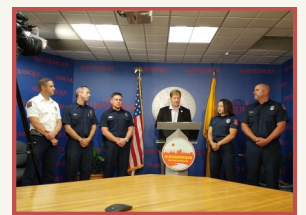
AFR STATION 17 / BC 4

- Station 18 had their interstitial door completed as well as a water fountain bottle filler.

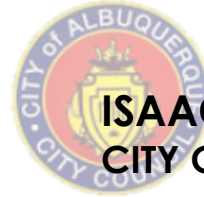

AFR STATION 15

- Engine 15 provided four separate day shift ride-a-longs for CNM EMT-Basic students this month.

- On the afternoon of July 24, Engine and Rescue 15, QI 78, and AAS responded to a trouble breathing call (6D) that was upgraded to a 9E by Alarm after the patient went into cardiac arrest. This was a 62 y/o male, a retired APD officer, who was found in refractory VF and defibrillated 6 times prior to pulses returning. He was

successfully transported and delivered to HHNM where he again went into cardiac arrest and was defibrillated two more times by ER staff. He was successfully moved to the cath lab where his vessel was opened in 7 minutes. He is awake, alert, and expected to make a full recovery.

AFR STATION 20 / BC 3

- Station 20 hosted a tour for approximately 25 kids from La Petite Academy.
- Station 20 hosted a Safer NM Car Seat Clinic.
- Engine 20 participated in a Back to School Shopping program for kids in foster care and displayed the truck for Mark's Casa Jeep Jam to support Special Olympics.
- Rescue and Engine 20 responded to an approximately 70 year old male Paloma Landing Assistant Living Facility for a trouble breathing call. When patient contact was made, it was determined that he had no pulses or respirations. The patient was one of the managers/supervisors of the facility. After initial resuscitation efforts, the patient spontaneously started breathing again and had a very strong pulse. AFR and AAS crews quickly loaded the patient and transported to the hospital. Three AFD paramedics rode in with the AAS unit. Pt had very stable vitals throughout the transport.

- Engine 22 had a non-functioning A/C unit that was finally repaired.

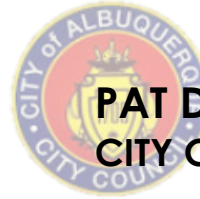

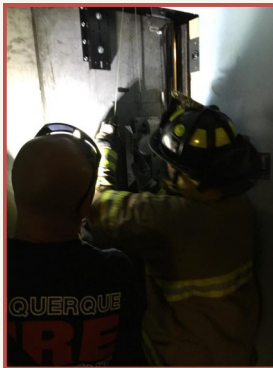

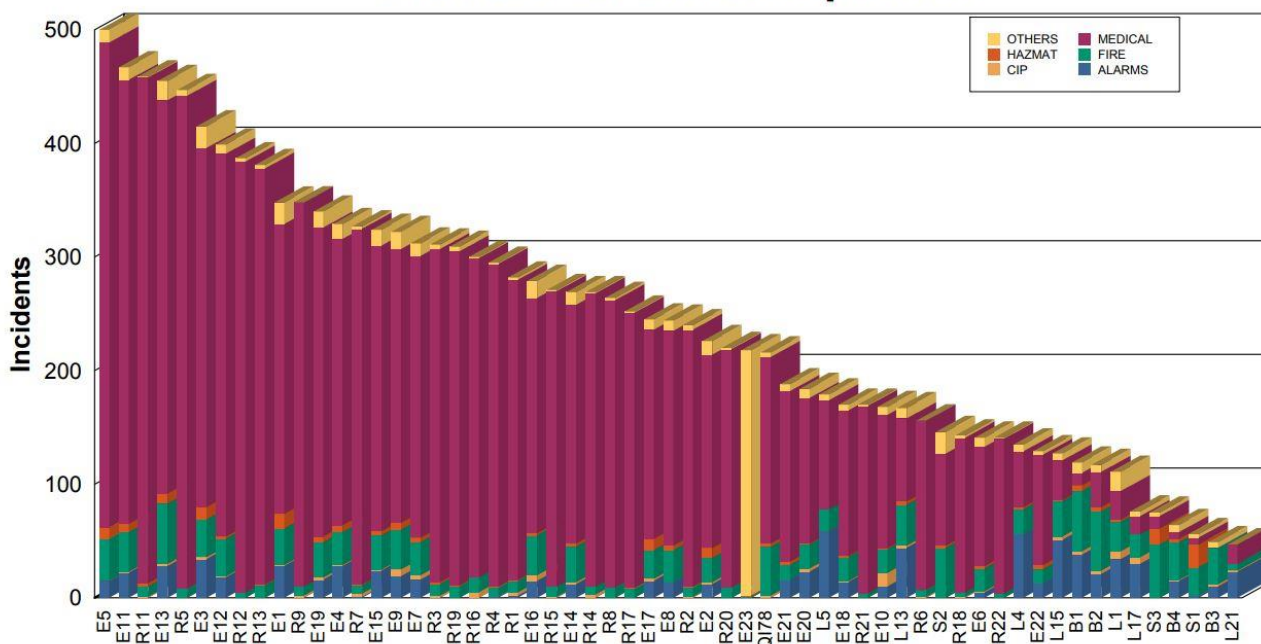

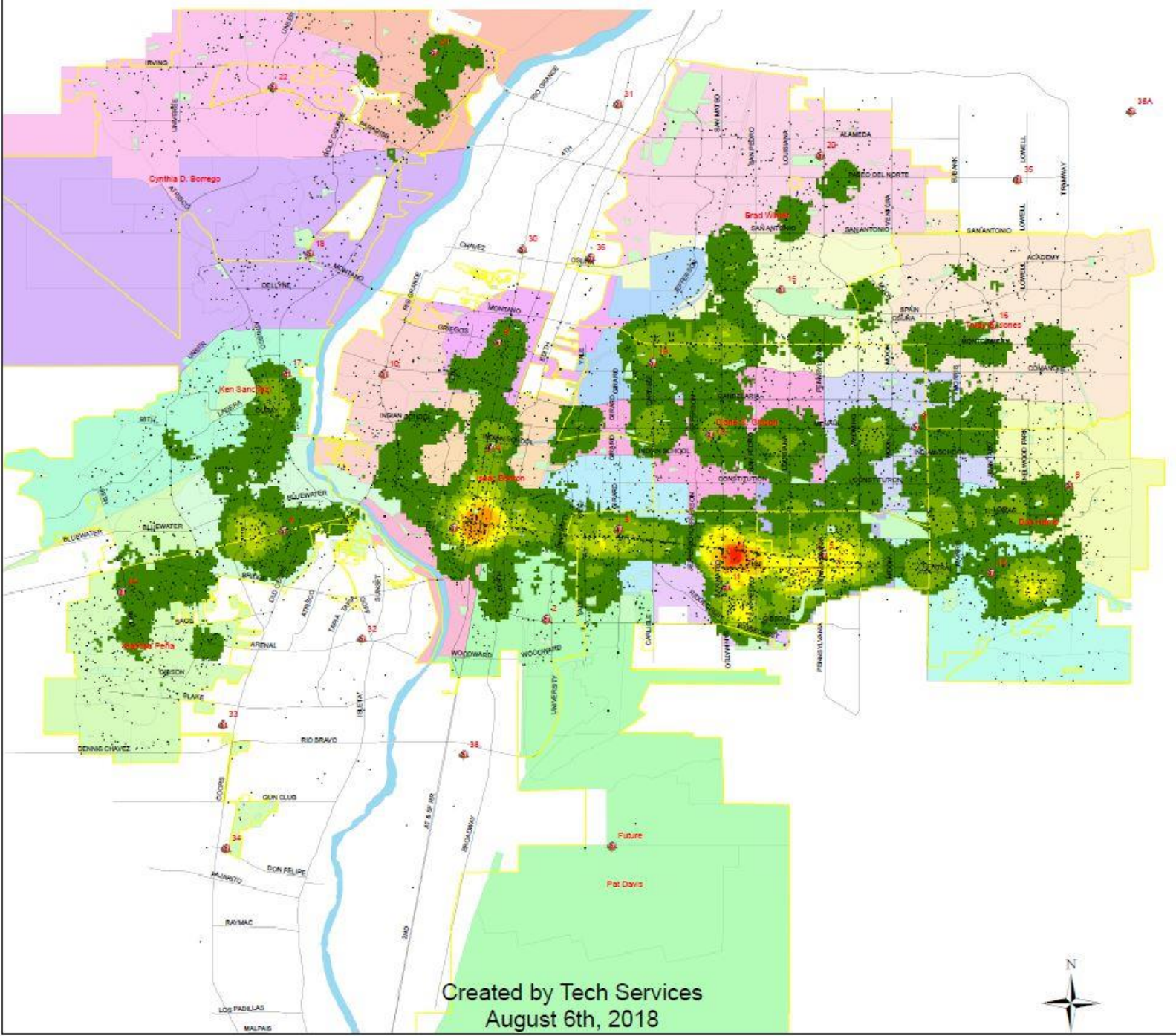
