## **New Business**

**PAC-** Chief Ortiz-covered in the last MCB. Kirtland- offering ALS 24 hrs/day 7days/wk. Trying to get auto aide system worked out. Went over stroke metrics. Hospital hub- what hospitals are on it? Sandia labs- talked about their drills. Vaccine- reaching out for those who can't get transportation to a vaccine site.
