







SIGNIFICANT EVENT ALERTS

3/1 - Residential Fire: AFR responded to the 3400 block of Crest Ave SE in fire district 2 for reports of a structure fire. Crews arrived to find a 5 plex with smoke coming from one unit. Engine 11 quickly extinguished the fire and all clear announced at 12:30 pm. The cause of the fire is unknown.

3/5 - Travel Trailer Fire: AFR was dispatched to the 3000 block of Cypress Dr. SW in fire district 7 for reports of flames from a travel trailer. Upon arrival crews found a travel trailer on fire threatening a structure. Engine 7 made a quick attack and was able to quickly extinguish the fire.

3/10 - Wildland Fire: AFR crews were dispatched to the area of I-25 near Isleta in BCFD fire district 38 for mutual aid to help contain a brush fire. AFR sent a task force unit including their Wildland Coordinator, 3 Wildland Apparatus and 2 Battalion Chiefs to assist BCFD with fire containment of an approximate 40 acre brush fire. There were no structures threatened and no injuries to firefighters or civilians to report.

3/14 - Apartment Fire: Albuquerque fire rescue crews were dispatched to the 300 block of Dallas St. NE in fire district 5 for reports of smoke showing. First on scene was ladder 5 to find smoke showing from an apartment complex. Crews went on the offensive fire attack and found that smoke was coming from an apartment on the first floor. Within 10 minutes, AFR crews were able to contain and extinguish the fire. The fire was contained to a single apartment and there was minimal damage to the structure.

3/17 - Wildland Fire: Albuquerque Fire Rescue responded to a Bosque fire south of Tingley on the East side of the river. The fire was contained to 2 acres. A total of 8 resources and 26 personnel from Albuquerque Fire Rescue Wildland Division were able to contain the fire quickly despite gusty winds.

3/25 - Residential Fire: AFR crews responded to a reported fire at a two story residential home on the 10000 block of Sandhurst Dr NW in fire district 22. Crews encountered smoke and flames coming from the garage upon arrival. Firefighters made a quick attack and the fire was under control in 12 minutes. The fire was contained to the garage which had severe damage.

3/27 - Residential Fire: AFR units were dispatched to the 5000 block of Namaste Ave NW in fire district 17 for reports of a structure fire. Crews arrived to find a single story abandoned residential structure fully involved with heavy fire and smoke. AFR crews went defensive and extinguished the fire from the exterior. The home suffered extensive damage.

3/27 - Residential Fire: AFR was dispatched to the 6500 block of Glen Oak NE in fire district 16 for a residential structure fire. First arriving crews reported heavy smoke and flames coming from the two story residential home and proceeded to make entry in order to perform search and simultaneous fire operations. Interior crews located one deceased victim inside and were able to remove that person from the home. Fire crews continued their interior search and while performing fire control, two firefighters fell from the second story to the first as a result of a floor collapse. The two firefighters were able to exit to structure safely and one firefighter was transported to a local hospital for minor injuries. Due to the unsafe interior fire conditions, command advised all remaining interior fire crews to exit the structure and at that time began defensive fire operations. Exterior fire operations continued for fire control and to protect nearby exposures. The fire was declared under control at 8:21am. The cause of the fire is under investigation.

3/30 - Residential Fire: AFR units were dispatched to the 700 3rd St SW for reports of a residential structure fire. AFR Crews arrived to find a two story residential structure fully involved with heavy fire and smoke. AFR crews used defensive operations and extinguished the fire from the exterior. The home suffered extensive damage and was reported to be vacant. One dog was found deceased at the scene.

- 1. AFR was proud to host Living Works Education at the Training Academy for their Applied Suicide Intervention Skills Training. The emphasis was on teaching suicide first-aid to help a person at risk to stay safe and seek further help as needed.**
- 2. NMSP EOD, AFR HazMat and the AFR Arson team performed joint training at Station 13. Members practiced the use of bomb/chemical/accelerant detection instruments including the highly skilled puppy dog nose belonging to Wheezy.**
- 3. AFR Station 17 A-Shift conducted Suppression as well as Wildland Preparedness Training while on shift. These in house company drills help our crews to be prepared ahead of any disaster.**
- 4. The AFR 95th Cadet Class continues to work hard every week and were recently issued frontline PPE that will be used in the remainder of their Academy and into the field upon graduation.**
- 5. Academy Captain Will McMullen leads a crew into a live burn drill that will later be used for suppression refreshers for all AFR members.**


FACES OF AFR | Dustin Ryan

- New MDT’s were received and installed in the Fire Investigators response trucks. The updated technology gives Fire Investigators real time and current information to assist with their fire investigations.
- The process of improving respiratory protection was initiated in the Fire Investigation Division. A new respiratory protection system(s) was received from a new vendor and is currently being evaluated by the Division for its effectiveness and scene adaptability.
- We drafted an arrest warrant for an individual that was suspected of arson in Albuquerque that was involved in a high speed pursuit which ended in Texas. The warrant will serve to extradite the individual back to Albuquerque and begin the indictment process.

HUMAN RESOURCES

HEALTH AND SAFETY OFFICE

Annual physicals

Cancer reduction best practices for firefighters include having an annual physical exam. Therefore, each Albuquerque firefighter is required to complete an annual physical through Employee Health. This physical meets NFPA 1582, Standard on Comprehensive Occupational Medical Program for Fire Departments (2018 edition) and OSHA 29 CFR 1910.134 – Respiratory protection. The physical includes; a physical exam, fasting blood draw, audiogram, vision, pulmonary, urinalysis, spirometry, EKG, chest x-ray and treadmill stress test, as indicated by the physician.

Firefighter Injuries

Sprains, strains and other muscular injuries are the most common injuries firefighters receive in the line of duty. Firefighters’ protective gear keeps them from being burned, but the sudden nature of their work and the heavy lifting it often requires means that they are at risk of other potential injuries and illnesses.





HAZMAT

HEAVY TECHNICAL RESCUE

- Conducted vehicle extrication refresher for Paramedic school students.
- Instructed vehicle extrication course for members of AFR's 95th Cadet Class.
- AFR took possession of an airboat that will allow AFR to conduct rescue operations in the Rio Grande River. Once training is complete the boat will be placed in service and available as a resource for the community. The airboat was purchased utilizing funds generated by AFR's Wildland Division on fire assignments during the 2018/2019 fire season.
- HTR Coordinator assisted the PIO with developing a PSA to be released to CABQ for the high number of mountain rescues occurring and the drive for people to get outside during this social distancing.



WILDLAND

- Cadet Wildland Week Completed, March 9th-13th - all Cadets received 40 hours of wildland training to meet NWCG standards for basic wildland firefighting qualifications.
- AFR has responded to four Bosque fires in the area of Central and Tingley. All fires were contained to less than two acres in size.
- AFR's Wildland Division responded mutual aid with BCFD on a 40 acre off south 2nd, St.
- AFR has completed pack testing and wildland refreshers for the 2020 fire season.

EMERGENCY SERVICES

HEART/BLS RESCUES

- HEART is still taking patient referrals; however, the team is re-scoped, along with members of the FMO, to the two AFR COVID-19 response teams. These teams provide 24/7 coverage for calls to patients that are symptomatic for COVID-19.
- Lt. Sargent began her chemotherapy in March. She is continuing to work with HEART patients remotely.

PHARMACY

- Priority in Pharmacy has shifted to keeping track of PPE related to COVID-19 and assistance in acquiring additional PPE.
- New modems and certadose syringes have arrived.

- Acquired 2 service vans and retrofit to trucks for mechanics to increase remote work and decrease out of service time for small repairs.


