




AFR UNITS ABOVE 110% CFAI THRESHOLD

ALBUQUERQUE FIRE RESCUE SIGNIFICANT ALERT EVENTS

APRIL 2022

These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

- 4/5 Apartment Fire: At approximately 8:06 am AFR was dispatched to 5800 Osuna Rd NE in fire district 15 for a residential apartment fire. Upon arrival, Engine 15 declared a working fire in a 2 story apartment with smoke and flames coming from the front window. Engine 15 stretched a hose line to the second floor of the apartment building to begin their fire attack as Rescue 15 simultaneously performed a search of the affected apartment. Ladder 13 performed ventilation operations in order to assist the interior fire crews. The fire was located in the back bedroom and extinguished by Engine 15 as Rescue completed the primary search. All occupants of the affected apartment were able to safely self-evacuate as fire crews were arriving on scene. Firefighters were able to locate and rescue two dogs that were in the affected apartment and safely return them to their owners. A total of 12 AFR fire apparatus were on scene to assist with fire operations. The cause of the fire was accidental and there were no injuries reported.
- 4/6 Mobile Home Fire: Just before midnight, AFR crews responded to a single family mobile home located at 628 Trading Post Trail SE in fire district 12. Engine 12 was first to arrive on scene. They encountered a double wide mobile home with smoke and flames engulfing the structure. There were also reports of victims inside. Engine 12 pulled a large diameter attack line and began attacking the fire from the outside. A search of the home began simultaneously looking for the occupants. The fire was brought under control by firefighters within about 10 minutes of arrival. The home sustained major damage from the fire. Luckily, the occupants from the house escaped and were able to get out injury free. Sadly, there was a dog found inside and attempts to resuscitate were unsuccessful. There were no injuries reported and the cause unknown.
- 4/9 Residential Fire: AFR was dispatched to a residential structure located at 915 22nd St. NW in fire district 4. Engine 4 was first on scene and found the house fully involved in flames. Firefighters fought the fire defensively. There were some structural issues making it unsafe to be in certain areas and the house had been compartmentalized quite a bit. Firefighters quickly discovered a basement as well. The substandard home was constructed out of lath and plater. All of these conditions combined make extinguishing a fire much more challenging to firefighters. Despite these obstacles, AFR crews worked diligently to fight the fire and eventually it was extinguished. Firefighters did an excellent job protecting the surrounding homes. No occupants were found inside of the boarded up abandoned structure. A piece of sheet metal cut through the glove of a firefighter injuring his hand. He was treated on scene. No other injuries were reported. The cause of the fire is unknown at this time.
- 4/18 Bosque Fire: At approximately 2:28 pm AFR was dispatched to a vegetation fire near 1300 Riverview Dr NW in fire district 7. The Wildland Task Force was dispatched in order to assist in firefighting operations. Engine 7 crew arrived on scene and reported a working Bosque fire with approximately 1/4 acre initially burned. Firefighters from Stations 7, 10, 1, 16 and 22 arrived on scene and began wildland operations to include the usage of hand tools, small diameter hose lines, and float pumps to help in supplying water for fire containment. Firefighters worked continuously to build containment lines around the fire, preventing any further fire spread. At approximately 6:00 pm firefighters declared that the fire was fully contained as they continued to put out hot spots within the burned area. No homes were evacuated as a result of the fire and there were no houses affected by the fire. A total of 41 firefighters were on scene to assist with fire operations. No injuries were reported and the cause of the fire is believed to be man made however the exact cause of the fire is under investigation.
- 4/21 Commercial Fire: At approximately 7:04 am AFR was dispatched to Central and 10th St NW for a single story commercial structure fire in fire district 1. Units from Station 1 arrived on scene and reported a working structure fire with heavy smoke and flames showing from the roof of the abandoned building. As additional units arrived on scene, defensive operations were declared due to the building having structural integrity concerns and confirmation that the building was cleared of any occupants. Firefighters from Engine 1, Engine 2 and Engine 4 utilized multiple handlines as they continued to fight the fire from a defensive standpoint. Ladder 1 set up on the east side of the building and was able to commence aerial operations, enabling firefighters to extinguish the fire. After approximately 30 minutes the fire was declared under control and firefighters were able confirm that there was no possibility of the fire spreading. A total of 13 fire apparatus and 32 firefighters were on scene to assist with fire operations. The cause of the fire is unknown. There were no injuries reported.
- 4/22 Residential Fire: AFR was dispatched to a reported structure fire at 737 Louisiana NE in fire district 11. Engine 11 arrived less than 3 minutes after dispatch and declared a working fire in a vacant residential home. A total of 9 units responded and coordinated search and fire attack. The structure was reported clear of occupants and the fire was under control in under 15 minutes. There were no reports of injuries.

- 4/24 Residential Fire: At approximately 4:19, AFR units were dispatched to 9536 Giddings Ave. NE in fire district 20 for a structure fire. Engine 20 was first on scene of a shed fire that extended to the adjacent shed next door. The sheds were quickly extinguished by Engine 20. One civilian burned his forearm at some point during the incident. There was no injury to firefighters and the cause is unknown.
- 4/25 Commercial Fire: At approximately 5:19 a.m. AFR units were dispatched to a structure fire at Richmond and Monte Vista in fire district 3. Crews arrived to find a single story abandoned commercial structure basement fire. There was no injury to firefighters or civilians. This building had been boarded up by Code Enforcement in the past. The cause of the fire is still under investigation.
- 4/25 Residential Fire: AFR units were dispatched to a structure fire at 3324 12th St NW in fire district 4 at approximately 10:31p.m. Engine 4 was the first unit on scene to find a single story home and visible smoke from the back. Engine 4 pulled a suppression line to the rear of the structure and found the fire in the basement of the home. The fire was quickly extinguished by transitional attack through a window. There was substantial damage to the property. There were no injuries reported. The cause of the fire was ruled accidental and the homeowner was displaced due to the damage caused from the fire.
- 4/26 MCI MVA: At approximately At approximately 6:52 p.m., AFR was dispatched to a single-story single-family abandoned structure near Jackson St SE and Crest Ave SE in fire district 11. Within minutes, AFR units arrived to a working fire. Having verified an all clear, the crews were able to make a quick attack and knocked down the fire with no reported injuries to firefighters and civilians.
- 4/27 Residential Fire: At approximately 1:49 p.m. AFR was dispatched to 1136 Turner Dr NE for a residential structure fire in fire district 8. Rescue 8 arrived on scene and reported a working structure fire in a large, three story residential home with smoke and flames coming from the rear of the home. A secondary report indicated that the fire had extended through the roof as additional units began to arrive on scene. Firefighters began to deploy hand lines for fire control. Emergency traffic was announced over the air that a portion of the roof had collapsed and at that time firefighters began to fight the fire utilizing defensive operations. The fire had extended to the yard and vegetation of a nearby house as fire crews stretched additional hand lines to protect the exposures. Ladder 13, Ladder 9 Engine 13 and Engine 3 were assigned alpha division for fire suppression as the utilized master streams to control the fire. Engine 9 and Squad were assigned to the bravo division for fire suppression efforts on the north end of the house. Engine 12, Rescue 12 and Rescue 9 were assigned to wildland fire fighting efforts in the rear of the structure. At a later point Engine 1, along with Brush 16, assisted with wildland efforts. In total 24 fire units were on scene to assist with fire operations. No injuries were reported and the cause of the fire is under investigation.




- 1. AFR crews participated in a full-scale emergency exercise held at the Albuquerque Sunport complete with a simulated airplane crash, 60+ victims, and response from several partner agencies.
- 2. Multiple AFR crews responded in rotation to help with exposure protection during the Big Hole fire in the Belen Bosque including Station 1C who were one the first responding crews.
- 3. AFR hosted the annual American Lung Association in New Mexico Fight for Air Climb at the AFR Training Academy. Paramedic Lieutenant Tomas Maestas was selected as the AT&T Firefighter of the Year!
- 4. The Albuquerque Sign Language Academy welcomed AFR Engine 4 for a visit. Visits such as these provide an inclusive way to educate all kids on fire safety and provide fun teaching moments to get kids comfortable with first responders ensuring community safety.
- 5. Engine 17 and Battalion 2 were performing a final walk through of a home that sustained major fire damage and happened to find the family pet that had been missing since the fire. "Jo Jo" was returned to the owner as they begin the difficult process of rebuilding.

ADAPT

- ADAPT has 127 properties that have been formally brought into the program, 72 have been cleared from the program and 55 are still in the program at different stages. ADAPT continuously monitors the properties that are in the program to track their compliance with the Nuisance Abatement Agreement.
- There are 96 properties on the Unsafe Buildings list. Two new properties were added to the list this month. The properties are labeled on the First Due application with a white "X" on a red background. In the field these properties are marked with a red spray painted "X" and the letters "AFR" under it.
- 4200 Spanish Bit NE was cleared with a 61% reduction in reported crime.

PLANS CHECKING

- Plans Checking worked diligently with architects on the Double Eagle airport project. We have approved a new 30,000-gallon AST (above ground storage tank) for bulk storage and bulk transfer of jet fuel. Plans checking also approved a 12,000-gallon and 1,000-gallon AST for aircraft fuel dispensing. All life safety requirements conform to IFC 2015 and NFPA standards.
- Bueno Foods (El Encanto, Inc.) is a successful family-owned New Mexican food company located in Albuquerque, New Mexico since 1951. They have grown from a small family-owned grocery store into the Southwest's premier producer of New Mexican and Mexican style foods. Bueno foods passed their final fire inspection. TRAINING ACADEMY

EMS DIVISION

RECORDS MANAGEMENT

- Collaborated with UNMH's Director of Stroke & Heart Failure Programs, to evaluate processes for measuring, assessing and improving continuation of care for stroke patients.
- Provided Bernalillo Count's Department of Behavioral Health Services- Harm Reduction (DBHS) with data revolving around Naloxone administration. The efforts are aimed at reducing environmental and public nuisance harms and promote an overall safe community. With the data, DBHS collaborated with the GIS Department to develop a Naloxone response layer to the Needle Mapping page.
- Assisted ACS with developing processes to handle record requests and procedures for releasing and tracking record releases.
- Met with the City's Violence Intervention Program Manager to go over the process of becoming Medicaid provider and how to develop medical billing processes.

HEART

- In the month of April, HEART provided 88 rides with its "Rides with HEART" rideshare service.
- The HEART Home Modification Program provided 52 home installation services. We usually average 33. These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 34 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with "Leave Behind Narcan Kits" to provide to community members in need.
- HEART BEATS had their 1 year anniversary!
- To date, the HEART BEATS stroke discharge program has received over 191 referrals for service. HEART is currently working with 72 patients in the program. Two more staff members are currently undergoing training to expand the HEART BEATS program and are close to being able to perform assessment as a separate team.
- Be Brave Fall Prevention Classes taught at North Domingo Baca Multigenerational Center and Highland Senior Center.
- HEART hosted and taught Community Health Worker certification class.
 Thirteen students in total. Combined of AFR and AMR.
- Worked to help Violence Program Intervention (VIP) team identify resources for their mission.
- · Provided data gun violence data for data tending for VIP.
- Meet with Adult Protective Services to reestablish the partnership post covid.
- · Provided support fill for frontline units.

SPECIAL OPERATIONS

WILDLAND

- For the month of April, the Wildland Division hosted the Wildland Engine
 Academy, and the Cadet's Wildland week. The Wildland Engine Academy
 curriculum consists of; S-211, Portable Pumps and Water Use, and PMS-419,
 Engine Operator. The Cadet's Wildland week consists of all required training to
 become an entry-level Wildland Firefighter.
- Due to severe fire weather conditions, the AFR Wildland Task Force responded to multiple outside fires this month. AFR crews have done a tremendous job keeping these fires under control. Red Flag Warnings will likely continue into early-mid July, after which we will hopefully experience our monsoon season. The National Oceanic and Atmospheric Administration (NOAA) predicts that New Mexico will experience normal to above normal monsoons this year.
- AFR has deployed multiple resources to the fires that are affecting our state.





HAZMAT

- Updated training for all three shifts at both station 13, and 17. Training included a hands-on refresher with monitors, as well as our new decontamination system.
- State Fire came to show different types of hands-on training with station 17
 crew. The training consists of identifying an unknown substance with the use of
 the monitors we have on our squad trucks.

FIELD OPERATIONS CENTER

The Field Operations Center has remained steadily busy. With the help of filling
positions during the week from personnel in support divisions, forcing members
to work overtime has been lessened. The FOC continues to determine better
solutions for the staffing difficulties we see on an almost daily basis.

HEAVY TECHNICAL RESCUE

- AFR Crews along with APD responded to a 198' Cell tower to work with the
 individual and crews to return him to safety. The individual climbed up the tower
 without any fall protection. Due to his demeanor crews were prepared with a
 rigging and rescue plan if needed. After falling twice and getting caught on the
 self-supporting tower. The individual climbed down under his own power and
 was treated for his injuries. AFR crews worked with the cell companies and local
 Experts to ensure the tower was safe to climb and rescue as needed.
- AFR along with BCSO MCAT and APD Open Space completed 28 students
 through their Swiftwater operations and technician course. The course started
 with personal skill for water survival and team-based rescues. After completing
 the rigorous waterman ship test students continued on to develop response
 plans for search operations that will support rescue, recovery, and evidence
 as needed. Due to the nature of our river valley and the immediate Reponses
 required, the training was done jointly with our fellow responders and public
 service entities.
- AFR members completed the practical refresher for the flood channel river system. The flood channel system is very different from our Swiftwater responses due to being tied off, and we WILL NOT enter the flood channel waters for a go rescue. Albuquerque is growing and the water flow is increasing during the storms. AFR along with BCSO MCAT and APD open space trained for immediate response to forward safe rescue opportunities for anyone that is caught in the relentless powerful and predictable force of flood water.
- The AFR Airboat program was able to support the wildland task force with a
 fire they had below the bluffs of the city along the Rio Grande. Airboat One was
 able to act as a second look out, deliver crews to the waters/fires edge, deliver
 equipment and fuel, and offer immediate pick up if any crew needed to use the
 river as an escape route.


SPECIAL EVENTS


