




The time from when a 911 call is received until the information is gathered and the call is dispatched.


### TURNOUT TIME



These events are activated by the AFR Dispatch Center as a “Significant Event” based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

**8/1 - Commercial Fire:** AFR crews were dispatched to the corner of Central and San Mateo for a possible structure fire in fire district 11. Upon arrival, Engine 11 reported smoke and flames coming from an abandoned, boarded up Circle K. The firefighters quickly made entry and encountered heavy smoke and flames from floor to ceiling creating very poor visibility. Engine 11 crew found a large pile of trash burning near the location of the old soda machine which they began to extinguish while firefighters from other units quickly ensured the structure was clear of any occupants. 13 crews from different stations worked together to have this fire under control and extinguished in about 10 minutes. No injuries were reported.

**8/4 - Commercial Fire:** Units with AFR and BCFD were dispatched to the address of 5650 University SE at Netflix studios in fire district BCFD 38. Upon arrival crews found a fully involved small sized movie set with smoke and flames. All units who responded work diligently to extinguish this event and got it under control quickly. There were no firefighter or civilian injuries to report during this event.

**8/5 - Residential Fire:** AFR responded to the 2800 block of Sierra Vista NW in fire district 10 for reports of a residential fire. Upon arrival units found there was an exterior patio awning that was impinging on the main structure of the house and threatening another structure on the side that had minimal damage. There was major damage to the exterior and interior of main home found after quick extinguishment by AFR crews. The homeowners will be temporarily displaced.

**8/9 - Residential Fire:** AFR units responded to the 12000 block of Singing Arrow SE to a single story residential structure. Engine 12 was first on scene with flames and smoke declaring a defensive operation. A neighboring house caught on fire from heat exposure to the main structure. There was one civilian that reported minor injuries but was not transported to the hospital. There was a blowing gas line that shortly delayed extinguishment of the fire. AFR units worked tactfully to get containment of the fire.

**8/10 - Residential Fire:** AFR units responded to the 6900 block of San Francisco Rd NE for reports of a mobile home fire in fire district 20. Engine 20 arrived to find a fully involved mobile home that was impinging on the resident next to it. A defensive strategy was declared and Engine 20 began defending exposures. No injuries have been reported to civilians or fire personnel.

**8/10 - Residential Fire:** AFR units responded to a residential structure fire located on the 1100 block of Walker Dr NE in fire district 9. First units arrived to find smoke and flames showing from the exterior of the structure. Engine 9 quickly pulled hand lines to extinguish fire. Due to the quick actions of the crews, the spread of fire damage was contained to the exterior of the structure. There was minor fire damage to the adjacent structure. This property was vacant and boarded up prior to the fire.

**8/18 - Residential Fire:** AFR crews were dispatched to the 1000 block of Tomasita St NE for a residential structure fire in fire district 12. Engine 12 arrived on scene and reported heavy smoke coming from multiple sides of a two story residential structure. Engine 12 declared an offensive strategy as they pulled an attack line to make entry for fire control. Engine 8 arrived shortly after and secured a water supply as Rescue 12 was assigned to perform a search of the home to ensure that the homeowners were out of the house and safe. A total of 13 fire units were on scene to assist with fire operations.

**8/24 - Residential Fire:** AFR was dispatched to the 600 block of Georgia St NE in fire district 11 for reports of a small single story abandoned residential structure fire. Units from Station 11 arrived on scene and reported a working structure fire with smoke coming from multiple sides of the roof. Engine 11 forced entry into the home for fire attack as Rescue 11 entered the home to conduct a primary search. Fire control was achieved as the fire was primarily located in the attic space. A secondary search confirmed that no patients were inside the home. Engine 5 and Ladder 5 assisted with ventilation and fire control operations.

**8/24 - Residential Fire:** AFR was dispatched to the 5200 block of Zurich Pl NE in fire district 16 for a residential structure fire in a town home. Rescue 16 arrived on scene and reported a working structure with smoke coming from the back of the house. Rescue 16 entered the home to conduct a primary search as additional fire crews arrived on scene. Engine 16 stretched an attack line to conduct fire control operations. The homeowners were outside of the home and safe as an all clear of the structure was confirmed. The fire was located in a back bedroom and successfully extinguished by Engine 16. There were 12 fire units on scene to assist with fire operations. Three pets were located inside of the home and brought to safety. The cause of the fire is believed to be accidental.

**8/24 - Residential Fire:** AFR was dispatched to the 1100 block of Louisiana SE in fire district 11 for reports of a single story residential structure fire. Engine 11 arrived on scene and reported a working structure fire in the front apartment of an occupied three-plex. Rescue 11 and Engine 11 made entry into the home to conduct primary search and fire control and were able to successfully extinguish the fire that was located in one of the bedrooms. The adjacent two apartments were evacuated and a search was conducted to ensure all occupants were out of the structure and safe. Engine 5 along with Squad 2 assisted with ventilation operations as firefighters checked for extension. One occupant was assessed and transported to a local hospital due to smoke inhalation. The cause of the fire is believed to be accidental.

**8/27 - Residential Fire:** AFR units responded to a two story residential structure fire on the 5800 block of Quail Rd NW in fire district 17. Upon arrival, units reported smoke at flames coming from the second story of the abandoned building. AFR crews attacked the structure from the outside because of imminent roof collapse. The fire was contained to a single structure.

**8/27 - Apartment Fire:** AFR units were dispatched to reports of a two story multi-family residential structure with smoke and flame from a second story apartment on the 5700 block of Kathryn SE in fire district 11. Engine 2 was the first arriving unit and reported a working fire. Coordinated efforts by all responding units provided quick extinguishment. AFR will be worked with the property owner to ensure all occupants had a safe place to stay.

**8/27 - Residential Fire:** AFR Units were dispatched to the intersection of Thaxton and Walter SE in fire district 2 for a single story structure fire. Engine 1 was the first arriving unit and reported a working fire that was involving two separate structures. A coordinated effort from all units involved helped to extinguish the fire quickly. There were no reports of injuries to occupants or fire department personnel. Four households were affected and none have requested Red Cross assistance.

1. Albuquerque Fire Rescue had the privilege in taking part in National Night Out 2021 with our community members. Locally, National Night Out is sponsored by the Albuquerque Police Department's Crime Prevention Unit and has had success with this event in building relationships with communities to help make our neighborhoods safer and more caring places to live.
2. AFR's Public Affairs Office Driver Mike Schum and Lifesaver Cadre presented a proposal and was approved to spend \$5,000 from the COA Executive Safety Committee. Lifesaver training teaches participants the skills to control life threatening bleeds with tourniquets and pressure dressings. Today's approved funding will be used to purchase the equipment necessary for employees to be successful if they are ever faced with a life threatening bleed.
3. Members of AFR's Peer Support Team, including "Wheezy" the accelerant detection canine and "Wriggly" the crisis support canine, visited Washington middle school to offer support in the wake of the tragic loss of an 8th grade student to gun violence. AFR members spoke with and played with students during their lunch hour offering whatever support they could after this horrific event in our community.
4. AFR held a promotional ceremony with Interim Fire Chief Gene Gallegos along with Mayor Tim Keller and CAO Sarita Nair who acknowledged the accomplishments of those members that have been promoted over the past year as well as those members that have gone above the call of duty to make a significant impact in the community.
5. AFR along with Albuquerque Police Department were proud to take part in Summerfest over this past weekend at North Domingo Baca Park. AFR provided EMS Standby ensuring that all of our community members were safe.

- In preparation for the 2021 Balloon Fiesta, the Fire Marshal's Office has been attending regular meetings with city officials to ensure a safe event. We have received and are processing 88 tent permits for food vendors, arts and crafts, and many other events.
- In addition to the 10 movie standbys in Albuquerque last month, FMO was able to cover two special effects standbys for BCFD. One was an all-night standby in the East Mountains and the other was on 2nd street SW.
- FMO sent 4 personnel to Washington Middle School after the tragic event that took place this August to talk, interact and play games with the students. The day was meant to give the students an outlet to discuss things and have a day with positive role models. All of the feedback received was very positive.
- Three newly promoted Drivers/Inspectors from our office were recognized at the promotional ceremony. Congratulations to Lieutenant Clay Vincent, Driver Jonathan Justus and Driver Gary Davis! With promotions and retirements, FMO is seeking letters of interest for Drivers that would like to join our division. 
### ADAPT

- ADAPT has 74 properties that have been formally brought into the program, 29 have been cleared from the program and 45 are still in the program at different stages. ADAPT continuously monitors the properties that are in the program to track their compliance with the Nuisance Abatement Agreement.
- There are 151 properties on the Unsafe Buildings list, 2 new properties were added to the list, and 1 property was removed because of demolitions. The properties are labeled on the First Due application with a white "X" on a red background.
- The APD Crime Prevention Specialists inspected 1 property.

    - 2 of which were exceptionally cleared (clearance rate of 66%)
- Thank you to the Fire Academy for hosting a class on behalf of the State Fire Marshal's office. 3 AFR Fire Investigators attended the two-day NFPA 921/1033 class.
- Truck bed slides were installed into the two Dodge pickups. These slides allow us to use the entire bed of the truck and not have to crawl in to get something from the back.
- Interviews were conducted for the upcoming vacancy for the Captain position within the office. Captain Jason Ramirez was selected and will be attending the next Police Academy which is tentatively scheduled to begin in December.

## HUMAN RESOURCES

### HEALTH AND WELLNESS OFFICE

The H&W Office continues its mission to ensure Albuquerque Fire Fighters have valuable and accessible resources to address the health and wellness challenges that present themselves throughout a career.

- The BH Director and H & W Officer continues to visit stations to introduce the BH director and overview the program to crews. The goal is to visit two stations/divisions a week until the entire membership has had a chance to be introduced and is aware of the benefits available to them.
- The Peer Support Team met for the monthly meeting and decided to change the structure of the peer support team to reflect battalions instead of shifts. This will hopefully engage the team more to participate in the peer support process.
- The AFR Chaplaincy is scheduled to attend the IFOC Chaplaincy training (40 hour) course September 13th-17th.
- Participated in APD SCION. Scheduled our own Peer Support member to present in future SCION.
- Continued to network with surrounding agencies to optimize the delivery of our support systems. Met with Clinical group GD psych services, to potentially be a part of MAP network.
- Met with "Solutions" group contracted by Presbyterian Insurance to create a plan on using their services to deliver curriculum to include financial literacy

and performance related to diet. Classed will be implemented into the cadet program as well as to all members (video webinar).

- Met with APD and AFR stakeholders to discuss the implementation of an Athletic training program that would benefit both APD and AFR training academies.



**EMS**

- Paramedic School
  - \* 8 AFR members submitted preliminary letters of interest for the upcoming CNM paramedic school program.
  - \* Although not without difficulty, all current members attending Paramedic school are keeping up with required coursework.

**Community Training**

- AFR's Training Division, In conjunction with CABQ's Employee Learning Center, delivered Lifesaver training for 43 new employees. This training was stopped on August 16th as new COVID-19 shut downs were instituted.
- The training division sent one member to the FDIC. While attending the convention, Lt. Duree was able to get excellent training that we will be able to incorporate into future EMS and suppression classes.

**AFR Inter-division Involvement**

- Assisted with training and instruction of 97th Cadet Class.
- Created and assigned July assignment in Target Solutions.
- Worked with Dr. Pruettt on additional training for the department, filmed and edited AFR's first "Case Study". This is an ongoing format for training in which a member of the training staff and a 78 officer review a call that can be used to train on issues the department is seeing in the field.
- Attended AFR QA and MCB meeting to better coordinate training with the EMS division. Specifically, to be able to tailor training to problems identified by 78's in the field.
- Worked with Tech Services to add case study submission form to EMS SharePoint tab.
- Filmed and edited multiple training videos using AFR's studio.
- Working with Captain Salazar on EMS grant for equipment to expand MOTU training capabilities.
- A member of the training staff tested positive for COVID-19, and is currently home and doing fine. The member experienced minimal symptoms.

**Relicensure**

- Designed training plan to deliver necessary training to personnel, even with the cancellation of the Advanced Lecture Series. This will include a combination of Target Solutions, Remote education, and small in person groups (MOTU). Preparation for the roll-out of this is ongoing and in station training will start at the beginning of October.

**OPERATIONS****WILDLAND**

- During the month of August, the AFR Wildland Division facilitated a training exercise for 90+ employees at both the ABQ Bio Park and the ABQ Zoo. The training consisted of hydrant operations, and fire suppression drills.
- Members from both the Wildland Division and AFR Fleet participated in the creation of a new Type 3 Engine specification this month. These individuals traveled to Los Alamos and Santa Fe to examine each department's current Type 3 Engine configurations.
- The AFR Type 6 Crew that had been deployed for an extended period of time returned this month from their assignments in Oregon, and California. They were assigned to the Bootleg Fire in Oregon and the McFarland Fire in California. The crew received superior performance ratings from both fires. Thank you to the members who deployed and were incredible representatives of AFR!



**HAZMAT**

- Albuquerque Fire Rescue members attended a two-week Hazardous Materials Technician Course. This course will allow AFR members to safely and effectively mitigate hazardous materials incidents such as fuel and chemical spills as outlined in National Fire Protection (NFPA) 472, Standard for Competence of Responders to Hazardous Materials/ Weapons of Mass Destruction incidents. The AFR Hazardous Materials Division recently purchased several HazMat detection monitors. The course is vital to learning and understanding the capabilities of our new monitors. AFR is fortunate to be able to teach this course in-house with an incredibly knowledgeable cadre of instructors. AFR would like to recognize Hazardous Materials Coordinator Lieutenant Mark Jaquez, Captain Michael Rogers and Lieutenant Adrian Cordero for teaching this class.

**HEAVY TECHNICAL RESCUE**

- AFR and APD completed a joint IFSAC Rope Operations course through the New Mexico Firefighter Training Academy. This training supports AFR's Heavy Technical Rescue Program, Wildland Rapid Extrication Module, and local search and rescue operations by ensuring compatibility and team work among our resources.
- With the cooler temperature, more people are getting out into the Albuquerque Open Space. Search and rescues crews continue to respond to calls in the foothills. AFR and APD crews are working together to ensure efficient and effective responses for foothills rescues. Recently, crews responded in the rain to a lost individual. The joint operation with Bernalillo County and the City of Albuquerque resulted in the lost individual being returned home unharmed before conditions worsened.
