ALBUQUERQUE FIRE RESCUE SIGNIFICANT ALERT EVENTS

DECEMBER 2023

These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

- 12/3 <u>Apartment Fire</u>: AFR was dispatched to the Madeira Flats Apartments at 1100 Madeira SE in fire district 11 for reports of a possible structure fire. Engine 11 arrived on scene and reported a three story, multifamily dwelling with working fire coming from the first floor. The fire was brought under control within 10 minutes of their arrival. Damage to the structure was mostly contained to the single apartment. No injuries of civilians or firefighters was reported.
- 12/3 Residential Fire: AFR was dispatched to the 900 block of Cagua NE in fire district 11 for reports of a possible structure fire at a single-family dwelling. Engine 5 arrived on scene and reported working fire conditions coming from the roof. The fire was brought under control within 50 minutes of their arrival. Damage to the structure was significant.
- 12/9 Residential Fire: AFR was dispatched to the area of Palomas and Bell SE in fire district 11 for reports of a possible structure fire. Engine 11 arrived on scene and had to initiate a complete search of the vicinity to identify the source of smoke in the area. Once located, they reported a two story multifamily dwelling with a working fire moving from the first to second floor on the back side of the complex. The fire was brought under control within 13 minutes of their arrival. Damage to the structure was mostly contained to the fire apartment and the apartment above. Both units were currently unoccupied.
- 12/10 <u>Apartment Fire</u>: AFR and Bernalillo County Fire Rescue were dispatched to the 2600 block of Verde SW in BCFR district 33 for reports of a possible structure fire at a single-story single family dwelling. Engine 7 arrived on scene and reported working fire conditions coming from the attic. The fire was brought under control within 30 minutes of their arrival. Damage to the structure was significant. No injuries of civilians or firefighters was reported. BCFR Fire Investigators were called to the scene to determine the cause and origin of the fire.
- 12/13 Commercial Fire: AFR was dispatched to Ricks Automotive at 1901 Alvarado NE in fire district 2 for reports of a possible structure fire. Engine 13 arrived on scene and reported a small commercial mechanic shop with a working fire in one of the mechanical bays. The fire was brought under control within 11 minutes of Engine 13's arrival. Damage to the structure was contained to the work bays and one vehicle is a total loss. No injuries to civilians or firefighters were reported. The cause of the fire was due to accidental ignition of gasoline during mechanical work on an engine.
- 12/14 <u>HAZMAT Incident</u>: AFR was dispatched to the University Football Stadium at 1700 Avenida Cesar Chavez SE in fire district 2 for reports of a semi-truck leaking fuel. Engine 2 and Rescue 2 were dispatched along with AFR's Hazmat Task force from Station 13, Squad 3, Engine 13 and Ladder 13. Engine 2 arrived and located a semi-truck in the west parking lot actively leaking fuel from a ruptured fuel tank. Crews from Station 2 worked to contain the spill with absorbent. The Hazmat Task Force from Station 13 arrived and were able to seal the punctured tank and contain the leak. Approximately 75 gallons of fuel leaked from the tank. AFR crews turned the scene over to UNM for clean-up and cleared the scene.
- 12/17 Commercial Fire: AFR was dispatched to the Smith's Food Store building located at 6001 Lomas NE in fire district 13 for reports of a possible structure fire. Engine 13 arrived on scene and reported a large commercial building with a very large fire in the back of the building coming from the alleyway. The fire was brought under control within 15 minutes of their arrival. Damage to the structure was moderate, primarily due to water damage from the sprinklers that activated in the area closest to the fire. The sprinklers kept the fire damage to a minimum. No injuries of civilians or firefighters was reported. Firefighters controlled the water flow and removed the smoke in the businesses.
- 12/19 Residential Fire: AFR was dispatched to 4806 Central Ave NW in fire district 7 for reports of a possible structure fire at a multi-family dwelling. Rescue 7 arrived on scene and reported working fire conditions coming from the residence. The fire was brought under control by Engine 1 within five minutes of their arrival. Damage to the structure was contained to the apartment of origin. No injuries to civilians or firefighters were reported.
- 12/25 Bosque Fire: AFR received multiple calls about a fire in the Bosque north of Central in fire district 7. First arriving unit's confirmed an active fire in the Bosque on the west bank of the Rio Grande. The fire was determined to be a large trash fire in an illegal encampment that was beginning to spread into the salt cedar and cottonwoods. Crews deployed portable pumps into the river waters and pulled hand lines to the fire. The fire was brought under control within 30 minutes. No injuries to firefighters or civilians reported. The exact cause or persons responsible is undetermined at this time.

12/26 - Apartment Fire: AFR was dispatched to the Hacienda Apartments located at 815 Coal SW in fire district 1 for reports of a possible structure fire. Engine 1 arrived on scene and reported a three story multifamily dwelling with a working fire with heavy smoke coming from the second floor. The fire was brought under control within 13 minutes of their arrival. Damage to the structure was mostly contained to the apartment of origin. One civilian was treated on scene for smoke inhalation and later transported by ambulance to a local hospital. AFR Fire Investigators were called to the scene to determine the cause and origin of the fire. A cause has not been determined at this time.

12/28 - MVA: AFR was dispatched to 10912 Mahlon Ave NE in fire district 9 for a significant motor vehicle collision into a residential home. Rescue 9 and Engine 9 arrived on scene and reported 2 vehicles involved and 2 patients with critical injuries. A total of 7 units, including AFR's Heavy Technical Rescue Task Force, were dispatched to the scene to establish treatment, extrication and transport. Due to the severity and amount of damage sustained in the accident, one of the patients needed to be extricated from inside the home. Albuquerque Ambulance transported both patients from the scene to local hospitals. It is unknown what caused the accident. APD remained on scene to finish investigating the accident.

12/29 - Residential Fire: AFR units were dispatched to a possible structure fire involving a mobile home and a vehicle at 2802 Campbell Rd NW in fire district 10. Fire crews arrived to find a fully involved mobile home and a vehicle that was also on fire, the fire was also threatening another mobile home. Fire crews quickly contained and extinguished the fire, containing the fire to the main mobile home. A near by mobile home did suffer damage from the fire, neighbors were able to assist getting an occupant out of the home. The home owner and one of the people who assisted in removing the occupant were treated for smoke inhalation and were transported to the hospital, no other injuries were reported. The cause of the fire is believed to be accidental.

12/31 - Commercial Fire: AFR was dispatched to Trumbull and Louisiana SE in fire district 11 for reports of a commercial structure fire. Engine 5 arrived on scene and reported a working fire with flame and smoke showing from the interior. Due to the instability of the structure, a defensive strategy was taken. The fire was brought under control in 10 minutes of arrival. The building is a total loss due to multiple fires that have occurred previously. No injuries to civilians or firefighters are reported. The cause of the fire is undetermined.

12/31 - Residential Fire: AFR was dispatched to a reported residential fire at 1004 Chuckar SW in fire district 14. Rescue 14 arrived and reported a working fire with flames showing from the second floor. Rescue 14 assumed command in the offensive strategy. The fire was brought under control within 15 minutes of arrival. There was significant fire damage to the second floor. The occupants were able to safely evacuate prior to AFR arrival. No injuries to firefighters were reported. The cause of the fire was determined to be accidental.

- 3. AFR is proud to announce the graduation of the 101st Cadet Class. 26 cadets completed the 18-week academy and will now join the department as sworn firefighters. They enter the ranks at probationary Firefighter 2nd Class and receive 11 months of intensive on the job training and monthly evaluations in order to attain the rank of Firefighter 1st Class.
- 4. AFR would like to congratulate the newest members of the Fire Investigations Division. Drivers Dylan Cordova, Brandon Maloney, and Mervin Martinez recently graduated from the Law Enforcement Academy. They completed a 19-week academy and are now certified law enforcement officers. They will become a vital resource to the department and the Fire Investigations Division.
- 5. The outside fire response pilot program is live. Brush 3 went into service at Station 3 and will be responding to calls and patrolling the areas of East Central to help Stations 5, 11, 12 and 13 which experience the highest volume of outside fire responses. Brush 3 is a 2006 F550 that is assigned to the Wildland Division as a Type 5 brush truck. It is being temporarily repurposed to respond to outside fires in Albuquerque's busiest districts to help reduce call volume for AFR's busiest engine companies. This response model should also keep those companies available for medical emergencies and large fire responses.

- ADAPT currently has 58 properties that are in the program at different stages.
 ADAPT continuously monitors the properties to track their compliance with the Nuisance Abatement Agreement.
- There are 79 properties on the Unsafe Buildings list. 2 new properties were added to the list this month. The properties are labeled on the First Due application with a white "X" on a red background. In the field these properties are marked with a red spray painted "X" and the letters "AFR" under it.
- The following properties were cleared from the ADAPT program with an average of 53% reduction in criminal activity:

The Arioso apartments had a major improvement for calls for service due to crime prevention standards being implemented. A large part was due to installing automatic gates and fencing.

PLANS CHECKING

- The Plans Checking Office recently started preliminary review meetings with the new owner of Two Park Central Tower, 300 San Mateo NE. The new owner wants to work with the City of Albuquerque and the Fire Marshal's office to help develop the towers into affordable multifamily high-rise apartments. This would be the first multifamily high-rise apartment building in the City of Albuquerque.
- The Plans Checking office held meetings with representatives from Route 66
 Flats (a housing project for lower-income families). The 35,000 square feet project
 will provide affordable housing in the Southwest of Albuquerque near Central
 and Unser Blvd. It will include nearly 50 one-bedroom apartments as well as
 communal spaces and a partnership offering support services to get people back
 on their feet.

EMERGENCY SERVICES

RECORDS MANAGEMENT

- Gathering data for the Ambulance Supplemental Payment Program. This program could allow AFR access to additional federal funds for Medicaid and Medicare EMS transports.
- Completed and submitted AFR's Medicaid/Medicare Ground Ambulance Collection Tool and are assisting Bernalillo County Fire Rescue and Rio Rancho Fire Rescue with their Ground Ambulance Collection Data.
- Provided the RMS portion of AFR's Performance Measures to administration.
- Attended National Emergency Response Information System (NERIS) Data Framework Webinar. This will be the new national fire reporting database, replacing National Fire Incident Reporting System (NFIRS). This system is a reporting standard that fire departments use to uniformly report on the full range of their activities from fire to emergency medical services.
- Working with the Medical Control Board and other stakeholders on Albuquerque-Bernalillo County Emergency Medical Services (ABCEMS) protocol updates.
- ABCEMS Protocol App transitioned to an unlisted app. This will streamline the download process of iOS users.
- Completed the process of incident response data migration of AFR's SSAS, SSAS Fire, and cubes, to improve performance and speed of analytic tools.
- Continued data collection for AFR 1st year review. This process will allow AFR to maintain its accreditation through the Center for Public Safety Excellence (CPSE).
- Continued developing content for the informational dashboards at all stations.
 This information will include emergency response data, interdepartmental communications as well as other relevant Department and City information to improve and information flow and communication within the Department.
- Continued to track and analyze data revolving around assaults on EMS personnel during emergency response. This data is being used to further understand this current issue and determine steps to take to make emergency response safer for field providers as well as patients.
- Continued work on the Premier One CAD to Image Trend Elite integration. This
 will create a single source for all of AFR's statistical analysis and improve the
 accuracy and consistency across all variables.
- Continuing the process of moving AFR's EMS documentation to the new version of the National EMS Information System (NEMSIS). This is the national system used to collect, store and share EMS data from across the country. NEMSIS develops and maintains a national standard for how patient care information is documented. This system is designed to improve patient care through standardization and point of care data aggregation.
- Continued collaboration with Albuquerque Fire Rescue, Bernalillo Fire Rescue and Albuquerque Ambulance to create a more uniform approach to EMS documentation in our system. The collaboration will create more consistency across the system as well as increase the ease of transferring information between the 3 agencies during emergency response.
- Provided support fill in for in for frontline units.

PHARMACY

- CR2 AEDs are still attempting to be connected to WIFI.
- Henry Schein PO has been extended and money has been added for the second half of the fiscal year.
- Stryker PO being created to purchase spare gurney batteries.

HEART

- HEART provided 88 rides with its "Rides with HEART" rideshare service.
- The HEART Home Modification Program provided 42 home modification installation services. These home installations included grab bar installations, door widening and ramp building in order to prevent falls.
- HEART received and processed 91 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with "Leave Behind Narcan Kits" to provide to community members in need.
- Fentanyl Strips to Frontline units has been completed and supply will be ongoing.
- Buprenorphine Program- Inserting information for suboxone treatment in the LBN kits. Individuals will receive access to an app with counseling, cognitive behavioral therapy, and contingency mgmt. Plus, monetary rewards for compliance. Will be an ongoing push.
- To date, the HEART BEATS stroke discharge program has received over 434 referrals for service. HEART is currently working with 75 patients in the program.
- Pediatric Assessment Program is live. AFR HEART division partnered with UNM
 Hospital for pediatric bronchiolitis assessments. The mission is to provide a
 patient visit with assessment 24-48 hours post discharge for sick children who
 were discharged from the hospital with oxygen. Currently we have worked with
 15 patients.
- HEART Carpenter partnering with Department of Senior Affairs to assist with home mods for our elderly in the community.
- Met with Adult Protective Service to discuss referred patients.
- Continue to build and foster a partnership with New Mexico Cancer Center with Wrigley's help.
- Partnered with ACS on several patients.
- Working closely with UNM Center for Development and Disability (CDD) for specific clients who require specific treatment plans and instructions.
- EMS Corp mentorship meetings.
- · Participated in Leadership Committee meeting.
- Participated in Peer Support Committee.
- Provided support fill for frontline units.

EMS TRAINING

- During December, the EMS Training Division kicked off our eight-week EMT-B course. This is held at the AFR Training Academy and will be running through the end of February. This cohort consists of 12 Firefighters who just completed the 101st cadet program, as well as 11 members of a new state pre-apprenticeship program.
- Continued developing the curriculum for the 2024 EMS training cycle.
- The AFR studio shot and edited multiple training videos with Dr. Pruett, Battalion Chief Ortiz, and EMS Training Division Staff.
- Coordinated, assigned, and tracked monthly department training on Vector Solutions.
- The EMS Training Division assisted 5 recent graduates of the 101st cadet program
 to successfully test for and obtain their NM EMT licenses. These individuals
 moved from other states to attend AFR's cadet program, and after obtaining their
 state licenses they have all been assigned to the field.
- We currently have 1 student attending CNM's paramedic program, and 18 attending UNM's.

SPECIAL OPERATIONS

WILDLAND

- AFRs Wildland Task Force has responded to multiple fires in the Bosque during the winter months. Here in New Mexico, Wildfire season is year-round.
- For the month of December, the Wildland Division is currently working on the training schedule for the new year and we are planning on hosting one Wildland Engine Academy in late April, two S-212 Chainsaw Operation courses in late March and October, and two S-270 Basic Air Operation courses in March and April.
- The Wildland Division is partnering with City of Albuquerque Senior Affairs to donate firewood to seniors across ABQ. This dead tree removal event at Coronado Park was an excellent opportunity to work with CABQ partners and used as a training opportunity for AFR's Wildland Division members to advance and certify to the next Intermediate Faller 2 level.






HEAVY TECHNICAL RESCUE

- Foothills crews worked multiple search and rescue events with APD open space rescue rangers ranging from lost individuals, injured legs, and a crashed paraglider. The technical rescue skills, fitness of our members, and their experience were the support for these events to be resolved.
- AFR crews had to rescue an individual that fell off of a bridge into the freezing Rio Grande River. The patient had multiple severe traumatic injuries and Swiftwater members in dry suits swam out to the patient to stabilize and package. APD Open Space along with AFR utilized the city airboat to gain access and transport the patient directly to EMS.
- 14 AFR members, along with 8 APD and 1 Isleta PD, completed their Rope Rescue Operations Course together. This course is the foundation rescue course that allows it members to rescue in the vertical environment of industrial, wildfire, and wilderness areas. The joint nature of this course is critical in continuity across our response partners for this low occurrence high risk events that are jointly completed. It also ensures compatibility among our equipment.
- AFR HTR program supported the CABQ Zoo with an urgent repair in a confine space that was Immediately Dangerous to Life or Health. The water filtration and heating system that sustains some of their residents during the cold months was no longer working. Alongside with Zoo/BioPark members and AFR Confined Space Technicians, we completed the repair and everyone is safe and warm.







HAZMAT

- First of two trainings competed at Double Eagle put on by the US Army Cops of Engineers. Stations 17 and 22 attended the training which involved awareness of munitions at sites near Double Eagle Airport.
- Multi day training scenarios set up with the 64th. Initial planning complete with site visits. Training will be January 9-11 and range from hands on classroom to larger multi-agency scenarios.
- December 14th Station 2 and Hazmat task force from Station 13 responded to a fuel leak from a ruptured semi-truck tank. Approximately 75 gallons of fuel was leaked. The Task Force was able to stop the leak and contain the fuel.

SPECIAL EVENTS

- Engine 6 provided EMS standby at the Old Town Holiday Stroll and tree lighting on December 1st.
- Station 3 participated in the Annual Albuquerque Twinkle Light Parade. They
 provided EMS standby for the event as well as decorated E3 and Med3 as Rudolf
 (Med3) pulled a sleigh (E3) with Frosty the Snowman. AFR took 3rd place in the
 government category.
- EMS standby for Downtown Luminaria Tour 12/24 provided by E1.

FIRE INVESTIGATIONS DIVISION

- The FID responded to a total of 108 responses in 2023 including 54 fire investigations, 40 consult cases, and 14 ATF/Canine cases. In 2023, 53.5 % percent of all arsons (incendiary fires) were cleared by either arrest or exceptional means.
- On December 15, 2023, Drivers Brandon Maloney, Mervin Martinez, and Dylan Cordova graduated from the 19-week CNM Law Enforcement Academy. They will become a vital resource to the department and the Fire Investigations Division.
- On December 20, 2023 the Fire Investigations Division along with Station 13
 C-Shift participated in the annual Southeast Christmas Toy Drive. AFR personnel
 helped Santa donated Christmas gifts to 45 children at the Singing Arrow
 Community Center. The children received a special visit from Santa and their
 neighborhood firefighters.
- On December 26, 2023, fire investigators arrived at 815 Coal Ave SW and examined apartment 218. Investigators noted that the door was not forced open. The apartment was approximately 800 square feet, single-bedroom and single-bathroom. Upon entering the front door of the apartment, severe smoke and heat-related damage was noted to all interior surfaces and furnishings. The kitchen and living room area were near the front door and sustained severe smoke and heat-related damage. Investigators continued to examine the north side of the apartment, there was severe smoke and heat related damage and severe soot staining to the bedroom and bathroom. There was heavy mass loss found in the bathroom area of the apartment with smoke and soot staining found throughout the remainder of the apartment. Fire crews removed dry wall from the bathroom and bedroom areas during fire suppression activities and overhaul operations to check for fire extension in the void spaces. Wall studs and ceiling trusses revealed no fire extension in the void spaces. Fire patterns were observed on the north wall

between the bedroom and bathroom door displaying a "V" pattern indicating that the fire originated in the bathroom and propagated into the bedroom. A large pile of clothing was found in front of the bathtub near the north wall and was heavily consumed by fire. Fire patterns revealed that this is the area of origin. A suspect was identified and an arrest warrant was written by investigators and approved. Once the suspect is located, they will be charged with felony arson.

- The Public Affairs Office worked together in planning, coordinating and assisting with AFR's 101st Cadet Graduation.
- Attended recruitment events at CNM, Technology Leadership High School and Workforce Connections.
- A video of the CPAT was filmed and edited for social media in preparation for open enrollment.
- The Public Affairs Office assisted with the preparation, logistics, execution and filming of the Twinkle Light Parade.
- Assisted with the retirement celebrations for Capt. Craig Deal, Lt. Rob Herrera and Lt. Ted King
- Memo created and sent soliciting letters of interest for continuation in Honor Guard as well as new members interested in joining. A total of 10 members voiced interest and training TBD January.

STRATEGIC PLANNING

- CPSE training and education began with DC Ferando preparation for AFR CPSE accreditation management.
 - * Reviewing metrics and structure for annual review.
 - * Travel arrangements made for CPSE conference in late February.
 - * Began review of CPSE Quality Assurance manual, previous ÅFR Strategic Plan and AFR Standards of Cover (2023).
- Memo created and sent soliciting letters of interest for continuation in Honor Guard as well as new members interested in joining. A total of 10 members voiced interest and training TBD January.

POLICY

- Beginning to receive policy drafts. Creating and organizing a system for policy approval and uploading/implementing.
- AFR Policy Committee met late November. Next meeting will be mid February after members of committee have taken the AFR Drivers Exam.

STAFFING

- Shift Commanders to begin new job position on December 30. As former FOC BC, I have been working with Deputy Chief Melek to create job aids to help the new Shift Commanders in managing Telestaff/FOC needs during their respective shifts. These job aids are being uploaded to the X drive for the Commanders to access for assistance in our absence.
- The transition will be gradual. A significant aspect of this area of management is interacting with payroll at the end of a pay period when it closes (typically on the Monday following PPE). Due to the nature of each Shift Commander's shift,

the opportunity for this in-the-seat training will not come around every week. The same challenge is presented at PPE when the Promotions Retirements Transfers memo comes out. Any time a given Shift Commander's shift falls on one of these days, we will work on these aspects of FOC/Telestaff/Payroll/HR interaction. But it will take some time due to the schedules.




