



# ALBUQUERQUE FIRE RESCUE SIGNIFICANT ALERT EVENTS

### DECEMBER 2020

These events are activated by the AFR Dispatch Center as a "Significant Event" and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

12/4 - <u>Residential Fire</u>: AFR was dispatched to the area of Washington St NE/Altura Ave NE in fire district 13 for a residential structure fire. Initial arriving fire crews reported that a vehicle had crashed into a home and subsequently struck the gas meter, causing the car and garage fire. The driver of the vehicle was able to exit the vehicle safely and did not require transport. The home owner self-evacuated and was not harmed. Station 13 fire crews pulled attack lines and were able to extinguish the fire in the garage and contain the blowing gas line fire preventing it from extending into the home. The home owner will be displaced for an unknown amount of time as a result of the fire. No injuries were reported to firefighters.

12/8 - <u>Commercial Fire</u>: AFR was dispatched to the 2000 block of Morningside Drive NE in fire district 13 for reports of a commercial structure fire. First arriving units reported smoke and flames coming from the roof of the building and initiated a quick attack and simultaneous primary search of the occupancy. Firefighters were able to safely evacuate the business owner and get the fire under control quickly, preventing it from spreading to the interior of the building. The main body of fire was located in the metal awning located in the front of the office building, and minimal damage was done as a result of the quick response from firefighters on scene. No injuries were reported to civilians or firefighters, the cause of the fire is unknown.

12/10 - <u>Residential Fire</u>: AFR responded to a single story abandoned residential structure at the corner of Domingo Rd and Alcazar St NE in fire district 5 for reports of a possible structure fire. Engine 11 was first on scene and found a working fire with smoke showing from the front of the structure. AFR made an aggressive offensive attack and was able to get the fire extinguished within minutes. No injuries were reported.

12/11 - <u>Residential Fire</u>: AFR responded to a single story residential structure on the 10300 block of Manzanillo Ave NE in fire district 16 for reports of a possible chimney fire. Engine 16 was first on scene and found light smoke showing from the front of the structure. Firefighters made a quick attack and was able to extinguish the fire that had extended in to the wall from the fire place. There was minimal damage to the home and the residents will not be displaced. There were no injuries to civilians or firefighters.

12/12 - <u>High-Life Occupancy Fire</u>: AFR responded to the Motel 1 at 2001 Candelaria Rd NE in fire district 19 for a 3 story, large motel fire. Upon arrival, AFR battalion 3 found a working fire with smoke showing from the second floor. AFR crews made a quick attack and extinguished the fire with in minutes while simultaneously performing a primary search. The Fire was contained to one fully involved motel room on the second floor. There were no injuries to firefighters or civilians.

12/14 - <u>Residential Fire</u>: (see top picture) AFR was dispatched to the 200 block of Yucca Dr NW in fire district 7 for a single story residential structure fire. Fire Crews from Station 7 arrived to find smoke and flames coming from a single story detached garage. Crews initiated a quick interior attack and were able to get the fire under control quickly. A search of the structure was performed by Rescue 7 to ensure there were no occupants inside. After a quick knock down of the fire, secondary crews checked for extension and preformed salvage and overhaul. Minimal damage was done to the house as a result of the fire. No injuries were reported.

12/14 - <u>Residential Fire</u>: (see bottom picture) Albuquerque Fire Rescue was dispatched to the 5400 block of Rim Ct SW in fire district 7 for a working structure fire involving a mobile home. The first arriving units reported heavy smoke and flames coming from multiple sides of a single wide mobile home. Station 7 crews performed a simultaneous search and fire attack once making entry into the home. An all clear of the structure was declared as additional fire units arrived on scene to assist with fire attack. The fire was brought under control as multiple units ensured that the fire did not spread to nearby homes. All occupants were able to evacuate the home safely and there were no injuries to civilians or firefighters. The a potentially dangerous fire.





# ALBUQUERQUE FIRE RESCUE SIGNIFICANT ALERT EVENTS

DECEMBER 2020

12/15 - <u>Residential Fire</u>: (see top picture) Albuquerque Fire Rescue was dispatched to the 6300 block of Dennison Rd SW in fire district 7 for a residential structure fire. Rescue 7 arrived on scene and reported heavy black smoke coming from the garage and took command of the incident. As additional units arrived on scene, command assigned Engine 7 as attack group and they began an interior search of the structure and fire suppression operations. Ventilation was performed to help the visibility of the interior fire crews as they were able to locate and control the main body of fire coming from a bedroom in the back of the house. A primary search of the home was completed and all occupants were accounted for and safe. Additional ventilation operations were performed by Ladder 17 and fire crews called a loss stopped to the and complexities of the home. There were no injuries to civilians or firefighters and the cause of the fire is unknown. The homeowner will displaced as a result of the fire and smoke damage to the home.

12/17 - <u>Residential Fire</u>: Albuquerque Fire Rescue crews were dispatched to a possible structure fire on the 1000 block of Florida St SE in fire district 11. Engine 11 arrived to find smoke and flames coming from a boarded up single-story residential structure. Fire crews had to force entry through plywood and boarded up doors to gain access and begin attacking the fire while simultaneously conducting a search of the structure. Firefighters quickly ensured the structure was clear of occupants and gain control of the fire. There was a partial roof collapse over the back corner bedroom. No injuries were reported.

12/19 - <u>Residential Fire</u>: Albuquerque's Fire Rescue crews were dispatched to the 9600 block of Camino del Sol NE in fire district 16 for reports of a possible structure fire. Firefighters from Station 16 quickly arrived and reported smoke and flames coming from the roof of a single-story residential structure. Crews pulled a hose to the front door of the structure where they were met by an elderly male who stated his wife was still inside. Firefighters rapidly began searching the structure while crews were simultaneously attacking the fire. The Firefighters located the elderly female and pulled her out to safety. Both patients were treated on scene for smoke inhalation and transported to a nearby hospital. There were no injuries sustained to firefighters. Thanks to the quick action of all the Firefighters on scene, while both patients suffered smoke inhalation and burns, early indications are that they will survive.

12/20 - <u>Apartment Fire</u>: Albuquerque Fire Rescue units were dispatched to the 6400 block of Academy Rd NE in fire district 15 for reports of a possible structure fire. Upon arrival, the first arriving unit reported smoke and flames coming from the second story of a two-story apartment complex. Firefighters quickly pulled a hose line up to the second story and made entry into the apartment. Firefighters searched the residence to ensure it was clear of any occupants. They quickly extinguished the fire containing it to the apartment of origin and keeping it from spreading to any of the adjacent apartments. Thankfully there were no injuries sustained to firefighters or civilians. The family who occupied the apartment will be temporarily displaced.

12/21 - <u>Electrical Fire</u>: (see bottom picture) AFR crews were dispatched to the Albuquerque Sunport in fire district 2 for reports of an electrical fire at an external transformer. Engine 2 arrived on scene and reported heavy black smoke and flames coming from the transformer and called for additional resources to assist in mitigating the event. Once additional resources arrived, AFR Command ensured that the power had been disabled to the transformer by PNM and they began their fire suppression efforts. Firefighters were able to utilize several Dry Chemical Extinguishers to control the flames, as well as use AFFF (Aqueous Film-Forming Foam) to get the fire fully extinguished. A total of 20 fire apparatus were dispatched to help in the firefighting efforts including 2 units from Kirtland Fire. AFR was able to establish unified command quickly, utilize resources appropriately, and get control of an unsafe situation by extinguishing the fire. No injuries were reported to firefighters or civilians. The initial cause of the fire is under investigation.

12/24 - <u>Residential Fire</u>: AFR was dispatched to the 4500 block of Rincon Rd NW in fire district 7 for an outside shed fire. First arriving units reported that an outside shed was fully involved and impinging on a nearby house. Crews deployed hand lines and were quickly able to gain control of the fire preventing the flames from extending to the house. As crews were extinguishing the fire, one person was pulled out of the structure by Rescue 7 and was transported to a local hospital for burns and smoke inhalation injuries. The condition of that person is not known and the cause of the fire is under investigation.





# ALBUQUERQUE FIRE RESCUE SIGNIFICANT ALERT EVENTS

### DECEMBER 2020

12/26 - Commercial Fire: Albuquerque Fire Rescue was dispatched to 1560 Juan Tabo Blvd NE in fire district 8 for a single story commercial strip mall fire. Rescue and Engine 8 arrived on scene and reported heavy black smoke and flames coming from the north side of the building and initiated an offensive attack on the fire deploying multiple 2 1/2" hand lines and ground monitors. Due to the size and complexity of the fire, a 2nd Alarm was dispatched and a total of 21 fire apparatus were on scene. Once fire crews were able to gain access into the building, Ladder 9 was used to flow water at 2,000gpm to gain control over the fire. While search crews entered the structure to ensure all occupants of the building were out and safe, the focus remained on containment of the fire to the building of origin. Fire crews were able to keep the fire from spreading to the 6 other businesses of the strip mall and were able to call fire under control. One of the occupants of the building had been transported to the hospital for burn injuries and one firefighter was also transported due to exhaustion. The cause of the fire is under investigation.

12/28 - Residential Fire: AFR fire crews responded to a residential structure fire on the 10300 block of Santa Paula Ave NE in fire district 16. Fire crews arrived to find smoke coming from inside the home. AFR crews immediately went inside to investigate and found a fire in the laundry room. Firefighters had the fire under control within minutes. The fire was determined to be accidental. No injuries were reported.

12/29 - Apartment Fire: AFR crews were dispatched to the 900 block of Thaxton SE in fire district 2. Crews arrived to find smoke coming from the window of a second story apartment complex. Units brought the fire under control within minutes. No injuries were reported.

- 1. AFR was happy to partner with The Western Trail Early Head Start Program and deliver Christmas gifts to families in need. This has been a wonderful tradition with the Fire Marshal's Office and AFR is glad to have been able to provide once again for APS Head start Families. A special thank you to Diane Archibeque from Early Head Start and thanks to Family & Community Services for the opportunity for AFR to give to our community.
- 2. Fire Chief Paul Dow presented the crew of Station 16 and Battalion 3 C-Shift with an AFR Challenge Coin for their rescue efforts at a house fire in mid-December. Their efforts, which included fire suppression along with search and rescue operations, were the direct result of two lives being saved from a fire in NE Albuquerque. As crews entered the home they found one of the home occupants and led him to safety. As they continued fire attack and search, they were able to locate the home owners wife and were able to successfully rescue her from the home that was filled with smoke. Thanks to these heroic acts of Station 16 and the Command of Battalion 3, both occupants of the home were rescued and transported to a local hospital.
- AFR joined City Councilor Cynthia Borrego in loading up 300 kits of PPE to be handed out to local Westside businesses. Albuquerque continues to work together in allocating resources for local businesses
- 4. AFR was honored to work with Dream Big, Albuquerque Police Department, and Cottonwood Mall to help deliver an unforgettable Christmas for several deserving children and their families. - There are 184 properties on the Unsafe Buildings list; 14 new properties were added this month. This list is in Target Solutions file center, under the FMO > ADAPT > Unsafe Buildings tab. The properties are labeled on the First Due application with a white "X" on a red background.
- 167 properties have been identified for the Crime Only Properties Program. 6 APD Crime Prevention Specialists are diligently
  working on verifying each police report associated with all 167 properties. They have reviewed 90 properties, and 34 of the
  properties reviewed meet the program criteria. Eight letters have been sent to the property owners, and three inspections are
  scheduled. 2 of the inspections have been scheduled, and the Nuisance Abatement Agreement is being drawn up.







#### HAZMAT

- The AFR Hazardous Materials Coordinator, Lieutenant Mark Jaquez, taught the Hazardous Materials Awareness level course to thirty-three APD Cadets. A person certified at the Hazardous Materials Awareness level will have demonstrated competency in the necessary knowledge and skills to recognize the presence of hazardous materials or WMD, protect themselves, call for trained personnel, and secure the incident.
- All 22 AFR Engines will be receiving new CGI TP-17 combustible gas indicators. These new gas indicators are capable of detecting natural gas and pinpointing the location of leaks. This capability will be a great asset to our engine companies to assist with early leak detection before requesting additional resources such as a Hazmat Squad or New Mexico Gas.

• In December, AFR crews responded to several complex incidents that required prolonged extrications and tested AFR's skills. AFR crews were able to extract entrapped victims effectively and provided excellent patient care.


