





These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

- 12/1 Commercial Fire: AFR crews responded to a two-story large commercial structure fire around 12:30 am on the 2500 block of Monroe St. NE in fire district 13. Engine 13 arrived to find heavy smoke and flames showing from an exterior stairwell. The fire extended into the wall and roof on the second floor of the building. An aggressive offensive fire attack with a total of three hand lines and the use of a platform Ladder 13 was able to stop the fire from spreading. Due to the size of the building, obtaining fire under control took a little while. Fire under control was achieved and a search of the property was completed without incident. There where no injuries to civilians or firefighters.
- 12/3 Commercial Fire: Engine 4 was first on scene of a working structure fire in a warehouse on 1809 8th St. NW in fire district 4. AFR crews went defensive immediately applying several master streams. Unfortunately the building was a total loss and the majority had collapsed. There were no injuries to firefighters or civilians.
- 12/5 Apartment Fire: AFR units responded to reports of an apartment fire on the 12000 block of Skyline Rd NE in fire district 12. Engine 12 arrived on scene first within 4 minutes to find light smoke showing. E12 forced entry and encountered heavy black smoke. E12 stretched a 1 3/4" handline for fire control while Rescue 8 performed a primary search. The apartment was declared all clear and fire under control in under 10 minutes. The occupants were not home at the time of the fire. 2 families were displaced due to the damage. No firefighters or occupants were injured.
- 12/6 MVA: AFR Early this morning around 12am Engine 10 responded to a Grey Hound bus that crashed into a fence. The Greyhound bus went off the road on the frontage road eastbound between 12th and 8th street in fire district 4. 8 AFR units and 4 AAS units responded. A total of seven patients were transported to local hospitals. There were a total of 25 people on the bus.
- 12/8 Residential Fire: At approximately 4 am Engine 4 along with 9 other AFR units were dispatched to a structure fire at Odelia and Broadway in fire district 4. Engine 4 was first on scene of a single story abandoned structure with heavy smoke and flames showing. Engine 4 was successful with a quick fire attack and was able to quickly extinguish the fire. There were no injuries reported.
- 12/10 Residential Fire: AFR units were dispatched to reports of a structure fire on the 1000 block of Stover Ave. SW in fire district 1. AFR responded with 13 units and 34 personnel. E4 arrived to find a small house with a working and were advised of a person in the house. Crews quickly made entry and rescued the occupant who was overcome by smoke and had his lower extremities burned. AFR transported the patient to a local hospital. The fire was extinguished in 8 minutes. Five bystanders were evaluated for smoke inhalation but were not transported.
- 12/11 Commercial Fire: At approx 11pm, AFR was dispatched to reports of a commercial fire at 6705 Acoma Rd SE in fire district 11. Station 11 units arrived on scene and declared a working fire. Heavy fire was found in the alley between 2 large commercial structures. Power lines and transformers were arcing overhead. The fire was knocked down and the commercial structures were searched and checked for fire extension. One individual was found deceased in the fire and the cause of the fire is currently under investigation. No injuries to firefighters were reported.





- 12/12 Residential Fire: At approximately 8:30am, AFR crews were dispatched to the 800 block of San Andreas Ave NW for a structure fire at a single story residential structure. Engine 6 arrived on scene and extinguished a small fire. The fire rekindled after crews left the scene and crews were dispatched back out to the address and quickly extinguished the rekindle. This fire was ruled accidental, and there was no injury to fire fighters or civilians
- 12/15 Apartment Fire: At approximately 6:30am, AFR units were dispatched to reports of a fire at a two-story 4 unit apartment complex located on the 1200 block of Ortiz St. SE in fire district 11. Within minutes, Engine 11 arrived on scene and immediately began fighting the fire. Other units quickly arrived, and with their help, crews were able to contain the fire to one apartment unit. Three units were occupied at the time of the fire but no injuries were reported. All of the building occupants were displaced. One dog was transported to a nearby veterinarian to be treated for injuries related to the fire.
- 12/17 Residential Fire: AFR At approximately 7:00am, a fire was reported at a single-story residential structure at Monroe and Claremont NE in fire district 13. AFR quickly had units on scene. Engine 13 was able to successfully stretch an 1 3/4" hose line and make a quick attack to render the fire under control within minutes. The fire started from a floor heater and was contained to a single room in the residence. One resident was transported to the hospital for minor burns.
- 12/18 Commercial Fire: AFR At approximately 4:30am, fire crews responded to a structure fire at the Spin Cycle laundromat at 2130 Juan Tabo NE in fire district 9. Fire crews arrived to find fire on the exterior of the building spreading up to the roof. After extensive efforts to expose the fire on the exterior, crews were able to get the fire under control and stop the fire from entering the structure. There were no injuries and the cause of the fire is under investigation.
- 12/18 Residential Fire: At approximately 6:15am, AFR units were dispatched to a 2 story residential home on the 10800 block of Vicenza Dr. NW in fire district 21. Upon arrival, Engine 22 found smoke and flames coming from the garage located at the front of the house. Engine 22 stretched hand lines to extinguish the fire and the first incoming rescue unit searched the house. The fire was declared under control within 18 minutes of arrival. All of the residents self-evacuated and there were no injuries to firefighters or occupants.
- 12/19 Residential Fire: At approximately 5:15pm, AFR units were dispatched to the 1200 block of Pearl Street SW in fire district 14. Engine 14 was first on the scene and discovered a chimney fire that they were able to contain to the living room of the home. The family was displaced and assisted by the Red Cross.
- 12/22 Commercial Fire: At approximately 5:30am, AFR responded to a smoke investigation call at 1803 6th street NW in fire district 4. Engine 4 was first on scene to find smoke and flames coming from a large commercial warehouse. The engine officer immediately called for additional resources. Fire crews went defensive immediately because of the size of the building and access. Firefighters worked for hours battling the blaze and eventually the fire was stopped about 3 hours after initial arrival. The warehouse was stored with movie props as well as an art studio. There were no occupants inside of the building at the time of the fire. No injuries were reported and the cause is unknown.





- 12/22 Residential Fire: At approximately 4:00pm AFR units were requested out by APD to 2400 block of Elizabeth NE in fire district 9 for mutual aid. Once the scene was secured, Engine 9 arrived to find smoke and flames coming from the home. Firefighters had the fire contained and extinguished within minutes. The fire was contained to the kitchen area although the house sustained extensive smoke damage. There was one occupant inside the home that self evacuated and transported to a local hospital for assessment.
- 12/27 Residential Fire: At approximately 6:34am, AFR was dispatched to the 500 block of Dorothy SE in fire district 12 for reports of a residential structure fire. Upon arrival Engine 12 declared a working fire and stated that smoke and flames were venting from a vacant single story home. Engine 12 conducted an initial fire attack while Rescue 12 performed a simultaneous search. An all clear of the structure was declared and due to advanced fire conditions, fire crews switched to defensive fire operations. The fire was extinguished by the use of exterior hand lines as well as Ladder 5 using its master stream. The cause of the fire is under investigation, there were no injuries reported by civilians or firefighters.
- 12/29 Residential Fire: At approximately 10:09 am, AFR units were dispatched to a structure fire on the 700 block of Rim Dr SW in fire district 7. In a matter of a few minutes, Engine 7 was on scene to find a condemned mobile home that has had a history of previous fires. The strategy was to go defensive to protect exposures. The fire was under control in approximately 35 minutes with the help of 11 AFR units, 34 personnel along with a mutual BCFD response. No injuries were reported.
- 12/29 <u>Apartment Fire</u>: At approximately 2:15pm AFR units were dispatched to a possible structure fire at 8000 Montgomery in fire district 15 at the La Entrada Apartments. Fire crews arrived on scene and found evacuation in progress and light smoke showing on the third floor hallway. Crews were able to search and find that the fire was in a heater located in one of the apartments on the 3rd floor. Fire crews were able to put the fire out immediately containing the damage to the heater closet. No injuries were reported and the fire cause was determined to be accidental and unintentional.
- 12/29 <u>Apartment Fire</u>: At approximately 9:30pm, AFR units responded to reports of an apartment fire at 3400 Comanche NE in fire district 19. Rescue 19 arrived and declared a working fire on the second floor. Rescue 19 conducted a primary search. As following units arrived, a coordinated effort to search and extinguish the fire was put into place in the offensive strategy. The fire was under control in under 10 minutes. No injuries were reported.
- 12/29 Residential Fire: At approximately 9:30pm, AFR units were dispatched to a structure fire on the 900 block of Alta Monte AV NW in fire district 6. Within minutes, Engine 10 was first on scene to a single story residence and noticed heavy smoke and flame emanating from the garage. Command opted to go defensive to protect any adjacent exposures. There were no injuries reported to civilians or our hardworking firefighters. The American Red Cross was called to render aid for the affected family.



- 1. AFR members from the Fire Marshal's Office, ADAPT and Plans Checking divisions personally chipped in to purchase presents for 12 children at the APS School on Wheels Magnet school. - 3. The Twinkle Light Parade was back and bigger than ever this year. AFR was happy to participate and used a spare ladder truck that was decorated by the Logistics division with the help of our new Fire Service Aids.
- 4. Station 5-A Shift donated Christmas gifts to UNMH Children's Hospital. The close relationship between firefighters and Children's Miracle Network at UNM Children's Hospital is one that is greatly cherished.









- 1. The AFR 97th Cadet Class recently graduated 34 firefighters after completing the rigorous 18 week fire academy. Thank you to the Training Academy staff in their relentless pursuit of perfection in training these now capable firefighters for their career in public safety.
- 2. Congratulations to AFR Lieutenant Mike Sedillo on receiving the Firefighter of the Year award and to Captain Alejandro Marrufo for receiving the Leadership award at the 2021 IAFF Local 244 Christmas party.
- 3. Two AFR Fire Service Aids help load hose after a storage shed fire in the NE Heights. FSA's have already been selected for the 98th Cadet Class and were offered to start their career early by helping fill support roles within AFR until February and are assigned to the Logistics division.
- 4. AFR Station 17 took delivery of new Squad 1, a 2021 Ferrara Inferno HazMat heavy rescue powered by a Cummins X12 engine. This truck was purchased with 2020 capital outlay funds with help from Lt. Miguel Tittmann and Cpt. Albert Ortega and their work on the CABQ legislative team as well as the IAFF Local 244 and our representatives and legislators who supported this project.

Albuquerque Fire Rescue would like to congratulate **Deputy Chief Sean Elks** on his retirement after proudly serving the department for 21 years. A Marine Corps veteran of 4 years, Chief Elks served in the Echo Co. 2nd Battalion 7th Marine Regimen 1st Marine Corps Division from 1995-1999, out of Camp Pendleton Ca. Chief Elks joined the department in 2000, was a graduating member of the 61st Cadet Class and comes from a tradition of firefighters as both his dad, Captain Jeff Elks and currently serving Captain Ray Elks both have served in the department. Along with earning an associate degree of Applied Science for CNM, Chief Elks also holds a Bachelors Degree in Fire and Emergency Management from Eastern NM. Early in his career Sean was assigned as a rookie firefighter to station 1 and station 4. In 2006 he was promoted to the rank of Driver and was assigned to drive at Engine 2 for 3 years. In 2009 Sean was promoted to the rank of Lieutenant and was assigned to Engine 13. In 2012 Sean was promoted to the rank of Captain and was assigned to Engine 9 for one year, and then served at Ladder 5. In 2016 Sean was promoted to the rank of Battalion Chief and was assigned to Bat-2 C shift. In February of 2018 Chief Elks was selected to serve as the Deputy Chief of Operations. In his position as Deputy Chief Elks oversees the operations of the department and is responsible for the direction and coordination of personnel and resources which includes the Field Operations Center and Special Operations Division. Chief Elks has the unique and proud distinction of scoring first on every one of his promotional exams and has been instrumental in the implementation of the Professional Development Program. Chief Elks has been vital in the growth of our department and his contributions are immeasurable. His integrity as a person and firefighter are truly admirable and he will be missed by all that had the honor and privilege to serve with him. EMERGENCY SERVICES

RECORDS MANAGEMENT

- Welcomed a new member, Lt. Zach Webb, to the RMS team.
- Monthly Training: Battalion Chiefs Best Practices and Tips for Report Compliance.
- Updating the City's website making it more user friendly
- Assisting with providing data to the Response Resiliency Committee to help identify areas for opportunity to better match resources to needs.
- Began providing STEMI feedback and patient outcome information to providers.

PHARMACY

- PPE steady, Glove pricing and allocations are having us acquire whatever type of medical grade gloves that are available.
- N95 stock is great.
- Provided N95 masks to our Safety Officer for annual testing.
- Epi 1:10 still on backorder and we are asking crews to mix their own.
- New Mexico Board of Pharmacy annual CL license renewal paperwork and payment taken to the office and competed.
- Ordered year end reverse distribution kit for expired controlled substances disposal.

HEART

- In the month of December, HEART provided 50 rides with its "Rides with HEART" ride share service.
- The HEART Home Modification Program provided 32 home installation services.
 These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 19 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with "Leave Behind Narcan Kits" to provide to community members in need. For the month of November and October, more than 20 kits were given out by our EMS crews.
- To date, the HEART BEATS stroke discharge program has received over 141 referrals for service. HEART is currently working with 32 patients in the program.

SPECIAL OPERATIONS

FIELD OPERATIONS CENTER

 The AFR Field Operations Center continues to work tirelessly to staff response apparatus despite staffing challenges during the pandemic among other variables. The holidays present a unique challenge that the FOC staff met head-on, managing expected and unexpected changes in staffing levels in filling vacancies as they became available and keeping all the district response units in service.

HAZMAT

- The Hazardous Materials program remained busy in the month of December with the routine but very necessary calibration of gas monitor for front line response apparatus throughout the city. This included the 6-gas monitors found on HazMat Squads 1 and 3.
- In addition to the calibration of monitors, Lieutenant Mark Jaquez, the
 Hazardous Materials Program Coordinator, conducted a class for the cadets
 of Class 97 on HazMat operations to fulfill the National Fire Protection Agency
 requirement for awareness and response within a professional fire department.

WILDLAND

- For the month of December, the WLD Division completed the new Type 4
 build specification. The apparatus specification is currently in pre-build at the
 manufacturer. A big thank you to Lt. Eric De La Torre and Max Mayer for all your
 hard work on this build!
- The division is currently working on the repair of our weather stations. An outside contractor has been working diligently, so that we have the stations back online before the critical fire season.
- AFR is continuing to respond to wildland fires even during the winter months. This solidifies that our fire season, here in New Mexico, is truly year-round.

HEAVY TECHNICAL RESCUE

- Crews across the city have been busy with vehicle extrications. Recent accidents are presenting with more patients, and more entrapments. As most are able to be solved within minutes after arrival and with the standard extrication tools our units carry. However, many are proving difficult due to modern materials and construction that are difficult for our old vehicle extrication setups to conquer. We are also seeing extrications involving larger vehicles such as semis. Stay diligent, call for E-Tools when needed, and additional resources early which may include heavy tow services. Keep up the efficient effective and safe work!
- AFR Crews and HTR task force supported 11's in a structural collapse incident
 with one confirmed patient under the collapsed portion of the building. Rapid
 access by crews, stabilization, and removal of the structure allowed crews to
 extract the patient in under 25 minutes. The teamwork and training showed on
 this event to give this entrapped person every chance we could.
