
AFR UNITS ABOVE 110% CFAI THRESHOLD

These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

- 12/1 Residential Fire: AFR units responded to 520 Bellamah Ave. NW in fire district 4 for reports of a residential fire. Battalion 1 Chief arrived and reported a working fire in a small single family dwelling. 10 AFR units responded. The structure was empty at the time of the fire. AFR crews contained the fire to the structure of origin. No civilians or firefighters injuries were reported. City Code Enforcement was requested to secure the structure
- 12/6 Residential Fire: AFR was dispatched to 7543 Prairie Rd NE in fire district 15 for reports of a carbon monoxide detector alarm at a two-story apartment complex. Fire crews from Fire Station 15 arrived on scene and reported light smoke coming from the front door of the residence and called for additional resources to assist with a small fire caused by an accidental electrical fire. Firefighters were able to quickly get the fire under control with the use of an 1 ¾" hose line. No injuries were reported as the homeowners were able to safely evacuate the residence.
- 12/14 Residential Fire: AFR responded to reports of a structure fire at 1719 Wyoming blvd NE in fire district 9. A total of 9 Albuquerque Fire Rescue units responded. Upon arrival, thick black smoke was showing from the structure. Rescue 9 arrived on scene first and assumed command. Engine 9 attacked the fire and made entry. Ten occupants were on scene, all out of structure prior to AFR arrival. No civilian or firefighter injuries were reported. Red Cross sheltered the occupants. The Fire Investigation division was requested to conduct an investigation of the fire.
- 12/19 <u>High-Life Occupancy Fire</u>: AFR crews were dispatched to 2321 International Ave SE in fire district 2 for reports of a residential structure fire at the Extended Stay America. Engine 2 arrived on scene and declared a working fire with smoke showing from the third floor. Fire crews were able to make access into room 305 and get the fire extinguished quickly. Several other rooms were evacuated as firefighters checked for fire extension. An all clear was declared, signifying that the occupants of the room had safely evacuated. A total of 13 fire apparatus were on scene to assist with fire operations.
- 12/26 Residential Fire: AFR units responded to reports of a possible residential structure fire at 2818 Alvarado Dr NE in fire district 13. Squad 1 was the first unit on scene and reported heavy smoke coming from the structure. The AFR pumper on scene performed a quick attack on the fire and had it under control within 30 minutes. The fire was contained to one room only. There were no injuries to occupants or firefighters.
- 12/28 Residential Fire: AFR crews responded to a single story residential home at 405 Wellesley PI NE in fire district 3. Engine 3 arrived and reported a fire in the garage. AFR crews quickly worked to extinguish the fire and kept it from spreading to other neighboring homes. There were no reports of injuries to the residents or firefighters.
- 12/29 Residential Fire: AFR crews and Bernalillo County Fire Department (BCFD) crews responded to 1105 Salamanca NW in BCFD district 30. Crews arrived to find a single story home with fire and smoke showing. A working fire was discovered in a laundry room that also affected the garage and the roof. The home owner was displaced but is with family. There were no reports of injuries.



- 1. Lieutenant Freddy Sanchez and Firefighter Morgan Mahboub recently graduated from the Law Enforcement Academy. They completed a 19-week academy and are now certified law enforcement officers. They will become a vital resource to the department and Fire Investigations Division.
- 2. AFR recently graduated 37 cadets to the rank of Firefighter 2nd Class of the 99th Cadet Class. The Academy began on August 1st, 2022 and was completed on December 8th, 2022. 16 of those graduates will start the EMT-Basic course at the Training Academy.
- 3. December is always a busy month of spreading holiday cheer and our crews were honored to participate in several events this month! (a) AFR teamed up with Toys for Tots in collecting toys for families in our community during the holiday season. (b) AFR Fire Investigators and firefighters from stations 5,8, and 12 had the privilege of donating Christmas presents to over 50 kids at Singing Arrow Community Center. (c) AFR's Training Division were able to donate toys to the children of the Manzano Mesa Child Development Center. (d) AFR Station 5 A-Shift worked to collect toys to be donated to the UNM Children's Hospital. (e) AFR Fire Marshal's Office along with "Sparky" and Engine 17 had the opportunity to provide gifts for the Western Trail Early Headstart.

ADAPT

 stages. ADAPT continuously monitors the properties that are in the program to
 track their compliance with the Nuisance Abatement Agreement.

The properties are labeled on the First Due application with a white "X" on a red background. In the field these properties are marked with a red spray painted "X" and the letters "AFR" under it.

PLANS CHECKING

- PC went out and did a final inspection on a new 25,000 sq/ft sound stage that will be named Hanover Studios. This will be a new location for movies and television shows to film and keep the film industry in Albuquerque growing.
- Plans Checking was asked by the State Fire Marshal to come help with an inspection at UNM Center of The Arts (Pope Joy Hall). A new state of the art Bi-Directional Amplifier (BDA), a signal booster to enhance in-building radio frequency, and an Emergency, Responder, Communications, Enhancement System (ERCES) were installed and since AFR's units will be responding to UNM, AFR PC was asked to assist with the inspection to make sure this system will work with our radios and communication systems throughout the building. A new touchscreen annunciator was also installed that will make it easier and faster for first responders to locate the emergency.

HEART

- HEART provided 33 rides with its "Rides with HEART" rideshare service.
- The HEART Home Modification Program provided 41 home modification installation services. These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 48 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with "Leave Behind Narcan Kits" to provide to community members in need.
- Fentanyl Strips to Frontline units has been completed and supply will be ongoing.
- Buprenorphine Program- Inserting information for suboxone treatment in the LBN kits. Individuals will receive access to an app with counseling, cognitive behavioral therapy and contingency mgmt. Plus, monetary rewards for compliance. Will be an ongoing push.
- To date, the HEART BEATS stroke discharge program has received over 297 referrals for service. HEART is currently working with 64 patients in the program.
- Lt. Gray and Wrigley responded to middle school in Las Vegas, NW for canine therapy for the one-year anniversary of a tragic incident.
- Lt. Sargent has established a partnership with the New Mexico Cancer Center for canine therapy with biweekly visits from Wrigley for patients and staff.

RECORDS MANAGEMENT

- Continued with implementation of ImageTrend Continuum, a software product that will allow our department to actively monitor our data through dashboards that provide instant visual insights on clinical and operational metrics through charts, tabular reports and maps.
- Collaborating with Clayton County Fire & Emergency Services (Georgia) to create usable dashboards to assist with CPSE accreditation.
- Conducted an in-depth analysis of AFR's emergency medical transport financial records, in order to provide accurate forecasting for FY24.
- Developing documentation tools to assist in evaluating AFR's encampment fire responses. With an effort to formulate solutions in response to the increase in outside/encampment fires.
- Assisting with the assessment and prioritization of AFR's Capital Outlay projects.
- Provided support fill in for in for frontline units.

EMS TRAINING

- This month we kicked off our six week EMT-B class. This course consists of 16 Firefighters out of the 99th Cadet class, and 4 APD officers. They should all be ready to start in the field late January or early February.
- The AFR studio shot and edited multiple training videos with Dr. Pruett and EMS Training Division Staff.
- CNM's Fast Track paramedic program runs for twelve months starting in December. This month AFR had one member graduate the program, and three more start it. Between CNM's and UNM's programs, AFR currently has a total of 15 Firefighters attending paramedic school.
- Coordinated, assigned, and tracked monthly department training on Vector Solutions.
- Completed audits on all AFR members' 2022 training, in preparation of the upcoming EMS license renewal process.
- Certified 16 new ACS employees in CPR and Lifesaver training.

SPECIAL OPERATIONS

HAZMAT

 AFR Hazmat Coordinator attended a pre-planning exercise with San Juan water treatment plant facility. Part of the pre-planning exercise was familiarization of the plant itself, what chemicals they have, and where at the facility the chemical is used and stored. San Juan wants to put an exercise with AFR and Bernalillo fire on a chemical spill at their location to see how well we can work together and the needed improvements they may need in case of an emergency.

WILDLAND

- The Wildland Division has been working in conjunction with the Fleet Division on the specification for the new Wildland 4x4 Rescue. The specification should be completed by the start of the New Year and construction should commence shortly after.
- The division is currently working on the training schedule for the New Year and we are planning on hosting two S-212 Chainsaw Operation courses which will begin in late March or early April.
- AFR is continuing to respond to wildland fires even during the winter months. This solidifies that our fire season, here in New Mexico, is truly year-round.




