These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

- 2/1 Commercial Fire: At approximately 2:50 pm AFR was dispatched to 7503 Central Ave NE for reports of a residential structure fire in fire district 5. Ladder 5 arrived on scene at the Loma Verde Hotel and reported smoke coming from one of the rooms on the ground floor. Fire crews made entry into the room and ensured that all occupants were out and safe. Engine 11 along with Ladder 5 and Rescue 5 completed a primary search and fire control. The fire was extinguished quickly and fire crews were able to prevent the fire from extending into the nearby hotel rooms. The cause of the fire was from a burnt mattress, no injuries were reported.
- 2/3 Commercial Fire: At approximately 3:45 pm AFR was dispatched to 902 Palo Duro Ave NW in fire district 6 for reports of a residential structure fire. Engine 6 arrived on scene and reported a working structure fire in a single story residential structure with smoke and flames showing from the front of home. Engine 6 began fire operations by stretching a hose line to the front door for fire control as Rescue 6 entered the structure to complete a primary search. An all clear of the structure was declared. The fire was extinguished within 11 of the first arriving units as Engine 4 assisted with ventilation needs and Ladder 1 completed a roof report. A total of 10 AFR units were on scene to assist with fire operations. No injuries were reported.
- 2/4 Apartment Fire: At approximately 3:05 pm, 12 AFR units were dispatched to an apartment building at 333 Pennsylvania NE in fire district 5 for reports of a 69D5 structure fire. Within minutes of the dispatch, Rescue 5 was the first arriving unit and reported a working fire in a second story apartment. All tenants had successfully evacuated the structure with one patient (40yo female) suffering burn injuries and was transported to UNMH by Rescue 11. A second pediatric (3yo) patient suffered minor burns and was evaluated by AFR units but remained with family. On scene, units were able to quickly extinguish the fire and stabilize the event. One apartment suffered significant fire damage, two apartments suffered water damage. The cause of the fire is under investigation. There were no reported injuries.
- 2/7 Commercial Fire: At approximately 4:15 am, AFR units were dispatched to reports of a gas leak at a veterinarian clinic on the 2200 block of San Pedro Dr. NE in fire district 13. Upon arrival, Engine 13 had discovered a working structure fire in a two story commercial occupancy. Thanks to our hardworking personnel, the fire was declared under control at 5:06am.
- 2/9 Residential Fire: At approximately 6:45 pm, AFR units were dispatched to reports of a residential structure fire at 344 Tennessee St NE in fire district 5. Within 2 minutes, engine 5 arrived on a scene and declared a working fire with flames and smoke showing from the front of the structure. Station 5 coordinated fire attack along with primary search to extinguish the fire and search for occupants. The fire was under control within minutes, and a primary search established the building was clear. Units remained on scene to complete extinguishment and check for hot spots. The cause of the fire is currently under investigation by on scene units. No occupants or firefighters were reported injured.
- 2/10 Residential Fire: At approximately 9:36 am AFR was dispatched to 1027 Maxine St NE in fire district 12 for a residential structure fire. Engine 8 arrived on scene and declared a working structure fire in a single story residential structure with smoke showing from the front of the house. As Engine 8 initiated fire attack by stretching a hose line to the front door, Rescue 8 preformed a primary search ensuring that all occupants were out of the structure and safe. The fire originated in the kitchen and was extinguished quickly. The homeowners will unfortunately be displaced as a result of the fire. No other structure were affected, no injuries were reported to civilians or firefighters. A total of 10 fire apparatus were on scene to assist with fire operations.
- 2/11 <u>Apartment Fire</u>: At approximately 10:19 am AFR units were dispatched to reports of an apartment structure fire at 710 Dan Ave SE in fire district 2. Within 2 minutes, Engine 2 arrived on scene and declared a working fire with smoke coming from the front door of one of the apartment units. Engine 2 coordinated an aggressive offensive fire attack along with primary search to extinguish the fire and search for occupants. The fire was under control within minutes, and a primary search established the apartment was clear. The fire was caused from the kitchen stove being left on and unattended. Units remained on scene to complete extinguishment and check for hot spots. The resident of the apartment was displaced, but other residents were able to go back in their units. No occupants or firefighters were reported injured.

- 2/11 Residential Fire: At approximately 1:10 pm AFR units arrived on scene of an outside fire with flames directly impinging on a mobile home at 11826 Cochiti Rd SE in fire district 12. Rescue 12 took command and declared an offensive fire attack strategy, assigning Engine 5 to fight the fire. Engine 5 extinguished the outside fire and made entry with a 1 3/4" attack line to extinguish the fire that had penetrated the west wall of the mobile home. Rescue 5 completed a primary search and reported that nobody was inside the structure. A total of 25 firefighters responded to the event and there were no injuries to firefighters or civilians. PNM also responded to shut off the electricity due to an arcing electric meter on the mobile home.
- 2/13 Residential Fire: At approximately 7:11 am AFR units were dispatched to reports of smoke and fire coming from a town home located at 5540 Overlook NE in fire district 16. Within minutes, AFR units arrived on scene and declared a working fire coming from the home. AFR coordinated an aggressive offensive fire attack along with primary search to extinguish the fire and search for occupants. The fire was under control within minutes, and a primary search established that the town home had a family dog and cat that were both rescued from the fire. Units remained on scene to complete extinguishment and check for hot spots. The cause of the fire is currently under investigation. No occupants or firefighters were reported injured.
- 2/14 Residential Fire: At approximately 11:57am AFR was dispatched to 513 Veranda Rd NW in fire district 6 for a single story residential structure fire. Rescue 6 arrived on scene and reported a working structure fire with heavy smoke showing from both the front and the rear of the home. As additional units began to arrive on scene, Rescue 6 and Engine 4 entered the front of the home to conduct search and fire control. Fire crews were met with dangerous fire conditions with limited visibility and extreme heat as they began their operations. The house proved to be extremely difficult for firefighters to navigate due to hoarder like conditions. Firefighters were able to locate the origin of the fire in a back bedroom and successfully extinguish the fire keeping it from spreading to nearby houses. Within minutes of entering the home AFR found one adult female laying on the floor unresponsive and removed her from the home as additional fire crews attempted to locate the fire. AFR Paramedics began resuscitation efforts in an attempt to revive the homeowner. The patient was transported to UNMH by AFR Rescue 4 where she succumbed to her injuries. The cause of the fire is under investigation. No other injuries were reported to civilians or firefighters.
- 2/14 Residential Fire: AFR was dispatched to reports of smoke at 2534 Landsman drive NE in fire district 8. Engine 8 investigated the area and found smoke coming from the home. A first alarm was requested and a working fire was declared. Engine 8 quickly located the fire and searched for occupants. The fire was extinguished within minutes. No fire fighters or occupants were injured in the fire. The cause of fire was determined to be a malfunctioning appliance in the garage.
- 2/15 Residential Fire: At approximately 12:50 pm AFR was dispatched to 1440 Vassar Dr NE in fire district 3 for a reports of a fire in a two story apartment complex. The first arriving unit reported light smoke showing from a second story window. Engine 3 and Rescue 3 initiated fire attack and simultaneous search of the affect apartment and were able to quickly locate and extinguish the fire. All occupants of the building were evacuated with the assistance of Squad 2. The affected apartment sustained significant fire and water damage and the apartment owner will be displaced. There were no injuries to firefighters or civilians.
- 2/17 <u>Apartment Fire</u>: At approximately 9:32 am AFR was dispatched to 12050 Candelaria Rd NE in fire district 8 for reports of a fire in a 2 story apartment complex. Engine and Rescue 16 arrived and reported a working fire on the 2nd floor with an urgent rescue profile. Engine 16 reported heavy smoke and flames coming from multiple windows with the apartment tenant on the balcony surrounded by heavy smoke. As additional units arrived on scene to assist with fire operations, Engine 16 was able to stretch a hose line to the 2nd floor as Rescue 16 entered the apartment to perform a primary search. A 24 foot extension ladder was placed at the base of the balcony as Engine 16 personnel were able to successfully climb up and rescue the apartment occupant escorting her to a waiting Albuquerque Ambulance unit for treatment and transport to a local hospital. The patient is listed as stable and expected to make a full recovery. As fire crews stretched multiple hand lines to the fire apartment for fire control, heavy fire began to vent through the roof creating extremely hazardous conditions to interior firefighters. An all clear was declared to ensure all occupants of the apartment building as firefighters exited the apartment and began defensive operations, flowing water from two ladder trucks that were on scene. Fire control was announced as the fire was extinguished and firefighters preformed salvage and overhaul ensuring that the fire had not spread to the rest of the building. Four apartments were affected due to water and smoke damage and those occupants will be displaced. No other injuries were reported. (Pictured on bottom page 9)
- 2/17 Residential Fire: AFR units were dispatched to a report of a single story residential structure fire at 9124 Comanche NE in fire district 9. E16 arrived on scene and reported smoke showing. Crews made entry with a 1 3/4" line through the front door. E16 found the seat of the fire on the stove in the kitchen and pulled ceiling above the stove to extinguish fire that had penetrated the attic space. A total 25 firefighters responded to the scene and no injuries were reported.

- 2/18 <u>Apartment Fire</u>: At approximately 12:37 pm AFR was dispatched to a structure fire at 1205 Madeira Dr. SE in fire district 11. Rescue and Engine 11 arrived to find a working fire involving two apartments, one on the first and one on the second level. Engine 11 extinguished the fire after extensive fire efforts. The first story apartment was a total loss with extensive damage to the second story. There was no injuries reported and the incident was ruled accidental after investigation.
- 2/19 <u>Apartment Fire</u>: At approximately 2:07am AFR was dispatched to a structure fire at 436 Louisiana SE in fire district 5. Engine 5 was first on scene of a fully involved apartment on the second level of the apartment complex. Engine 5 quickly extinguished the fire in the apartment on the second level. The apartment below received extensive water damage from firefighting efforts. There was no injuries to firefighters or civilians in this incident.
- 2/19 Residential Fire: At approximately 9:07am AFR units were dispatched to a structure fire at 1028 Alvarado Dr SE in fire district 11. Rescue 11 was first on scene. There was a small room and contents fire in one of the apartments in a single story multi family residential building. Engine 11 quickly extinguished the fire with minimal damage. There was no injuries reported and the incident was ruled accidental after the investigation was complete.
- 2/20 Residential Fire: At approximately 7:04 pm AFR units were dispatched to 6843 Elona NE for a structure fire in fire district 20. Engine 20 was first on scene of a single story single family residence. Engine 20 was able to extinguish the small room and contents fire that originated in the laundry room. There was damage to the internal and external wall due to flames and firefighting efforts. No injuries were reported and the fire was ruled accidental after an investigation was conducted.
- 2/22 Commercial Fire: At approximately7:55 am AFR responded to 141 Wyoming NE in fire district 5 for reports of a commercial structure fire. Rescue 5 arrived on scene and reported a working structure fire with smoke showing from the rear of the large, unoccupied commercial building. Engine 5 and Rescue 5 successfully made entry into the building to perform simultaneous fire control and search. Engine 5 was able to quickly get the fire under control and an all clear by Rescue 5 confirmed that all occupants were out of the building. PNM and NM Gas confirmed that all utilities had been shut off to the property. A total of 30 firefighters assisted with fire operations and were successful in extinguishing the fire. No injuries were reported.



- 1. AFR and IAFF Local 244 conducted a promotional and recognition ceremony. Fire Chief Gene Gallegos along with Mayor Tim Keller, CAO Sarita Nair and District 4 City Councilor Brook Bassan acknowledged the accomplishments of our members that been promoted over the past year as well as members that have gone above the call of duty to make a significant impact in our community.
- 2. AFR took first place again in the First Responders Relay Race during the Don Kirby Elite Invitational and the Albuquerque Convention Center competing against teams from APD,BCFD and Abq. Aquatics.
- 3. AFR Ladder 20 and Engine 15 had the privilege of receiving several boxes of stuffed animals from Albuquerque Academy student Abigail Levenson who created a toy drive as part of a middle school project to teach students how they can give back to the community.
- 4. The AFR Training Academy started the 98th Cadet Class and open enrollment for the 99th will begin April 15, 2022.
- 5. AAS and AFR Station 13 crew were recognized for their help in a successful field birth after a mother had started to deliver her baby while en route to the hospital in an Uber vehicle. These members were awarded a "Stork Pin" from Dr. Kim Pruett.













Albuquerque Fire Rescue would like to congratulate Paramedic Lieutenant Greg Gonzales on his retirement from the department. Greg joined AFR in 1999 as a member of the 60th Cadet Class. As a rookie Firefighter Greg was assigned at stations 4, 3, and 19. In 2005 Greg graduated from Paramedic School and was assigned to Rescue 16 then over to Rescue 7. He was then promoted to Paramedic Lieutenant and spent majority of his time assigned at Station 14. He became involved with the AFR mental health committee whose goal was to secure funding for a permanent mental health program. Greg has been recognized by his peers for several of his selfless efforts while serving the community including a Unit Citation Earned for the "Northland Fire" while at Station 19. Greg has been honored by MADD when he was nominated by family who lost child in drunk driving accident for actions taken in the field to save their infant's life who eventually succumbed to his injuries but was able to donate his organs. Greg volunteered hours with Behind the Badge for a study that offered free alternative modalities to AFR and other first responders in our community who had sustained trauma on the job. Greg has spent his career serving and treating all members of the Albuquerque community with dignity. compassion and humanity as his highest priority. Always trying to lead by example, he has taken great pride in his duty as a firefighter and has absolutely loved his work. He found his passion at AFR as a paramedic and has the great privilege of serving his community for almost 23 years! Congratulations Paramedic Lieutenant Greg Gonzales on your retirement, thank you for your commitment to the department and the community. Good luck with your future endeavors.

FIRE MARSHAL'S OFFICE

INSPECTIONS DIVISION

- We are about ¾ through the 145 annual inspections of schools. We have begun working with the State Fire Marshal to expand our inspections in the schools to include all improvements and any change to the school's life safety systems.
- FMO is continuing the adoption process of the 2021 International Fire Code and the construction of the City Ordinance. We have made some good strides and continue to work with City Legal to ensure everything is accurate and just. To expedite the process, we are looking at possibly meeting more times a month until it is complete.
- Working with the expansion of Netflix, FMO sent inspectors out to the facility to look over the new rotating sound stage that is being built and look at approving a welding permit. This will be one of the largest LED sound stages in the country if not the world. With the filming of a new large-scale production, Netflix is erecting a 9,000+ sq ft tent to handle all the logistical needs required to accommodate a production of this size.

- ADAPT has 117 properties that have been formally brought into the program, 59
 have been cleared from the program and 58 are still in the program at different
 stages. ADAPT continuously monitors the properties that are in the program to
 track their compliance with the Nuisance Abatement Agreement.
- There are 88 properties on the Unsafe Buildings list. Ten new properties were added to the list this month. - Closing of the hiring process for the 99th Cadet Class set to begin August 2022


EMERGENCY SERVICES

PHARMACY

- PPE is fairly stable with the exception of EMS gloves. We have found two
 options moving forward that will stabilize this issue, hope to have this resolved
 in the next week or so.
- CyanoKits switched manufactures, we are working on getting the contract set up for purchasing.
- The controlled substances side of the Vector Solutions system is still being worked on. One station is testing, should have a larger part of the city testing soon.
- Unknown arrival date for the LP15 order that was supposed to arrive in February.
- Multiple back ordered items (EMS supplies and EMS medications). For now we have a replacement product for every back order.

RECORDS MANAGEMENT

- February Monthly Training: Documenting CIWA Scores.
- Assisting with the implementation plan for the new Permeir1 CAD and integration with ImageTrend Elite.
- Working with Centers for Medicare & Medicaid Services to ensure AFR is compliant with the Medicare Ground Ambulance Data Collection program.
- Provided data for the Staffing for Adequate Fire and Emergency Response (SAFER) grant.
- Provided data KRQE revolving around EMS response by day of the week and hour of the day for the last 3 years.
- Working with the Office of Equity and Inclusion to determine what translator resources were available for AFR providers.
- Continued to track and trend data revolving around hospital drop time averages, means and 90% to assess the impact on the EMS System.
- Continued to assist with tracking and analyzing data revolving around the Cerebral Oximetry research study AFR is participating in.
- Provided data revolving around Patient's eligibility to be transported to the CARE Campus. This could potentially provide more appropriate destinations for a specific patient population as well as potentially alleviate some of the burden to area hospitals.
- Providing data to Field Personnel revolving around AFR unit time on task and reports written to assist with contract negotiations.
- Continuing to provide feedback to providers regarding outcomes for STEMI Patients. While tracking bench mark times for the entire EMS System.
- · Assisted with the Lieutenant Certification course.
- Continuing to trend data revolving around AFR Transports my unit and EMD monthly and YTD.
- Continuing to trend data revolving around Naloxone Administration, Overdoses, and EMS death response.



QUALITY ASSURANCE 78

- School bus rollover on 2/22 with 27 people involved. AFR, BCFD, and AAS did
 an exemplary job of coordinating a joint response and running a unified scene to
 provide care to multiple wounded. This is an excellent example of the services
 the community receives from its investment in Fire & EMS services.
- Captain Rob Laprise has created a training to educate field personnel on how to better work with our APD colleagues as we navigate a significant increase in Court Ordered Evaluations (C of E's).
- The EMS Division has procured hundreds of COVID tests for its members. The EMS division continues to lead the way in workplace and public safety through the many extra-departmental relationships with community shareholders throughout the State.
- The EMS Division has addressed over 14 internal and external Quality
 Assurance/Quality Improvement issues in support of AFR personnel's continued
 education and improvement. The EMS Division is committed to supporting our
 membership while assuring the community we serve receives the best possible
 care.
- The EMS Division will begin the testing process for prospective applicants who
 wish to be part of the CQI Cadre. This cadre of providers is responsible for
 assuring, improving, directing, and implementing Emergency Medical Services
 (EMS) that we provide to our community.
- The newest permanent member of the assigned 78 group is Captain Breeswine. Captain Breeswine will be the D-shift EMS Captain. He previously lead HEART, which has been instrumental in implementing innovative new services to our community.

HEART

- In the month of February, HEART provided 57 rides with its "Rides with HEART" ride share service.
- The HEART Home Modification Program provided 35 home installation services.
 These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 33 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with "Leave Behind Narcan Kits" to provide to community members in need. For the month of February 2022 approximately 54 kits were given out by our EMS crews.
- To date, the HEART BEATS stroke discharge program has received over 164 referrals for service. HEART is currently working with 42 patients in the program. Two more staff members are currently undergoing training to expand the HEART BEATS program.
- Be Brave Fall Prevention Classes taught at North Domingo Baca Community Center and the other at Montebello Senior Living
- Provided Support Fill for frontline units

SPECIAL OPERATIONS

WILDLAND

- For the month of February, the Wildland Division hosted the Work Capacity Test (WCT) aka "The Pack Test" at the arduous level for all uniformed personnel. The arduous level WCT consists of walking 3 miles in the allotted maximum time of 45 minutes 45 seconds, while wearing a 45-pound weighted vest. This test is designed to simulate the endurance levels required to fight long duration wildfires.
- The RT-130 Refresher has been assigned to all personnel in Target Solutions and has a due date of April 1, 2022.
- The combination of the above aforementioned courses, along with the Wildland training received in the Fire Academy, allows all uniformed personnel to be "Red Carded". This means that all our Firefighters are qualified to fight Wildfires.



HEAVY TECHNICAL RESCUE

 AFR Heavy Heavy Technical recue completed its long-awaited Structural collapse rescue course. Students spent 60 hours learning about construction and rescue techniques to gain access to any collapsed structure. 
