





MONTHLY INFORMATIONAL REPORT

SIGNIFICANT EVENT ALERTS

These events are activated by the AFR Dispatch Center as a "Significant Event" and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

7/5 - MVA: At approximately 2:30 in the morning, AFR Engine14, Rescue 14, and Unit 78 were dispatched to a 29D2 at the intersection of 98th and San Ygnacio in fire district 14. Upon arrival, Engine and Rescue 14 found a 3 car MVA that consisted of 1 red, 2 yellow, 1 green triaged patients. The red and yellow were transported to UNMH. The other two were transported to Presbyterian Hospital.

7/5 - Shed/Vehicle Fire: AFR crews were dispatched to the 1800 block of Griegos Rd NW in fire district 10 for reports of a residential shed fire. Engine 10, Engine 6, Battalion 1, and Squad 1 arrived to find a working shed fire that spread to a vehicle. The fire was quickly extinguished before further damage could occur. No structures were compromised and no injury to civilians or Firefighters have been reported.

7/6 - Residential Fire: AFR crews responded to reports of a structure fire on the 400 block of Martinez Ave NE in fire district 4. Units arrived to find a working fire involving at least 1 house, 2 sheds, and 2 cars. Each a total loss. The cause is still under investigation and there were no injuries to civilians or firefighters in the event.

7/8 - Residential Fire: AFR units responded to reports of a possible structure fire on the 800 block of Hidalgo Circle NW in fire district 7. First incoming units searched the house and encountered light smoke coming from the ceiling in the kitchen. Crews exposed the sheet rock and found a small smoldering fire in the roof and quickly extinguished the fire.

7/16 - Residential Fire: AFR units were dispatched to the 200 block of General Chennault NE for reports of a residential structure fire in fire district 5. AFR crews arrived to find a single story residential structure with heavy smoke. Engine 5 was first on scene and was able to extinguish the fire quickly and contain it to the garage. The cause of the fire was believed to be electrical. The residents self evacuated and had no injuries. AFR crews did Rescue the family dog from the structure.

7/21 - Residential Fire: AFR was dispatched to the 1600 block of La Cabra Ct SE in fire district 12 for reports of a residential structure fire. Initial reports from the neighbor stated that the home was struck by lightning and the roof was on fire. Engine 12 arrived on scene and reported smoke and flames coming from the home and initiated an offensive attack. Engine 12 took command and performed fire suppression while Rescue 8 and Rescue 5 performed a search of the home to ensure all occupants had exited the structure safely. The cause of the fire was confirmed to be a lightning strike and no injuries were reported.

7/21 - Residential Fire: AFR crews were dispatched to a residential structure fire in Corrales near Ellison/NM528 near fire district 21. Upon arrival, AFR reported two structures fully involved, a single story residential structure and a mobile home trailer. Both structures were reported a total loss. No injuries were reported and one resident was displaced.

7/29 - Residential Fire: AFR units responded to multiple calls to a mobile home on fire with a person trapped on the 5400 block of Rim Ct. NW in fire district 7. Units arrived on scene of a working fire with heavy smoke and flames showing from multiple sides of the structure. Units initiated fire attack and search operations. Fire was declared under control at as well as all clear. A secondary search was performed and declared all clear. Units remained on scene for arson to arrive and perform an investigation. No injuries were reported.

7/31 - Swift Water Rescue: AFR received multiple reports of a person caught in the flood channel waters. AFR crews were able to locate a man in the water near Candelaria who was being helped by some civilians that had a rope thrown out to him preventing him from being swept away. Crews were able to rescue the man safely. Once he was rescued the man notified AFR crews that he had a friend with him that was also swept away in the flood waters. Crews spotted the other victim minutes later floating down the arroyo system but unfortunately he was face down in the water and unresponsive for over 20 minutes. AFR command dispatched BCFD to assist with the rescue. Crews were unable to recover the unconscious victim in the water at multiple sites. AFR Command turned over the recovery efforts further north outside of the city to BCFD.

- 1. The 2019 Firehouse National Run Survey included a total of 209 departments across 43 states that highlight statistics such as busiest station and apparatus. AFR comes in as the 25th busiest department, with Engine 5 being the 12th busiest fire truck in the survey.
- AFR, along with Mayor Keller, Abg Parks Director Dave Simon and County Commissioner Pyskoty, took part in a press conference to discuss the July 4th holiday and urged citizens to report the use of illegal fireworks utilizing the CABQ.gov/fireworks website or the "ABQ 311" app.
- Deputy Chief/Fire Marshal Gene Gallegos responded to media following the 4th of July holiday to discuss how AFR responded. AFR responded to 370 calls on Saturday night alone. 35 were brush fires, 11 were structure fire and nearly 300 were EMS calls. The City's Firework Enforcement Units also responded to more than 90 locations handing out 55 cease-and-desist orders.
- 4. AFR qualified Lieutenants take the written portion of the Captain promotional testing process.
- 5. Station 11 crew and members from Family & Community Services held a traditional "Push In" ceremony with the newly acquired Engine 11. The Engine, along with all of the equipment, was purchased by the Hud Community Development Block Grant.
- 6. Station 5 crews perform aerial operations training, even though down time is almost nonexistent at AFR's busiest station, in order to stay proficient at what they do best.

ALBUQUERQUE FIRE RESCUE 4TH OF JULY RESPONSE ANALYSIS

AFR held several press conferences and media interactions to inform the public about the safe use of legal fireworks, reporting illegal fireworks, and the dangers of fires in our open spaces and Bosque. We also sent these messages out to the public through our social media platforms and engaged with various community groups throughout the City. We had several additional resources available to respond to illegal firework activity and the increase in outside fires. 2020 was the first time in the last few years, where we did not have a Bosque fire or significant structure fire on the 4th of July.


Residents of Albuquerque could report illegal fireworks using the ABQ311 APP, the One ABQ APP, and 311. The information from all three sources is collected and loaded into a mapping system that we use to dispatch our resources to address the illegal firework activity. AFR did not send an apparatus to respond to every isolated report of illegal fireworks, as this is not an appropriate use of our resources. However, each report of illegal fireworks we received helped us to identify concentrated areas of illicit fireworks activity, and we would then dispatch units accordingly.

ALBUQUERQUE FIRE RESCUE 4TH OF JULY RESPONSE ANALYSIS

Both APD and AFR teamed up to respond to illegal fireworks on the nights of July 3rd and 4th. Fireworks Enforcement Units (FEUs), made up of one FMO Inspector, and one APD Officer responded from 1800-2400 hours each night. The FEU's primary objectives were public education, inspecting fireworks vendors, and responding to reports of illegal fireworks.

On the evenings of July 3-4,2020, there were 97 FEU responses and 55 cease and desist orders issued. An additional 78 orders were issued throughout the weeks prior.


AFR also staffed additional wildland apparatus on July 3rd and 4th. These Brush Trucks conducted patrols in and around the Bosque, Foothills, and West Mesa areas. AFR will continue patrolling the Open Space areas with two additional wildland apparatus for the next two weeks.

INSPECTIONS DIVISION

- In the days leading up to the 4th of July, our personnel continued entering firework complaints into ArcGIS, and multiple complaints to the same address resulted in a "knock and talk" to personally educate. For the 4th of July weekend, FMO put together six field enforcement units to patrol on July 3 and 12 units to patrol on July 4. They issued Cease and Desist orders, confiscated thousands of dollars' worth of illegal fireworks, and had numerous educational encounters with the public.
- In conjunction with Albuquerque Parks and Recreation, the FMO was able to successfully and safely manage three simultaneous firework displays at separate locations.
- The Fire Marshal's Office would like to congratulate Lieutenant Derrick Ross on his retirement. Lt. Ross is the final member of the 56th cadet class to retire. He served 25 years with AFR, of which the last seven were in the Fire Marshal's Office. Lt. Ross was an asset to this division: his positive attitude and work ethic will be missed.
- Due to COVID-19, the popular Camp Fearless went virtual. Utilizing field units, FMO created two videos; a fire safety scenario and an EMS scenario. Our mascot, Sparky, was even able to attend to give some fire safety tips!

- The Plans Checking Division went through the preliminary review of the 3rd and Lomas Development called Elevate. The building is a 7-story mid-rise building. The building is a mixed-use occupancy, floors one and two are mercantile and business, floors 3-7 are apartments. The construction is projected to start on January 1, 2021.
- Final inspection of Stone Age Climbing Gym's 2nd location, a 28,500sqft facility located @ the SE corner of Alameda and San Pedro was conducted and passed.
- The Plans Checking Division is looking at using an E-plan for all plan submittals. We have been using email for all plan submittals during the Covid-19 pandemic and would like to move to a software that would streamline the process for the applicant.
- We issued 107 new Temporary Outdoor Dining Area Permits in the month of July.

ADAPT


- ADAPT has had 58 properties that have been formally brought into the program, 20 have been cleared from the program, and 38 are still in the program at various stages. ADAPT continuously monitors the properties that are in the program to track their compliance with the Nuisance Abatement Agreement.
- There are 55 properties on the Structurally Compromised list. Six new properties were added to the Structurally Compromised list. Eight properties were demolished by Code Enforcement and removed from the list. The list is in the Target Solutions file center, under the FMO > ADAPT tab.
- ADAPT is received approval from City Administration to implement a new program that focuses on properties that have a high call volume of crime-related activity but no dilapidation. ADAPT is working on training and procedures to implement the new program.
- Inspector Joseph Salazar designed a Crime Prevention Through Environmental Design (CPTED) inspection form in Image Trend that will significantly improve the quality and consistency of CPTED inspections. The program will be tested out this month and should be fully operational sometime in September.
- Lieutenant Eric Gonzales has continued to assist the City of Albuquerque's Emergency Operations Center as one of the liaisons from AFR. He is part of the nursing home task force and is assisting in facility assessments. One property was inspected in July.





- AFR Squad 3 conducted training with the NM DOH and 64th Civil Support Team on our newest 908 monitor. This device was purchased through a SSGHP grant and is used to detect chemicals, warfare agents, drugs, and explosives.
- AFR Squad 1 conducted radiation training with NM DOH and Los Alamos National Labs on the new FLIR Identifier. Instructors from Los Alamos conducted training on how to use our Ludlum and FLIR Identifier together in an emergency. The Ludlum is used to check for radiation, whereas the FLIR can identify the specific radioactive isotope. This new device will greatly improve AFRs response to radioactive incidents

HTR

- AFR hosted a Rope Rescue Operations course in the wilderness setting for members of AFR, APD, and BCSO. AFR used the opportunity to train members for REM deployments, while APD and BCSO Open Space officers trained for a response to SAR and high angle operations in the Foothills and East Mountains.
- EMS Consortium Fellows joined AFR for an introduction to technical rescue and vehicle extrication. This was a great opportunity to show the medical and rescue hurdles our crews encounter.

WILDLAND

- Over the 4th of July weekend, AFR's Wildland Division staffed four Type-6 Engines that were assigned to conduct Open Space Patrols as well as an initial attack for wildland fires throughout the City. These units responded to 54 brush fires over the course of four days in the Foothills, West Mesa, and the Bosque.

- CQI cadre interest is increasing, which is bolstering quality improvement.

QUALITY ASSURANCE


- The QA officers are piloting a cerebral oximetry device.
