


The time from when a 911 call is received until the information is gathered and the call is dispatched.


#### **TURNOUT TIME**


The time from apparatus en route to arrival at the incident.

### ALBUQUERQUE FIRE RESCUE SIGNIFICANT ALERT EVENTS

These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

- 7/2 Residential Fire: AFR crews responded to the 800 Block of Towner Ave NW in fire district 4 to a working fire with smoke and flames showing. Engine 4 made entry quickly and had the fire under control within minutes. Engine 6 helped with attack and overhaul while Rescue 4 performed a primary search. One occupant and 3 dogs were all able to get out of the house and are safe. No injuries were reported. Unfortunately, the house was a totally loss.
- 7/3 Residential Fire: AFR crews responded to a vacant single family home located at 4300 block of Mesa Grande PI SE in fire district 3 with heavy smoke showing upon arrival. Engine 11 made an aggressive attack with 1 3/4 inch attack line and had the fire under control within 9 minutes of arrival. No injuries were reported.
- 7/8 Residential Fire: AFR responded to a single story residence located on the 12500 block of Rosemont NE in fire district 8. Units arrived to find smoke and flames coming from the garage. Firefighters had the fire extinguished within minutes. Fortunately, the homeowner noticed the fire and quickly grabbed his kids and pets and called 911 immediately. The small fire was contained to the garage so the occupants will not be displaced. There were no injuries reported.
- 7/10 Residential Fire: AFR crews were dispatched to a single story residential home located on the 1000 block of Carol St. NE in fire district 9. Upon arrival crews encountered smoke and flames coming from the home. Firefighters quickly pulled a cross lay to fight the fire. The fire got into the void spaces which made the it a bit trickier to extinguish, but fire crews had the fire under control and extinguished within about 15 AFR crews administer oxygen to two dogs that suffered smoke minutes. The homeowner was home at the time and initiated the 911 call. The occupant was outside when fire crews arrived. The home sustained quite a bit of damage and the homeowner will be displaced. There were no injuries reported.
- 7/11 Commercial Fire: AFR fire crews were dispatched to an outside fire at the Scarpas restaurant located at 5500 Academy Rd NE in fire district 15. When Engine 15 arrived they recognized a trash pile against the building had caught nearby connex boxes on fire. These large containers were next to the gas meter and set the gas meter on fire. A full dispatch was requested at this point. Firefighters pulled an attack line to protect the structure while simultaneously shutting the gas meter off. The fire was extinguished within minutes of responding. No injuries were reported.
- 7/12 Residential Fire: AFR crews were dispatched to the 300 block of Dallas St SE in fire district 5 to a single story residential home. Firefighters encountered smoke and flames coming from the back of the house upon arrival. Interior crews announced the structure was an enclosed structure (wrought iron), and appeared to be abandoned with boarded up doors. The fire was quickly extinguished. The structure appeared to be inhabited by squatters but was currently vacant. The structure was left in possession of **CABQ** Code enforcement.

- 7/17 Commercial Fire: AFR crews were dispatched to a commercial structure fire at 933 San Mateo Blvd NE in fire district 11. Upon arrival, crews found smoke and flames coming from the roof. A ladder truck was used to gain access to the roof and deploy an attack line. The fire was quickly isolated and under control within minutes. There were no injuries to civilians or firefighters.
- 7/17 Apartment Fire: AFR crews were dispatched to a fire at 1004 Indiana St SE in fire district 11. Upon arrival they found smoke and flames coming from the home. Crews made a quick attack of the fire. Crews found a woman whom they rescued through a window and transported. There were no other injuries to civilians or firefighters. Arson was called to investigate the cause.
- 7/20 Swift Water Rescue: AFR units received reports of potentially three victims swept away in rapid waters following flash flood conditions near 7500 Constitution St NE in fire district 9. The victims were not spotted at the designated checkpoints AFR Swift Water crews had established. Unfortunately, three bodies were discovered in the North diversion channel near Roy Rd and 4th St. NW over the next three days.
- 7/27 Swift Water Rescue: AFR units received reports of a female victim swept away in rapid waters following flash flood conditions near Wyoming and San Francisco Rd NE in fire district 20. The victim was not spotted at the designated checkpoints AFR Swift Water crews had established. The victim was found deceased the following morning in the North diversion channel near Roy Rd and 4th St. NW.
- 7/28 Residential Fire: AFR units On July 28, at approximately 11:53 in the evening, Albuquerque fire rescue crews were dispatched to the 3600 block Yippee Calle Ct in fire district 18, Northwest for reports of a structure fire. A neighbor who called 911 to report smoke coming from the structure stated the owner was out of town. Upon arrival, engine 18 reported heavy smoke coming from the roof of a two-story residential structure. Engine 18 quickly forced entry into the home and begin searching for the fire while Rescue 18 was simultaneously conducting a search of the entire residence to ensure there were no occupants. The fire was located in the void space between the ceiling and the roof. The firefighters quickly began pulling down ceiling to expose and extinguish the fire. The home was in the process of getting a new roof which appears to be where the fire originated . In total, nine AFR units responded and worked together to contain the fire to the home of origin, not allowing it to spread to any of the neighbors homes. There were no AFR worked with APD, BCSO, BCFD and Sandia Pueblo PD to injuries to civilians or firefighters. There is no further information available for this call.

- 1. Albuquerque Fire Rescue joined the family of Councilor Ken Sanchez, Mayor Tim Keller and Abq City Council for the dedication and renaming of Fire Station 7. Councilor Ken Sanchez was an exceptional advocate for Albuquerque's west side and worked hard to build Fire Station 7. The dedication came on Ken Sanchez's birthday who would have been 65.
- 2. AFR recently began using a department owned drone (UAV) for search operations involving victims of the flash flood conditions in late July. Aerial cameras allow a unique and valuable perspective in multiple scenarios. This operation confirmed that having these new tools available will greatly benefit our department and the community we serve going forward.
- 3. AFR deployed 3 members of the Wildland Task Force to Oregon along with BCFD, and Cochiti Fire personnel. They assisted with the Bootleg Fire which was at 273,582 acres at the time of their deployment. The AFR crew consists of; Firefighter Karina Hernandez (ENGB), Paramedic Driver Justin Moore (ENGB), and Paramedic Driver Daniel Murphy (ENOP).
- 4. AFR Station 19 held a traditional push-in ceremony for their new engine, a 2021 Ferrara Cinder. Family & Community Services was instrumental in the acquisition of Engine 19 through the Community Development Block Grant.
- 5. Lt. Athena Valerio-Hirschfeld, Lt. Jake Gray, and K-9 Wrigley, Crisis Response Canine attended the Friendship Coffee at the Highland Senior Center. Lt. Gray used this opportunity to discuss and demonstrate Wrigley's special skill set.











AFR, Albuquerque Police Department and New Mexico National Guard completed the fifth and sixth week for Camp Fearless hosted at Oñate Elementary and Sagebrush Church on Coors NW. Live rescue scenarios were demonstrated at the Whitewash Trail and the Rio Grande river. This new group of campers learned basic first aid, injury prevention and a comprehensive demonstration of emergency response agency operations. These last two weeks were unique as the rescue operation demo was also a training exercise for the Office of Emergency Management. Members from Albuquerque Mountain Rescue Council, Rio Grande Basin Rescue, Rio Rancho Fire and Rescue and the UNM EMS Consortium also contributed their expertise to make these events fun and safe for all.

The remaining 14 inspectors were sent to 5 different parks to inspect and standby for 5 different firework displays set to go off simultaneously around the city. Everything went off without a hitch and the collaboration between all the different city entities worked well.
- This year's Camp Fearless was a huge success. FMO sent 5 inspectors for five weeks, and along with APD, National Guard and many others put on a great camp for well over 100 kids. They put on many different interactive events that really engaged the children and taught them some valuable life lessons. The children got to simulate a mountain rescue, a river rescue, and learn a part of what emergency workers do. One of their favorite activities was a tug -of-war that teamed all the kids against Gary Davis. Gary won!! Every year, seeing the positive impact this has on the children, makes it such a worthwhile event.

#### **ADAPT**

- ADAPT has had 82 properties that have been formally brought into the program, 28 have been cleared from the program and 54 are still in the program at different stages. ADAPT continuously monitors the properties that are in the program to track their compliance with the Nuisance Abatement Agreement.
- There are 125 properties on the Unsafe Buildings list, 4 new properties were added to the list, and 1 property was removed because of demolitions. The list is in Target Solutions file center, under the FMO > ADAPT > Unsafe Buildings tab. The properties are labeled on the First Due application with a white "X" on a red background.
- The APD Crime Prevention Specialists inspected 3 properties.

#### **PLANS CHECKING**

- witness statements being obtained by Fire Investigators. The suspect was later arrested and charged with a 2nd degree felony.
- 8 letters of interest were submitted for the upcoming Captain vacancy within the division. Interviews have been scheduled and upon section the process to gain acceptance into the Police Academy will begin.
- Curbs were painted adjacent to the Arson Office in the St. 13 parking lot. These spaces are to be utilized by arson personnel in order to keep the vehicles parked behind the locked gate at night.

- Several stations are set up with and evolution in the afternoon.

#### **EMS**

- Paramedic School
  - \* 3 AFR members graduated UNM's paramedic school program on July 15th. Congrats to Driver Carlos Miranda, Firefighter Ryan Hill and Firefighter Craig Amend.
  - \* Several CNM P-School students had scheduling issues that were becoming an issue. Working with CNM we were able to find solutions and change ongoing procedures to prevent this in the future.
  - \* An AFR member in CNM P-School contracted COVID-19, the Firefighter is doing well and recovering quickly. All contact tracing and State notification done by AFR Safety Officer, and CNM's program director.

#### **Community Training**

 AFR's Training Division, In conjunction with CABQ's Employee Learning Center, restarted Lifesaver training for new employees. This was the first Lifesaver training held since COVID-19 shut downs were instituted. It was received with great enthusiasm by CABQ new hires, and we got outstanding feedback for all AFR members involved with the training.

#### **WILDLAND**

#### 4th of July Readiness

In order to be proactive and assist front line units for a busy Fourth of July
weekend the AFR Wildland Division, along with surrounding agencies,
coordinated an Albuquerque metro area initial attack plan. Brush units were
staffed throughout the day and into the evening to conduct patrols, respond to
wildland incidents and conduct small training evolutions. Fortunately, with the
help of recent rain and good communications, vegetation fires were minimal and
quickly extinguished.

### **Deployments**

- The AFR Wildland Division deployed resources to the following fires:
  - \* Brush 22 115 Fire, 10 acres- Aztec, NM
  - \* Brush 22 currently assigned to the Bootleg Fire 413,400 acres in Bly, Oregon
    - 3 personnel 1 Engine Boss, 1 Engine Boss (trainee), and 1 Engine Operator.
    - Assigned as a part of a New Mexico strike team, consisting of resources from the following agencies: Bernalillo County Fire Rescue, Los Alamos County, San Juan County, Valencia County, Cochiti Fire Department, Sandoval County and Farmington Fire Department.

#### HTR

- Albuquerque Fire Rescue has been very busy with flood channel rescues.
   During the month of July, AFR responded to eight individuals in the flood channel. Joint efforts with APD and BCFR resulted in the rescue of four of those individuals.
- The AFR Heavy Technical Rescue Division and doctors with the UNM EMS
  Consortium spent four days training on technical rescues to include: vehicle
  extrication, high angle rescue, flood channel and swift water rescue. This
  training allows the doctors to experience the unique challenges from a rescuers
  perspective and rescuers learn best medical practices from the doctors.
- AFR crews were dispatched to an individual who became trapped in a storm drain. The injured male had to be secured with rope systems in order to ensure he could breathe while firefighters were working to extricate him from the storm drain. AFR crews then had to dismantle the drain while being mindful of the confined space they were working in. The atmospheric readings obtained showed that the space was flammable presenting additional challenges. AFR crews were able to mitigate the atmosphere and safely rescue the individual from the storm drain.

#### **HEART**

- In the month of July, HEART took over 960 calls for "Rides with HEART" ride share services and provided ride services for 370 people between the ages of 50 and 59 and 590 for people 60 and over.
- The HEART Home Modification Program provided 32 home installation services.
   These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 20 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided Stations 1, 3, 4, 5, 7, 11, 12, and 14 with "Leave Behind Narcan Kits" to provide to community members in need. During the month of July, 20 kits were given to community members in need. HEART hopes to expand the program city wide in the near future.
- HEART sent Lieutenant Laurianna Sargent and our Crisis Response Canine
  Wrigley to Santa Fe for a week long training at the Assistance Dogs of the West
  training facility. At this training, Lt. Sargent was trained to be the secondary
  handler to Wrigley. Also, Lt. Athena Valerio-Hirschfeld was sent to the training
  for two days to become Wrigley's respite handler.
- The HEART "Be BRAVE" Fall Recovery Class started back up for its first time since the beginning of the COVID pandemic. HEART providers were able to provide the training to a group of residence at The Montebello on Academy -Senior Living Community.
