



### ALBUQUERQUE FIRE RESCUE SIGNIFICANT ALERT EVENTS

These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

5/6 - <u>Residential Fire</u>: AFR was dispatched to the 4800 block of Tower Rd SW in fire district 7 for reports of a structure fire at single family residence. Rescue 7 was first on scene and reported smoke and flames coming from the home. Swift efforts from firefighters brought the fire under control within 13 minutes after their arrival. Although the occupants were home they were able to self evacuate with no injuries. The fire extended into the attic space which made it a little more difficult for fire crews. There were a total of 9 AFR units totaling 23 firefighters on scene.

5/7 - <u>Apartment Fire</u>: AFR was dispatched to the Desert Park Apartments located at 900 Valencia Dr SE in fire district 11 for reports of a fire. Engine 11 was first on scene and reported a working fire with smoke and flames coming from a single apartment on the 2nd story. Firefighters extinguished the fire within 10 minutes of arrival. Swift efforts of fire crews contained the fire to the apartment of origin and there was no fire extension into any of the other apartments. The occupants were not home at the time of the incident. A total of 16 AFR units with 40 firefighters responded to this fire.

5/7 - <u>Residential Fire</u>: AFR Rescue responded to a single family home located at 4808 Douglas McArthur Dr NE in fire district 19. Rescue 19 was first on scene and reported smoke and flames coming from the side of the house. Fire crews quickly put the fire out within minutes of arrival. Although the fire was contained to one room, the house sustained smoke damage throughout. The occupants self evacuated. There were no civilian or firefighter injuries reported.

5/11 - <u>Residential Fire</u>: AFR responded to a residential structure fire located near Broadway and Santa Fe St. SW in fire district 2. Rescue 1 noticed heavy smoke in the area while responding to another call. The crew located a small single story residential structure with smoke coming from the back of the house and called for a full dispatch. The home was undergoing renovation and had no occupants at the time of the fire. Albuquerque Fire Rescue crews forced entry into the home and quickly brought the fire under control and extinguished the fire. There were 9 AFR units that responded to the fire.

5/13 - <u>Apartment Fire</u>: AFR was dispatched to the 4200 block of Central Ave NE in fire district 3 for reports of a structure fire at a residential dwelling. The first arriving unit on scene reported a working fire affecting one of the apartments. The fire was brought under control within 6 minutes after their arrival and was contained to the apartment of origin. One civilian self evacuated and was transported for injuries. The cause of the fire is determined to be accidental.

5/17 - <u>Apartment Fire</u>: AFR crews were dispatched to 312 Louisiana Blvd. SE in fire district 5 for reports of smoke and flames coming from a single story abandoned apartment. Engine 11 was first on scene and reported heavy smoke and flames on the southwest side of the structure. 14 AFR units were dispatched to the fire. Engine 11 along with the other units were able to extinguish the fire within 25 minutes. All three apartment units were damaged with the initial apartment having the most significant damage.

5/27 - <u>Water Rescue</u>: At approximately 12:29 PM, five units were dispatched to Avenida Dolores Huerta SW for reports called of a victim stranded on a sand bar in the middle of the river. AFR and APD worked together to safely get this swimmer and his dog to safety. The overall rescue took 30 minutes.

5/28 - <u>Residential Fire</u>: AFR units were dispatched to 234 Louisiana Blvd. SE. in fire district 5 for a working fire at a small residence. Rescue 5 was en-route to a medical call when they saw smoke from a nearby location and discovered a working fire. Station 5 and Engine 11 simultaneously searched the structure and performed fire control. The structure was clear of all occupants and the fire was brought under control within 10 minutes.

5/29 - <u>Residential Fire</u>: AFR units were dispatched to 733 Louisiana SE in fire district 5 for reported Structure Fire. Engine 5 was the first unit to respond and reported a working fire with flames showing. An offensive fire attack to the main body of fire resulted in minimal impact to the interior of the occupancy. 12 total AFR units responded with no reported injuries to civilians or AFR personnel.

5/29 - <u>Residential Fire</u>: AFR crews were dispatched to 7320 Cienega Rd. NW in fire district 18 for a report of single-story residential fire. 10 Albuquerque fire rescue units responded. Fire crews were able the extinguish the fire within 30 minutes. The structure was a total loss. Occupants were displaced and able to stay with other family members.

# ALBUQUERQUE FIRE RESCUE **CURRENT EVENTS**

- 1. The AFR Wildland Division works with the High Desert HOA annually on wildfire prevention and safety. Judy Pierson is Chair of the Fire Preparedness Committee under the HDHOA and has helped coordinate a unique strategy this year to create a more defensible space in their neighborhood. With help from a Fire Adapted NM micro grant, a herd of goats and sheep were brought in by Horned Locus Goatscaping to graze on the native landscape and reduce the amount of vegetation that wildfires feed on.
- 2. Station 1 B-Shift performed a pre-incident planning assessment on the historical Sunshine building. The building is approaching 100 years of age and has multiple floors and spaces that could be difficult to navigate. Having these opportunities greatly increase the safety of firefighters in the event of a fire.
- 3. The AFR 100th Cadet Class traveled to the Rio Grande bosque open space area to learn wildland firefighting including pump operations.
- 4. The AFR Executive Staff participated in the final week of suppression refreshers along with other members and did a fantastic job! EMS refresher is now in full swing and includes open space rescues commonly found in the foothills and bosque areas.
- 5. Engine 21 responded to cyclist who had fallen off of her bike a few blocks from home and was unable to ride back. Firefighter Loren Martinez rode the tricycle home for her and helped get her comfortable back at home after she decided not to be transported to the hospital.
- 6. Evan, a 2nd grader at Georgia O'Keefe Elementary, created a fire station for his "Boxville" project to help students learn about the needs and careers within a community. Even taught his peers about fire safety and first aid. Good job Evan, we hope to see you apply with us in the future!



### FIRE MARSHAL'S OFFICE

#### INSPECTIONS DIVISION

- This month the Fire Marshal's Office hosted a senior intern, Isaac Montano, from Hope Christian who was required to work 4 weeks in a career field he may be interested in pursuing. Isaac got a very well rounded view of our department and all that is offered with a career in this field. It is eye opening to see how much more is offered in our department in addition to fighting fires and medical calls. Thank you to everyone that helped show Isaac what they do and made him feel very welcomed. He had nothing but positive things to say about all of his encounters!
- Working with Arts and Culture and members of the Mayors office, FMO surveyed the Rail Yards for Mayor Keller's State of the City Address. We ensured all existing life safety systems were up and working and all other buildings had added safety measures. We also ensured there would be adequate points of egress with FMO personnel on standby. The Mayor's address went off without a hitch and AFR personnel that were present worked extremely well together. A special thanks to the crews from Engine 4, Ladder 1, and the PIO office for all of their assistance with the inflatable training house.
- The FMO division Captains worked together to devise this years 4th of July plan. Starting in June, we will begin issuing cease and desist orders to all addresses that receive 2 or more 311 complaints. We will also have FMO personnel conducting night inspections in an attempt to find and educate the more problematic firework abusers. We will assign patrols to cover the city on both the 3rd and 4th, along with APD, in an effort to slow the amount of illegal firework usage.

#### ADAPT

- ADAPT has 153 properties that have been formally brought into the program, 96 have been cleared from the program and 57 are still in the program at different stages. ADAPT continuously monitors the properties that are in the program to track their compliance with the Nuisance Abatement Agreement.
- During the Month of May 4 TLC properties cleared the program with a 100% reduction in 311 calls over a 6-month period. For ADAPT properties the average drop in crime at 4 cleared properties is 61%. For COP properties 1 location has been cleared and showed a 100% drop in criminal activity.
- There are 125 properties on the Unsafe Buildings list. Four new properties were added to the list this month. The properties are labeled on the First Due application with a white "X" on a red background. In the field these properties are marked with a red spray painted "X" and the letters "AFR" under it.

### MAY 2023

#### FIRE INVESTIGATIONS DIVISION

- On May 6, 2023, AFR responded to a structure fire in southwest Albuquerque. Fire investigators responded to the scene to conduct an origin and cause investigation. After a thorough investigation, an arrest was made in connection with arson. BCSO was also on scene and coordinated their efforts with AFR FID to take the suspect into custody.
- On May 7, 2023, AFR fire investigations personnel were dispatched to the Desert Park Apartments, located at 900 Valencia Dr. SE #35 to determine the origin and cause of a structure fire. Upon arrival fire investigators met with AFR Battalion 2 Chief. He stated fire crews showed up to smoke and flames showing from a second-story apartment, which was determined to be apartment #35. Engine 11 was the first unit on scene and stated that the front door of this apartment was open upon their arrival and that they did not force entry. Engine 11 was able extinguish the fire that was located in the living room area. During fire suppression efforts, neighbors were holding down the male individual who they stated they witnessed starting this fire. The suspect was arrested and taken into custody.
- On May 11, 2023, the Fire Investigations Division was recognized by the IAFF Local 244 for outstanding performance in investigations and subsequent arrests. Thank you IAFF Local 244 for the support.
- Lieutenant Freddy Sanchez officially joined the division and will be the B-Shift Lieutenant. Thank you to Lieutenant Adair for your dedication to the division and all of your hard work. Lieutenant Adair was in the division from 2020-2023.
- K9 Louise "Wheezy" celebrated her sixth birthday. Happy Birthday Wheezy!
- On May 19, 2023, AFR Fire Investigations personnel had the privilege of participating in the Law Enforcement Torch Run for Special Olympics NM.
- On May 29, 2023, Fire Investigators were contacted by Sergeant Bowe of the Albuquerque Police Department in reference to a male subject of interest related to a structure fire event that took place the previous day, May 28, 2023. Sergeant Bowe stated the male subject had been detained and asked if Fire Investigators would like to contact the subject. Fire Investigators arrived on scene shortly after being notified by Sergeant Bowe. Upon arrival, Sergeant Bowe stated that his officers were patrolling the area where the fire incident took place and observed a male subject matching the description from the previous day on the east end of the structure that sustained prior fire damage. Sergeant Bowe stated his officers contacted the subject who was identified. Prior to Fire investigators contacting the suspect, APD officers read him his Miranda rights in which the suspect agreed to speak to Investigators. The suspect stated he had been in the area because he was cleaning up debris on the vacant property. He advised that he was at the property the day before on his bicycle and with a backpack, however, he did not start a fire. The suspect later stated that he started a fire on the property because he was warming beans. Fire Investigators concluded the investigation with the suspect, and he remained in APD custody for a felony warrant that was extraditable out of Arizona. The Fire Investigations Division has a total of 54 responses YTD (27 fire investigations, 19 consult cases, and 8 ATF/canine cases).

### **EMERGENCY SERVICES**

#### **RECORDS MANAGEMENT**

- Provided data revolving around AFR's response to the International Sunport and surrounding properties in compliance with the MOU between The Albuquerque Aviation Department and AFR for EMS response.
- Updates several hundred prescribed medication descriptions within ImageTrend to assist providers in obtaining patient's medical history through obtaining a patient's prescription medications.
- Began the process of updating the Primary Impression Lists to increase documentation precision as well as increasing the Departments ability to accurately and efficiently track data and make changes to improve patient care/ patient's outcomes
- Continued conducting RMS station visits educating crew on available resources, how to mitigate common issues with ImageTrend, answering questions, receiving suggestions for improvements and talking about current projects the division is working on.
- Continuing the process of moving AFR's EMS documentation to the new version of the National EMS Information System (NEMSIS). This is the national system used to collect store and share EMS data from across the country. NEMSIS develops and maintains a national standard for how patient care information is documented. This system is designed to improve patient care through standardization and point of care data aggregation.
- Continued work on the Premier One CAD to ImageTrend Elite integration. This
  will create a single source for all of AFR's statistical analysis and improve the
  accuracy and consistency across all variables.
- Assisted with AFR's professional development program, teaching EMS & Fire documentation in the Lieutenant Certification course.
- Provided support fill in for in for frontline units.

#### HEART

- HEART division moved from John Marshal to new facility. This new building will better foster alternative response, create an in-house home modification prefabrication site as well as house all HEART members and equipment under one roof.
- HEART provided 68 rides with its "Rides with HEART" rideshare service.
- The HEART Home Modification Program provided 30 home modification installation services. These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 53 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with "Leave Behind Narcan Kits" to provide to community members in need.
- · Fentanyl Strips to Frontline units has been completed and supply will be ongoing.
- Buprenorphine Program- Inserting information for suboxone treatment in the LBN kits. Individuals will receive access to an app with counseling, cognitive behavioral

therapy and contingency mgmt. Plus, monetary rewards for compliance. Will be an ongoing push.

- Lt. Cruz officially moved over and his training has begun. He will eventually take lead on repeat patient program.
- To date, the HEART BEATS stroke discharge program has received over 356 referrals for service. HEART is currently working with 42 patients in the program.
- Pediatric Assessment Program is currently being forged. AFR HEART division will partner with UNM Hospital for pediatric assessments. The mission is to provide a patient visit with assessment 24-48 hours post discharge for sick children who were discharged from the hospital with oxygen. Details are still being worked out. The go live date to be determined. All equipment, documentation and staff are trained and ready to respond. Currently working of referral process with UNM ED.
- Two members attended a "Steps to Safety" class taught by NFPA at Rio Rancho Fire Dept.
- Taught a three-step BE BRAVE class that focused on fall prevention and fall recovery at Oasis Independent Living.
- HEART Carpenter helped out CIP with projects while they rehire more staff and assisted HEART and RMS with moves to new respective locations.
- HEART Carpenter will resume partnering with Department of Senior Affairs to assist with home mods for our elderly in the community.
- Met with Adult Protective Service to discuss referred patients.
- Presented at Adult Protective Service's operations meeting to educate them on HEART and community paramedicine.
- Wrigley responded post a tragic incident to Robertson HS in Las Vegas, NM. Her presence was a huge success. Both staff and students were debriefed.
- Working on Blue Cross Blue Shield application. Hopefully this will be led to reimbursements for the stoke assessments. Work in progress.
- Working with Image Trend on a "direct" messaging service that will bridge the gap for our pediatrics respiratory assessment program. Work in progress.
- Continue to build and foster a partnership with New Mexico Cancer Center with Wrigley's help.
- Partnered with ACS on several patients.
- KOB News story on HEART programs and impact to the community.
- Educated the students about the division at the Lieutenant Certification.
- Podcast on HEART rolled out to the department on Vector Solutions.
- HEART FAQ also posted on Vector Solutions.
- Provided support fill for frontline units.

#### QUALITY ASSURANCE

- PECMO training has been completed for all three shifts at Station 3. PECMO will once again be operational with a projected start date of the third week of June.
- The EMS Division is in the process of completing Paramedic Credentialing for 10 new AFR Paramedics.
- AFR is continuing to work with APD, ACS, and other community shareholders as we collectively determine the best way to address the mental health crisis in our community.

#### PHARMACY

- Attended Wifi meeting with AFR tech and City tech to figure out how to have more reliable internet connections for our NarcBoxes. AFR Tech has a NarcBox and is working with the company and the city for a solution.
- Working on the escalatory emails that are sent to the BC's due to a NarcBox not being checked on time. Currently the email does not list the unit identifier.
- HUD gurneys have been received and AFR pharmacy will start the process of distributing them.

### **SPECIAL OPERATIONS**

#### FOC

- In May of 2023, the Field Operations Center flowed smoothly. Late April and early May come with the beginning of the Isotopes Baseball and NM United Soccer home games. The FOC works to staff these home games with EMS coverage as contracted with the Isotopes Stadium. Most days, this includes 4 AFR personnel that respond to varying degrees of emergency medical incidents within the stadium during the events. Ideally, these personnel are utilized through the overtime signup lists. In the event that full coverage for an event cannot be utilized with field overtime sign-ups, the FOC will coordinate with a designated on-duty Battalion Chief that will arrange sending a field unit to cover the 4-to-6-hour event.
- Recent promotional exams have produced new lists for Drivers and Lieutenants. Personnel have promoted into various field vacancies, helping to alleviate some of the staffing strains and balance the distribution of personnel among all 3 shifts in the field. In addition to this, the FOC is anticipating the upcoming credentialing of recently graduated AFR Paramedic students to address the needs for positions at this licensure level in the field.

#### SPECIAL EVENTS

In May, AFR provided EMS coverage and displayed a Fire Truck for the Old Town Mother's Day event sponsored by the City of Albuquerque. Preparation meetings have been underway and event action plans (EAPs) created for the City's three Summerfest events, beginning with the Heights Summerfest in North Domingo Baca Park on June 10. This will be followed by the Route 66 Summerfest in July and the West Side Summerfest in August. One of the City's biggest sponsored events will the Freedom 4th at the Balloon Fiesta Park. AFR provides EMS coverage for these events. The Fire Marshal's Office also provides coverage for the event to ensure everything is done safely for all participants. In addition to EMS and Fire Marshal's Office involvement, the AFR Wildland program works alongside FMO for fireworks coverage to wrap up comprehensive Fire Service involvement for the heavily-attended Freedom 4th.

#### WILDLAND

- For the month of May, the Wildland Division hosted Wildland Week for the 100th Cadet Class. This week consists of all required training to become an entry-level Wildland Firefighter.
- The Wildland Division also participated in a community wildfire preparedness event with High Desert Homeowners Association. The focus of the event was wildfire prevention, preparation, and fuel mitigation/reduction utilizing "goatscaping".





#### HAZMAT

- The Hazmat coordinator is planning and participating in a team building exercise with the 64th CST and Albuquerque Fire Rescue. The purpose of this meeting is to enhance communication between the teams and foster stronger collaboration with Sandoval County.
- Station 17 conducted a training session led by the hazmat coordinator on utilizing the class A-kit. The training served as a refresher on the proper use of the level A-kit specifically for handling 150lb chlorine pressurized cylinders.
- We are currently in the midst of a two-week Hazmat tech course that began at the end of May and will conclude in the first week of June. Upon completion of the course, we will welcome an additional 12 new technicians to augment our department's workforce.

#### HEAVY TECHNICAL RESCUE

- The technical rescue needs were in high demand this month!
- Joint training operations with BCFR and AFR for our flood channel system occurred this month. All crews assigned along the flood water control system rehearsed, prepared, and completed scenario-based training to be ready for the monsoon season.
- AFR, APD, and BCSO students completed their Rope Rescue Operations course this month. This prepares us for rescues that require vertical access in the mountains and industrial setting. The joint aspects of these courses are critical as we all come together to ensure everyone goes home from the mountains. These events are large and intensive in labor. The joint courses also prosper relationships among responders and ensure a common ground and compatibility of our systems. Priceless in those high stress high risk situations which are occurring more often.
- The Rio Grande River has delivered big flows this year especially over the sunny holiday weekend. Corrales Fire Department lead a collaborative effort bring all the responding agencies together to be proactive with safety on the river during these high flow times. Coordinated patrols, common communication channels, public announcements, and many other aspects by all partners involved lead to a safer time on the river. Despite the many rescues this month on the river, our response times have been quick, support is available, and interagency operations has been priceless. Thank you to all of our responding partners especially APD Open space who assisted in our inflatable raft to be outfitted with an out-board motor during these high risk river conditions.


