





SIGNIFICANT EVENT ALERTS

These events are activated by the AFR Dispatch Center as a "Significant Event" and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

11/9 - Residential Fire: AFR crews were dispatched to a single story residential home located on 1500 block of California ST NE in fire district 5 for reports of a residential fire. Upon arrival, crews found a single family dwelling fully involved. Crews quickly jumped into action trying to extinguish the fire. Three residents were able to evacuate from the home. The residents were transported to the hospital for evaluation. Despite significant damage suffered to the home, AFR crews were able to stop the fire from spreading to other homes.


11/10 - Residential Fire: AFR responded to a single story residential home located on the 900 block of Ortiz DR SE in fire district 11 for reports of smoke. Fire crews arrived to find heavy smoke coming from the residence. Crews quickly pulled primary and secondary attack lines. The fire was quickly extinguished within approximately 20 min from dispatch. There were no injuries reported. The home suffered heavy smoke and fire damage.

11/11 - Commercial Fire: AFR responded to a Big O Tire shop located at 1141 Juan Tabo Blvd. in fire district 12 for reports of smoke. Fire crews arrived to find heavy smoke coming from the building. Crews quickly pulled primary 2-1/2" blitz line for an offensive attack. The fire was quickly extinguished within approximately 20 min from dispatch. There were no injuries to firefighters or civilians reported.

11/12 - Residential Fire: AFR was dispatched to the 1300 block of High St SE in fire district 2 for reports of a single story residential structure fire. Fire crews from station 2 arrived on scene and reported a working structure fire with smoke and flames coming from the front and the side of the home. Engine 2 deployed hand lines in order to initiate an interior attack of the fire while Ladder 1 arrived on scene and performed a simultaneous search of the home. A water supply was secured by Engine 1 while Engine 3 was assigned to Rapid Intervention Team. Ladder 1 assisted with ventilation of the home as Rescue 2 secured the utilities. The home owners were able to safely exit the home prior to AFR arrival. Fire crews were able to quickly get the fire under control and prevented the fire from spreading to nearby homes. The origin of the fire was found to have been coming from one of the bedrooms, the cause of the fire is under investigation. The home owner will be displaced as there is significant fire and smoke damage to the home. There were no injuries to firefighters or civilians.

11/12 - Commercial Fire: AFR and BCFD were dispatched to a recycle facility at 5021 Edith Blvd NE in fire district 6 for reports of a fire that had started in a compactor. AFR Engine 6 arrived on scene and reported a working fire in a compactor and initiated a quick attack. AFR Battalion 1 arrived on scene as well as AFR Engine 19 and BCFD Engine 30. Unified Command was established and both agencies worked well in order to get the fire under control quickly. On scene fire crews were able to keep the fire

contained to the compactor, preventing any extension into the recycle facility. There were no injuries to employees of the facility or firefighters.



California St. Fire



SIGNIFICANT EVENT ALERTS

These events are activated by the AFR Dispatch Center as a "Significant Event" and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

11/12 - Commercial Fire: AFR was dispatched to a commercial structure fire on Juan Tabo and Princess Jeanne NE at the Firestone Auto Center in fire district 8. Engine 8 arrived on scene and reported heavy black smoke coming from the back side of the structure. As additional resources began to arrive on scene, Engine 8 deployed 2 hand lines and initiated a quick attack of the fire. Due to the size and complexity of the structures involved, command called for a 2nd Alarm to be dispatched. Fire crews were able to then gain control of the fire utilizing multiple hand lines and horizontal ventilation of the building. The structures involved sustained heavy smoke damage to the interior and the cause of the fire is under investigation. A total of 14 fire apparatus responded and fire crews did a great job at getting the fire under control.

11/21 - Mobile Home Fire: AFR was dispatched to a possible structure fire on the 300 block of Galantenu NW in fire district 14. Crews arrived to find smoke and flames coming from the rear of a single wide mobile home. The fire was quickly extinguished but there was extensive damage to the home as well as a shed and vehicle. No injuries were reported.

11/27 - Residential Fire: AFR was dispatched to an abandoned single story residential home on the 1400 block of Espejo St. NE in fire district 9. Engine 9 was first on scene and saw flames coming out of the front of the home. As crews were working on extinguishing the fire, a portion of the roof collapsed and crews had to exit the structure and fight the fire from the exterior of the building. Shortly after exiting the building, AFR crews were able to extinguish the fire. No injuries to any AFR personnel or any civilians occurred. The home was abandoned, therefore no residents had to be displaced.

11/28 - Commercial Fire: AFR was dispatched to an abandoned two-story, unoccupied church on the 3600 block of Montgomery Blvd. NE in fire district 19. Engine 19 was first on scene and saw light smoke coming out of the second floor window. Crews found rubbish/trash on fire on the second floor and quickly extinguished the fire. No injuries to any AFR personnel or any civilians occurred.

11/29 - Commercial Fire: AFR was dispatched to an outside fire near the area of San Pedro and Central NE in fire district 5. Upon arrival, Engine 5 found a pile of garbage on fire against the outer wall of a building. The outside fire then extended into the building which is when additional crews were called to fight the fire. Crews fought the fire from inside the building until the fire broke through the roof at which time the crews were called out of the building to fight the fire from the exterior. AFR crews were able to extinguish the fire. There were no injuries to firefighters or civilians.

5. 1200 pairs of socks were donated to residents of The Westside Emergency Housing Center with help from Cottonwood Mall General Manager Debra Sherman, Dream Big Founder Kevin Banks, Sams Club General Manager Rene Portillo, Councilor Cynthia Borrego, and AFR Captain Martin Salazar.
6. New apparatus that arrived in November included Squad 3, Engine 12, and Engine 8. These units were all welcomed with a traditional push-in ceremony.

FIRE INSPECTIONS

- Inspections- 325
- COVID Educational Interactions- 1447
- With the changes to the Public Health Order in November, the focus of the Inspection's office shifted to ensure COVID-19 compliance within the community, in support of the mission to flatten the most recent spike in cases.
- We are still conducting inspections on a limited basis, addressing complaints and requests from the business community. We've also continued installing ten-year smoke detectors and replacing batteries for those who require assistance.
- Our office was able to accommodate fire extinguisher training for Cutter Aviation to facilitate compliance with FAA regulations. We were able to train their entire management staff while maintaining COVID Safe Practices.

PLANS CHECKING

- Total Plans Reviewed - 142
- The Plans Checking Division is working on a new project called the Overture Andalucía Senior Apartments/Cottage Development. This is a 55 and over, 135,000 sq. ft. senior community located at 5300 Antequera Rd NW.
- The Plans Checking Division is working closely with the Orion Group, a major aerospace and technology company, on the Orion Center's development. The project is 4.1 million sq. ft., on a 122-acre site adjacent to the Sunport. The Orion Center plans include 1000 + aerospace manufacturing jobs for Albuquerque. Plans Checking has reviewed and approved the Fire 1 site plan for this project.

AFR DIVISION UPDATES

ADAPT

- ADAPT has had 61 properties that have been formally brought into the program, 23 have been cleared from the program, and 38 are still in the program at different stages. ADAPT continuously monitors the properties that are in the program to track their compliance with the Nuisance Abatement Agreement.
- The Structurally Compromised list has been changed to the Unsafe Buildings list. The list will still contain buildings that are structurally compromised from fire damage. It will also include all posted facilities as substandard (abandoned, vacant, dilapidated, no utilities) by the Code Enforcement Division. Twenty-nine properties have been removed from the list because they have been demolished or renovated. Over 140 properties are being added to the list and uploaded into the First Due application. The buildings are identified with a white "X" on a red background. The list is in Target Solutions file center, under the F.M.O.> ADAPT > Unsafe Buildings tab.
- One hundred sixty-seven properties have been identified for the Crime Only Properties Program. 6 APD Crime Prevention Specialists are diligently working on verifying each police report associated with all 167 properties. They have reviewed 90 properties, and 34 of the properties examined to meet the program criteria. Eight letters have been sent to the property owners, and three inspections have been scheduled.


FIRE INVESTIGATIONS DIVISION

- The Fire Investigation Division arrested a long-time arsonist of the downtown area. After many hours of investigative work by the division, an Arrest Warrant was obtained by Investigator O.Vasquez and was executed with assistance from APD's P.R.T. team. Anthony Tolbert was arrested for Felony Arson relating to a vehicle fire that extended into a structure in early November.
- Some of the trail cameras were removed from the Bosque over the last few weeks and redeployed. These cameras were used as a deterrent and possibly provided valuable photos of nefarious actions in the Bosque.
- The redeployed trail cameras are being used at Albuquerque's Healthcare for the Homeless for several outside fires that occurred over recent weeks. We are hoping that with these cameras, we will identify the individual that is the cause.



OPERATIONS

WILDLAND

- The month of November was very productive, primarily utilized for resource order billing and equipment maintenance. The annual revenue generated from this past fire season should exceed \$500K. The Wildland Division is excited to announce that we will be receiving a new COVID response unit by the end of the year.

HTR

- Albuquerque Fire Rescue HTR hosted a Trench Rescue Technician Course with N.M. Gas Company. Thirteen additional AFR members trained in trench rescue.
- Albuquerque Fire Rescue HTR conducted trench rescue refreshers for those currently trained in trench rescue. This year the concentration was on conquering an intricate L-shaped trench with perpendicular shoring to create a sizeable operating space safe enough to conduct a rescue.
- Albuquerque Fire Rescue outfitted a new HTR trailer with specialized equipment to better support HTR crews during a trench collapse.



EMERGENCY SERVICES

HEART

- AFR HEART has continued its work with Family and Community Services to select our Peer Support positions for the Harm Reduction Program.
 - * We completed interviews in November, and an individual was selected and will start to work with the team in January.
 - * The program will focus on working with individuals who have experienced a recent opioid overdose or are struggling with substance addiction.
- HEART providers and other members from the Albuquerque Fire Rescue continue to assist the New Mexico Department of Health with COVID testing at Expo NM.
- Collaborative Community Health Worker training continues for four members of AFR and two members of AMR.
- In November, the HEART providers attended an ARCA Acquired Brain Injury class.
 - * The four-hour class focused on numerous aspects of brain injury, including the following:
 - Brain Injury basics
 - Cognitive and psychosocial consequences
 - Effects of brain injury on families
 - Concussions and mild T.B.I.
- The HEART providers are continuing their efforts to better each existing program in the division. They are currently working hard on creating new programs, such as alternative responses to medical calls and a new Stoke Discharge Follow-up Program.
- The Stroke Discharge Follow-up Program is spearheaded by two HEART Lieutenants and is closely coordinated with the AFR Medical Director.

PHARMACY

- Currently, AFR has no shortages or issues related to P.P.E. for COVID-19 response.
