

ALBUQUERQUE FIRE RESCUE SIGNIFICANT ALERT EVENTS

NOVEMBER 2021

These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

- 11/5 <u>Apartment Fire</u>: At approximately 5:39 am, AFR units responded to reports of an apartment fire at 7600 Montgomery Blvd NE in fire district 15. Within 4 minutes, units arrived on scene and reported a working fire with flames showing from the roof. A total of 3 hand lines were put into place to check for fire and protect searching crews, evacuees, and the structure itself. All occupants were evacuated and the fire was declared under control. A total of 20 occupants were without power. No injuries were reported.
- 11/5 Residential Fire: At approximately 8:45 am, AFR units were dispatched to a structure fire at 1004 21st NW in fire district 4. Rescue 4 took command of the scene and Engine 1 quickly and stretched a hand line to begin fire attack. A chimney fire was found that had spread to the attic space. Rescue 4 performed a primary search while Ladder 1 made access to the roof to help vent the fire. Within minutes the fire was under control. Both the occupant and their dog had safely evacuated. Overhaul was very labor intensive due to the straw bale insulation of the structure. No injuries to civilians or firefighters were reported.
- 11/9 <u>Apartment Fire</u>: At approximately 4:03 pm, AFR units were dispatched to 210 Texas St. NE in fire district 5 for a small single story structure fire. A cooking fire started the house on fire, the single occupant of the home was able to exit the structure but sustained some smoke inhalation. The occupant was transported to a local hospital by AAS. Engine 5 was able to quickly get the fire under control and loss stopped shortly after. No injuries were reported.
- 11/11 Commercial Fire: AFR units responded to an abandoned commercial structure at 140 Juan Tabo NE in fire district 12. There was smoke coming from the building with no flames showing from the outside. Engine 12 made entry and was able to quickly get the fire under control. After the fire was extinguished, it was determined the fire started outside and had spread into the building. The cause of the fire was undetermined.
- 11/11 Residential Fire: AFR was dispatched to 3958 Montgomery NE in fire district 19 for a structure fire at an apartment complex. Units from Station 19 arrived on scene and reported a working structure at a multi-family 3 story apartment building with smoke and flames showing from the 3rd floor. As additional fire crews arrived on scene, Engine 19 performed a quick attack as they were able to gain access into the affected apartment. Rescue 19 performed a search of the apartment to ensure that all occupants were out and safe. An additional hose line was utilized to assist in fire control as fire crews worked to extinguish the fire. The fire was brought under control and was contained to the apartment of origin. Three other adjacent apartments were affected by smoke and were also evacuated for precaution. A total of 13 fire units were on scene to assist with fire control as Battalion 2 and Battalion 3 crews made a good stop to prevent the fire from spreading, causing serious damage to the rest of the apartment building. No injuries were reported.
- 11/14 Residential Fire: AFR units were dispatched to 1801 Zickert PI NW in fire district 10 for reports of a fire. Crews found smoke and flames showing upon arrival. Engine 10 was able to quickly extinguish the fire. There was a victim found inside of the structure and was transported to UNMH but later succumbed to his injuries. Another occupant was treated for smoke inhalation and was already outside when crews arrived. It was later reported that the victim found inside had helped rescue his father and went back inside to search for his sister when overtaken by the smoke.
- 11/18 Residential Fire: AFR crews were dispatched to a structure fire near Central Blvd and Valencia SE in fire district 11. Engine 11 was first on scene and declared a working fire. Along with units E5, E3, L5, R11, R5, S3, B2, B1, the firefighters were able to contain the fire to a casita behind the house that was unoccupied. There were no injuries to civilians or firefighters.
- 11/19 Residential Fire: AFR units were dispatched to 908 Ganado SE for reports of smoke in the attic of a single story residential structure fire in fire district 12. On arrival, R12 reported light smoke in the attic and E8 was assigned to investigate. Crews found the seat of the fire and worked quickly to extinguish it and look for extension. The house is untenable, however the residents have family available and Red Cross services were declined. The cause of the fire appears to be electrical in nature but is under investigation. Unfortunately another fire occurred the next morning just after 6 am and a command decision was made to go defensive to protect any and all surrounding structures. There were no injuries reported to civilians or firefighters.

- 11/20 Motor Vehicle Accident: Shortly At approximately 7:00pm, AFR units were dispatched to a motor vehicle accident involving 3 motor vehicles and a motorcyclist at the intersection of Montgomery and Morris in fire district 16. Rescue 16 was first on scene and quickly took command. After triage and a primary assessment, AFR units confirmed 5 red critical, 1 black, and two dogs transported. Later reports confirmed a vehicle with five occupants struck another vehicle with a single occupant who was declared deceased by first responding units. One of the five occupants had been ejected and none of them were restrained causing significant injuries.
- 11/24 Residential Fire: At approximately 6:55am, AFR was dispatched to a small residential structure fire near Rio Grande and Zearing Ave NW in fire district 4. Upon arrival Engine 1 declared a working fire of a small one story unoccupied structure. Engine 1 began fire operations as Rescue 1 and Ladder 1 arrived to assist with search and ventilation. The fire was quickly brought under control and a search was completed to confirm that the structure was clear of civilians. A total of ten fire crews were on scene to assist with fire operations. The cause of the fire is unknown, there were no injuries to civilians or firefighters.
- 11/26 Residential Fire: AFR was dispatched to a single family home located at 7516 Teakwood NE in fire district 17. Engine 17 was first on scene to find smoke and flames coming from the back of the house. Fire crews quickly caught a water supply, made entry into the home and extinguished the fire within minutes of arrival. The homeowner had fallen asleep while cooking some food in the kitchen and was awakened by the smoke. The homeowner attempted to put out the fire with an extinguisher but was unable to do so. 911 was Initiated at that time. The fire extended through the house and caused extensive damage to the home. The occupant will be displaced and is staying with relatives. No injuries to the homeowner or firefighters were reported.
- 11/26 Commercial Fire: AFR crews were called to an outside fire located at 1200 Dickerson SE in fire district 2. Engine 2 was first to arrive and found the outside fire had spread to an unattached storage garage of a commercial structure. Firefighters quickly extinguished the fire in under 10 minutes of arrival. The fire damaged about 1/4 of the building. The storage contained various types of equipment. There were no occupants inside the structure at the time of the fire.
- 11/27 Commercial Fire: AFR units were dispatched to a two story commercial building located at 2015 Yale SE in fire district 2. The structure also had a basement. The fire was called in by APD. Engine and Rescue 2 were the first to arrive to find moderate smoke coming from the building. The building appeared to be boarded up but at one time used for offices. It was also apparent that squatters had been there as well at some point. Rescue crews conducted a primary search, which took a bit of time due to the layout of the building and the basement. The smoke conditions inside made it difficult for fire crews, but an all clear of occupants was declared. The fire was between the 1st and 2nd story floors which also made this structure fire difficult. The fire was extinguished but had caused significant damage to the interior of the building. No injuries were reported.
- 11/28 Residential Fire: AFR units were called to a single family residential home located at 1612 Alamo SE in fire district 2. Engine 2 was first on scene to find heavy smoke and flames coming from the back patio of the home. Upon further investigation, the patio was completely engulfed in flames impinging on the house. The swift efforts of firefighters quickly contained the fire to the patio as much as possible and had the fire extinguished within minutes. There was a little bit of extension into the house but crews were able to mitigate. There was smoke and some water damage inside of the house. The quick actions of firefighters saved this family home from being a total loss. The homeowner was awakened by the sound of the fire and called 911 immediately. The family of three and their pets were able to evacuate the home with no injuries. Red Cross was contacted to assist the family. There were no injuries reported. The cause appeared to be some hot ashes from the wood stove placed in a metal container close to combustibles.
- 11/28 Residential Fire: AFR units responded to a single family residential home located at 13426 Desert Hills PI. NE in fire district 16. Rescue 16 was first on scene and reported nothing showing. Engine 16 arrived seconds later and made entry into the garage. They encountered light flames and smoke. Crews extinguished the fire quickly. The home was vacant and light hoarding was apparent. There were no injuries to firefighters and the cause of the fire is unknown at this time.
- 11/30 Residential Fire: AFR responded to a single story residential home located at 606 Aztec NW in fire district 6. Engine 4 was first on scene and found smoke and flames showing from the front of the home. Firefighters quickly went into a defensive attack on the fire and extinguished the flames within minutes of arrival. Swift efforts from fire crews limited the spread of the fire to other areas within the home. Although there was minimal damage, the homeowner will be displaced due to the smoke damage. Red Cross was contacted to assist the occupant. Thankfully the homeowner self evacuated with no injuries and there were no pets inside at the time of the fire.



- 4. Members of the 97th Cadet Class hosted a "Family Night" where families were invited to the Training Academy to learn more about the Cadet process. Cadets displayed some of the skills they have learned including live burn scenarios.

Before becoming Interim Chief, Gallegos served as the Fire Marshal for three years.

Always choosing to lead by example and never shying away from the easy path, Rick will always be remembered as a man of true integrity. Thank you Captain Rick Cordova for your commitment to the department and the community, congratulations on your retirement and good luck in your future endeavors.

PLANS CHECKING

- The Albuquerque Fire Rescue Plans Checking Division worked with the water authority to open the new treatment plant at 6000 Alexander NE. The new treatment plant consists of four new buildings. The new facility passed their fire final inspection.
- The Plans Checking Division worked closely with multiple food truck vendors over the course of November. Our goal was to provide fire inspections to ensure the safety of the mobile food units in preparation for upcoming events.
- Plans Checking worked through a number of challenges with Tierra Adentro
 Charter School located at 1781 Bellamah NW. We were able to issue a 30-day
 Temporary permit to occupy while ensuring all life safety met the intent of the
 code. They have since passed their fire final inspection and have attained their
 certificate of Occupancy.

HEALTH AND WELLNESS OFFICE

The H&W Office continues its mission to ensure Albuquerque Fire Fighters have valuable and accessible resources to address the health and wellness challenges that present themselves throughout a career.

- The Health and Wellness office and the production/media office recorded multiple educational videos for our membership. Financial Expert Jocelyn Black was interviewed In October and professional performance coach Jose Maresma was interviewed two different times in November covering various topics about performance.
- AFR hosted financial expert Jocelyn Black to discuss financial literacy and wellness topics to the 97th cadet class. This class was a follow up to a class that was recorded in October to disperse to the entire membership via Target Solutions.
- AFR hosted performance coach Jose Maresma to present topics including diet, supplements, mindfulness and general performance topics to the 97th Cadet class. This class was a follow up to a class that was recorded in October to disperse to the entire membership via Target Solutions.
- The Health and Wellness office and BH Director slowly began to move into the new Clinical office located at the John Marshall Building (1500 Walter St SE). This location is off site from the administration building making it more assessable and amenable to the mission of clinical support for the members

- of AFR. The move includes securing the data lines and furniture needed for a comfortable clinical office.
- Through the COA contract with The Solutions Group, we were able to offer a
 unique resilience building exercise with most of the Academy Training staff. We
 participated in an exercise that was designed around the Wim Hoff cold plunge
 at an off-site location. The response was overwhelmingly positive. We plan to
 offer similar opportunities to different crews.
- The BH Director and H & W Officer continues to visit stations to introduce the BH director and overview the program to crews. The goal is to visit 2 stations/ divisions a week till the entire membership has had a chance to be introduced and is aware of the benefits available to them.



HEART

- In the month of November, HEART provided 32 rides with its "Rides with HEART" rideshare service. HEART continues it planning with FCS on the future of the program.
- The HEART Home Modification Program provided 36 home installation services.
 These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 19 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with "Leave Behind Narcan Kits" to provide to community members in need. For the month of November and October, more than 20 kits were given out by our EMS crews.
- To date, the HEART BEATS stroke discharge program has received over 121 referrals for service. HEART is currently working with 27 patients in the program.
- Wrigley, HEART's Crisis Response Canine, and her secondary handler, Lt.
 Sargent, went to Los Lunas to visit with an EMS crew from AMR who had to deal with a difficult and stressful call.
- HEART was invited to East Mountain High School to be a guest for a public safety brunch that was hosted by the school's student council.
- Members of HEART met with the upper management of Oak Street Health, a new medical provider in the city. Oak Street Health is aimed at serving seniors and people with disabilities who are on Medicare. Their services include a preventative care focus that strives to their patients healthy and out of the hospital.
- HEART joined the IAFF with the presentation of \$10,000 to the Make-A-Wish Foundation. HEART plans on partnering with Make-A-Wish to assist with building outdoor playsets for Make-A-Wish kids in our community.

FIELD OPERATIONS CENTER

This challenge is met by utilizing support staff during the week, probationary firefighters specifically placed on weekend shifts during heavier staffing needs, and accessing pools of voluntary and mandatory overtime. As the 97th cadet class graduates, the extra personnel will help to lighten the burden of adequately staffing field response going into the new year.
- On November 15, the FOC said goodbye to long-time firefighter Tony LaCour after nearly 10 years occupying this essential position. Thank you for your service, Tony!
- The Field Operations Center welcomed our newest addition to the team shortly after Firefighter LaCour's departure. Firefighter Mark Hoffman is a most welcome addition with his 17+ years' experience as a firefighter with Albuquerque Fire Rescue. We look forward to using his good work ethic and eagerness in his new position at the FOC.

HAZMAT

Training:


- Hazmat A&O challenge for the 6 personnel was a success, all passed.
- Hazmat technician challenge for one personnel was a success, passed.
- In-house training for station 13, and 17 on use of monitors to include familiarization of identifying unknown and known chemicals.

Monitors:

- With the approval from WIPP and WIPP funds, AFR received permission to purchase 4 RAdEye PRD4 radiation monitors. Once received, Squad 1 and Squad 3 will receive two RadEye monitors. With future WIPP funds, AFR will purchase 4 additional monitors. The goal is to have 4 RadEye for each Hazmat Squad.
- The RadEye PRD4 and PRD-ER4 Personal Radiation Detectors enable accurate dose rate measurements across the broader gamma spectrum, providing a greater assurance of personal safety. The neutron indication capability of the RadEye PRD4 provides an additional layer of detection critical to determining the level of radiation threat. (RadEye PRD4 and PRD-ER4 Personal Radiation Detector (thermofisher.com)

HEAVY TECHNICAL RESCUE

- The prolonged warm fall weather has continued to keep foothills crews busy with wilderness responses. During a recent foothills rescue, Station 16 personnel along with additional crews were able to aid multiple lost subjects out of the Sandia foot hills after sunset. Their continued readiness and investigative work prior to entering the field allowed for an efficient completion of finding and returning the lost party home.
- Station 7 was assisted by S2 to help free an individual who got their hand trapped between the blades of a tire cutting machine. The work of all crews resulted in the safe extrication of the patient with their hand intact. With machinery rescues, please remember that turning the machine off could complete the machines work cycle causing more harm. Also disassembling the machine screw by screw may be necessary to keep the patient safe despite prolonged extrication times.
