









## TOP 10 NON-MEDICAL CALLS









These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

**11/2 - Residential Fire:** AFR responded to a vacant residential home that was under renovation located at 820 Monte Alto DR NE in fire district 8. Fire crews arrived and reported a fully involved structure fire and immediately started defensive fire operations. Fire crews were able to extinguish the fire and protect the exposed homes in the area containing the fire damage to the home involved. AFR had 15 units respond to the fire.

**11/3 - Bosque Fire:** On Thursday November 3rd at approximately 4:23pm AFR was dispatched to the area of Central Ave and Sunset Rd in fire district 1 for reports of smoke coming from the Bosque. Firefighters from Station 1 and Station 7 arrived on scene and reported heavy smoke and approximately 6-8 ft flames coming from the area. Fire crews were able to establish a perimeter around the fire and successfully contain the flames from spreading. Multiple resources were utilized in order to quickly get the fire extinguished. A total of 1/4 acre was burned, no structures were damaged.

**11/5 - Residential Fire:** AFR responded to a residential structure fire at 1822 Alvarado Dr NE in fire district 13. Multiple citizens reported this fire to 911. A total of 10 AFR units were dispatched. Engine 13 arrived on scene to find a working structure fire at an abandoned single story duplex. Engine 13 entered the structure and was able to quickly extinguish the fire.

**11/7 - Commercial Fire:** AFR crews were dispatched to 1801 Mesa Vista Rd NE in fire district 3 for reports of a structure fire in a commercial building. The first AFR unit arrived within three minutes and reported significant fire coming from a three story residential structure. AFR initiated defensive operations because of collapse potential of the structure and extreme fire conditions. A second alarm was dispatched to assist with fire operations because of the potential of the fire to spread to other structures. The quick actions of crews on scene were able to contain the fire to the initial building, preventing further fire spread to nearby structures. A total of 18 units responded to the scene to get the fire under control. There are no reported injuries to civilians or firefighters.

**11/8 - Residential Fire:** AFR units were dispatched to 4108 Dietz Farm in fire district 10. Crews from Station 10 were first on scene and arrived to find flames and smoke coming from the kitchen windows from the rear of the house. Firefighters immediately made entry and identified the source as a grease fire that originated in the kitchen of the dwelling. Firefighters quickly began to attack the fire from the inside and had the fire under control within 15 minutes. All 5 residents self- evacuated and one person was transported to the hospital for minor burns and smoke inhalation. There were no injuries to firefighters.

**11/10 - Residential Fire:** AFR crews responded to a fire at 1952 San Pedro NE in fire district 13. Upon arrival Engine 13 found smoke coming out of a boarded up abandoned residential home. Firefighters immediately made entry and extinguished the fire that was contained to one of the rooms. There were no injuries to firefighters or civilians. The start of the fire is believed to be squatters that were not in the home at the time of the AFR's arrival.

**11/11 - Residential Fire:** AFR crews responded to a report of fire at 12216 Vienna Dr NE in fire district 16. Engine 16 was first on scene to find smoke coming out of the front door of the single-story family dwelling. Residents of the home were already outside when AFR arrived. Fire crews took a hose line in through the front door and quickly extinguished the small fire that was contained to the kitchen. There were no injuries to firefighters or to civilians.

**11/14 - Commercial Fire:** AFR was called out to a commercial structure fire at 109 San Pablo SE in fire district 5. When crews arrived they found a large detached shed on fire. Engine 5 was first on scene, and with the help of other crews they quickly established a water supply then stretched a hand-line and extinguished the fire within a few minutes. There were 12 AFR units with 34 personnel assigned to this event. After fire was under control, AFR crews found no extension to the main building. There were no injuries to civilians or firefighters.

**11/16 - Apartment Fire:** AFR units were dispatched to 12050 Candelaria Rd. NE in fire district 16 for reports of an apartment fire. The first arriving unit reported smoke showing from a second story apartment. A total of 12 units and 33 firefighters were on scene. The fire started in a chimney. Fire units were able to contain and extinguish the fire within 20 minutes. A total of four apartment units were displaced because of water and smoke damage.

**11/21 - Residential Fire:** AFR crews were dispatched to 1515 Silent Meadows SW in BCFD district 32 for a mutual aid single story structure fire. Upon arrival crews reported smoke and flames coming from the structure. Fire crews were able to gain control within 15 minutes. The home was reported to be vacant. After a primary search no occupants were found inside. No injuries to firefighters or civilians were reported.

**11/23 - Residential Fire:** AFR responded to reports of an outside fire at 12021 Skyline Rd NE in fire district 12. Engine 5 arrived on scene of a 2 story apartment fire and requested a first alarm. Engine 5 reported smoke showing from the attic. 17 AFR units responded to the scene. The structure was searched and determined to be clear of occupants. The fire was under control after approximately 45 minutes. All occupants of the building were displaced and assisted by Red Cross. No occupants or firefighter injuries were reported.

**11/25 - Commercial Fire:** AFR responded 1801 Mesa Vista Rd NE in fire district 3, for the second time in November, for reports of fire in the single-family two-story commercial structure. Engine 4 arrived on scene to find smoke showing from the South side of an abandoned building on the second floor. This building is a former fraternity house located on UNMH campus. Shortly after arriving, fire began to push from the windows on the second floor. Albuquerque Fire Rescue Crews were able to quickly bring the fire under control. There were no fire fighters or civilian injuries. Albuquerque Fire Rescue Arson Division were called out to investigate the cause of the fire.

**11/28 - Commercial Fire:** AFR was dispatched to 2913 Palo Verde Dr NE in fire district 8 for a residential structure fire. Upon arrival Engine 8 reported light smoke coming from the roof of a residential single story three-plex. After performing a full assessment Engine 8 declared a working structure fire with smoke coming from one of the units. Engine 8 along with Rescue 8 were able to gain entry into the occupancy and perform simultaneous search and fire control along with assistance from Rescue 16 and Engine 9. The fire was contained to the kitchen and extinguished. A total of 11 fire units were on scene to assist with fire operations. No injuries were reported to civilians or firefighters. The home owners will be displaced as a result of the fire, the cause of the fire is undetermined.

**11/30 - Residential Fire:** AFR was dispatched to 147 ½ Virginia St NE in fire district 5 for reports of a residential structure fire. Rescue 5 arrived on scene and reported a working fire in a small single story casita with smoke coming from the residence. Engine and Rescue 5 performed simultaneous search and fire control, extinguishing the fire within minutes after their arrival. A total of 9 fire apparatus were on scene to assist with fire operations. The homeowner was home at the time and was able to safely exit the house. As a result of the fire, the homeowner will be displaced and be assisted by the Red Cross.

1. *AFR Medic 12 officially went into service this afternoon after a push-in ceremony welcomed the new Rescue apparatus to Station 5. This truck will alternate calls with Rescue 5, our busiest Rescue in the City, and bring some relief to the neighboring fire stations who are utilized when Station 5 units are busy on other calls. This Rescue can also respond sooner than an out of district Rescue in the event that Rescue 5 is tied up on a separate incident. AFR is planning on adding another Medic Truck to the Central corridor in the future.*
2. *AFR Captain Brian Fox participated in the Atrisco Heritage High School Fall Career Fair as a high school ambassador for AFR. Several AHA students visited their table to access information about becoming a firefighter. Captain Brian Fox, along with 12 other ambassadors, are instrumental in building a bridge of communication to thousands of APS high school students who are interested in learning about a career with AFR.*
3. *AFR had the honor and privilege of hosting an honorary day in the life of a Cadet for Russell Leverett. Russell is the brother of the late AFR Paramedic Lieutenant Ben Leverett. Russell completed several aspects of what it is like to be in a fire academy and received a certificate of completion at the 99th Cadet Class graduation. Congratulations Russell!*
4. *AFR's Technical rescue program was approached to assist the ABQ Zoo with an urgent surgery for their Elephant Irene. Our technical rescuers along with Corrales FD and Rio Rancho Fire Rescue members gathered the necessary equipment and expertise to move a 8000 lbs elephant who was sedated and intubated. ABQ Zoo brought in a team of 37 experts from around the world to complete this low frequency surgery. It was a honor for our Technical rescue program to work with this amazing team that completed a textbook surgery.*



**FIRE MARSHAL'S OFFICE**

**INSPECTIONS DIVISION**

- After 23 years with AFR, Lieutenant Albert Herren has retired. Albert started his career in 1999 as a member of the 60th cadet class. He spent over 16 years as a member of the Fire Marshal's Office where he gained a considerable amount of knowledge that was invaluable to our office. We wish him well on his retirement and good luck in all his future endeavors.
- FMO has been out ensuring adequate radio coverage in businesses throughout the downtown area, in large scale businesses, and businesses with basements. Inspectors walk through the entire business with specially programmed radios to measure the signal strength. Any business that does not have adequate strength is required to put in repeaters. This ensures that our firefighters will not encounter dead spots in buildings during emergency responses.
- Congratulations to the inspectors that took the IFSAC Inspector II course this month. All passed and we now have almost 100% of our staff certified as Inspector I, II, and ICC accreditation.

**ADAPT**

- ADAPT has 153 properties that have been formally brought into the program, 86 have been cleared from the program and 67 are still in the program at different stages. ADAPT continuously monitors the properties that are in the program to track their compliance with the Nuisance Abatement Agreement.
- There are 136 properties on the Unsafe Buildings list. Three new properties were added to the list this month. The properties are labeled on the First Due application with a white "X" on a red background. In the field these properties are marked with a red spray painted "X" and the letters "AFR" under it.

**FIRE INVESTIGATIONS DIVISION**


- Investigator O. Vasquez completed APD’s Rifle School. This was a 5-day course and he finished at the top of his class.
- Investigator S. Nelson was promoted to the rank of Lieutenant. Congratulations to him and his family.
- On November 2nd, Fire Investigators responded to a two-story residential structure fire in the foothills. The home was being renovated and was deemed as a defensive fire upon the arrival of fire crews. Crews worked safely from the exterior to extinguish the fire and protect exposures.
- On November 7th, Fire Investigators responded to a 2nd Alarm fire near UNM Campus. AFR Fire Investigators worked with UNM PD and Investigators from the State Fire Marshal’s Office during this investigation. Fire Investigators continue to communicate with UNM PD and the remaining structure is scheduled to be demolished mid-December.
- On November 15th, Fire Investigators made an arrest in Northeast Albuquerque in connection to an arson investigation. A suspect was identified by investigators and taken into custody. Charges were filed, the suspect was booked and transported to the PTC.
- Fire Investigators received one set of lab results to confirm the use of an accelerant in a residential structure fire that is currently under investigation. This new piece of evidence will allow Investigators to pursue arson charges and possible insurance fraud.
- Multiple fires were investigated during the final days of November. This includes a fire that was started at Lowes near the rear of the store. On November 28th, Investigations was contacted by Lowes assistance manager with information that an individual was seen on surveillance video the night before. Fire Investigators responded to the scene and were updated by the store manager that the suspect had left the parking lot but was found and detained for questioning. The suspect did not admit to starting fire at the Lowes and stated he was at his tent in a nearby location the evening before. Surveillance video was reviewed while suspect was detained for questioning. Imaging on video was similar in appearance, but was not clear enough to positively identify individual to proceed with arrest.

- Hosted BH Committee Meeting.
- Met with new potential Peer Support team member.

**HEART**

- HEART provided 45 rides with its "Rides with HEART" rideshare service.
- Uber ride service pilot program for the EMS system, still ongoing 17 rides, providing alternative transport to a Rescue or Ambulance.
- The HEART Home Modification Program provided 40 home modification installation services. These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 37 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with "Leave Behind Narcan Kits" to provide to community members in need.
- Fentanyl Strips to Frontline units has been completed and supply will be ongoing.
- Buprenorphine Program- Inserting information for suboxone treatment in the LBN kits. Individuals will receive access to an app with counseling, cognitive behavioral therapy and contingency mgmt. Plus, monetary rewards for compliance. Will be an ongoing push.
- To date, the HEART BEATS stroke discharge program has received over 286 referrals for service. HEART is currently working with 61 patients in the program.
- Jacob and Athena presented at the 2022 CHW Conference.
- Lt. Sargent continues to build partnership with New Mexico Cancer Center and took Wrigley for a visit with patients and staff. Lt. Sargent has worked to establish consistent visits.

- Assisted with creating reports for ArcGIS (Esri) to be able to provide real time dashboards, revolving around specific Department measures, to AFR members as well as to the Citizens of Albuquerque.
- Assisted with an analysis of the efficacy of the ALS expansion pilot at E20 and E14. Looking at response times, time on task, interventions performed, code 3 returns, AFR ALS requests, number of calls, call types, and refusal percentages.

- The new application and recruitment website, abqfire.com, has launched and already has 300 new profiles that have been created.
- The last week of November was the 99th Cadet Class' EMS week. During this week, cadets who already are licensed EMTs are shown the specifics of AFR's EMS treatment and protocols. This prepares them to deliver the highest quality emergency medical treatment possible, immediately following graduation.

### QUALITY ASSURANCE

- The QA Division has completed Day 2 PECMO refresher with Station 3 personnel. Come December the QA Division is planning on implementing the third and final PECMO training which will involve a live scenario with an outlying station.

### SPECIAL OPERATIONS

#### HAZMAT

- AFR hazmat team assisted Homeland Security with an arrest/drug warrant. The purpose was for hazmat/rescue possible exposure of fentanyl or other drugs to officers while arrest. Arrest was a great success, they captured their person in question with over 25lbs of fentanyl. Rescue was only needed for the detainee who injured himself while trying to get away.

#### WILDLAND

- For the month of November, The Wildland Division was invited to participate, as an interviewer, in Valencia County's hiring process for seasonal wildland firefighters. Valencia County hired 6 additional personnel for the upcoming wildfire season, and we look forward to working with them in the coming months.
- The Wildland Task Force responded to multiple vegetation fires throughout the Albuquerque Metro Area this month due to the lack of recent precipitation, which was amplified by explosive vegetation growth due to the early monsoons.



### HEAVY TECHNICAL RESCUE

- AFR HTR program hosted the vehicle extrication component to the **Cadets Field Transition night**. Vehicle extrications are a more common response we encounter, and the modern vehicles, speeds and materials are posing new hazards for our rescuers. This station is designed to reduce the reflex gap for these new firefighters as they apply the process and skills of working as a team to solve these complicated problems. Great job to the cadets and staff solving these problems and welcome to the field!
- Four of the Technical rescue program's subject matter experts attended the 3-day **International Technical Rescue Symposium** with 200 of the greatest rescue minds from around the world. This limited seat symposium allows our instructors to advance their education and training to bring back the safe effective and efficient practices for our technical rescue response. Their additional efforts through these continuing education practices allows AFR to effectively provide our services for the citizens in the best practices and allows us to host more trainings in the most cost-effective high yield manner.
- A busy month in the open spaces of Albuquerque. Crews along with APD open space division maintain an effective response to those in need and notably in two critical responses this month. The first was a carry out of a patient who was stuck out in the mountains for 17 days with no food and minimal water. A citizen hero found him and carried him to a trail where he was able to get a hold of our SAR members and get him to the hospital. The second was a citizen who was able to get some kids who were in a precarious spot on a cliff. He rescued them with others and realized he was in a position with great consequence. They called for a rescue and APD open space along with AFR technical rescue was able to complete a high angle rope rescue quickly!



**FOC**

- The AFR FOC continues to work tirelessly to support staffing and fill vacancies for AFR’s field operations. The month of November saw an increase in members off sick, thus creating more vacancies most days. These vacancies were filled during the week with members working in the support division and on weekends by implementing mandatory overtimes for select members on a rotating list.
- November saw the implementation of recruiting field members to volunteer for a schedule change from the normal 48 hour work schedule to a 40 hour work schedule that covers four 10-hour shifts Thursday through Sunday. This allows the FOC to fill vacancies during the time of the week that experiences the most members taking time off during their normal duty shift. Eleven members volunteered for this assignment change. Having the increase in personnel (especially those able to upgrade to the next rank) enables the FOC to cover more of these vacancies and work to avoid larger disparities in our field response.
- The newly acquired FOC Lieutenant Clayton Vincent continues to learn the Telestaff system and work his shift, navigating all of the aspects of the FOC. As he continues to develop these skills and knowledge, he will work with the FOC Battalion Chief and the Deputy Chief of Operations to improve upon current systems and discern any areas where AFR can improve efficiency in the staffing of front line response.

**SPECIAL EVENTS**

- On Sunday November 13, AFR provided Advanced and Basic Life Support services as well as remote access capabilities (wilderness search and rescue equipment and personnel trained in this response) for the first annual Foothills Run put on by the Albuquerque Parks and Recreation department. Over 80 runners and dozens of volunteers and CABQ personnel participated in this inaugural event. AFR provided EMS coverage to ensure a safe event for all participating.
- The first of several post event After Action briefings was held with Albuquerque International Balloon Fiesta and participating public safety entities (AFR, APD, OEM for Albuquerque and Bernalillo, BCSO, BCFD, Parks and Rec, City Security, and several others) to discuss the 50th annual Albuquerque International Balloon Fiesta’s successes and opportunities for improvement. The implementation of a Unified Command Post was an overwhelming success. Each agency spoke to the improved efficiency and communication that expedited public safety response to incidents on the field and getting the appropriate resources needed for each event. A big thanks to the Bernalillo County Office of Emergency Management which was instrumental in erecting tents and a hub for all agencies to contribute specialty resources for each operational period. AFR looks forward to future opportunities to improve public safety for New Mexico’s largest event. Planning for the 2023 AIBF will be underway just after the New Year.


