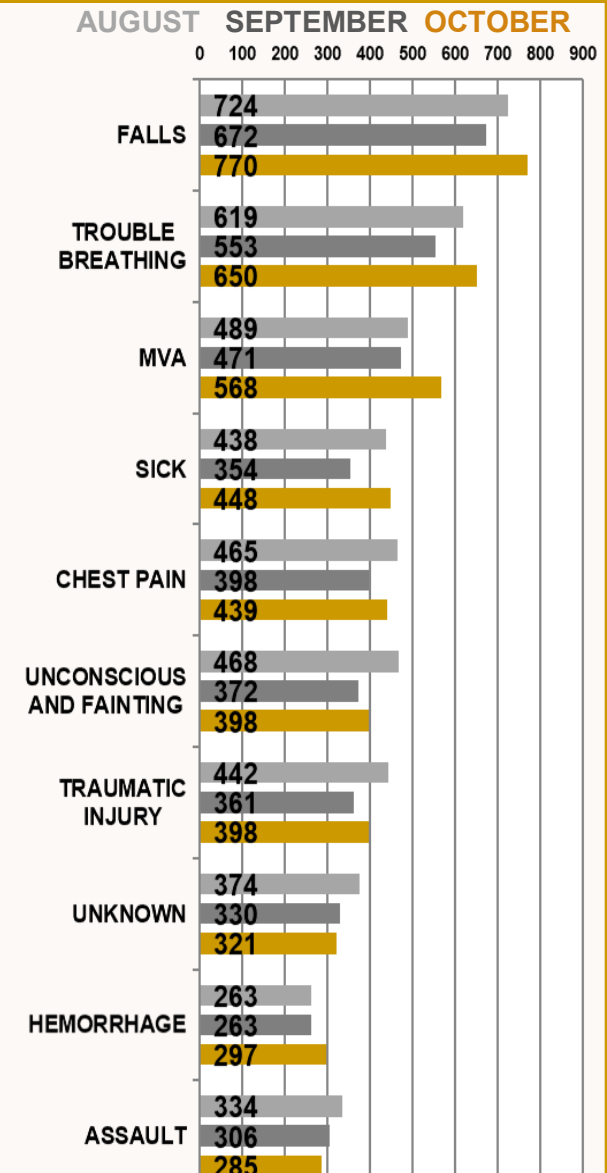

SIGNIFICANT EVENT ALERTS

These events are activated by the AFR Dispatch Center as a "Significant Event" and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

10/1 - Explosion: AFR crews were dispatched to the 12800 block of Central Ave NE in fire district 12 for reports of an explosion. Engine 12 arrived and found one of the units had experienced an undetermined explosion with two occupants involved. One was transported in very stable condition to UNMH. No other injuries to civilians or firefighters. The cause was determined to be accidental.

10/9 - Residential Fire: AFR responded to a single-family residence on the 4800 block of Larchmont Dr. NE in fire district 16 with reports of smoke coming from the roof. Engine 16 was first on scene where they found a small fire in the attic. They were able to pull a section of ceiling from inside the home and quickly extinguish the fire. The residents were out of the structure and no injuries were reported.

10/17 - Apartment Fire: AFR responded to a fire at a 3 story apartment complex located on the 4200 block of Louisiana Blvd NE in fire district 15 for reports of a fire. Engine 19 was the first unit on scene and reported smoke and flames coming from the second floor. Firefighters made entry and contained the fire to the apartment of origin and extinguished it. The fire was called in by building occupants who were alerted from the building's smoke detectors. Four families have been displaced due to the fire and the cause is unknown. No injuries were reported.

10/18 - Residential Fire: AFR responded to a single story residential structure fire located on the 1100 block of Tomas St SW in fire district 14. Engine and Rescue 14 were the first units on scene and reported heavy smoke coming from the house. Crews made entry to search for occupants and extinguished the fire before it could spread any further. A neighbor reported the fire and alerted the occupants to evacuate. The smoke detectors in the house were reported to not be working. A dog is deceased despite resuscitation efforts by AFR crews. No injuries were reported.

10/26 - Residential Fire: AFR responded to reports of a possible structure fire on the 6100 block of Canis Ave. NW in fire district 22. Crews arrived on scene to a single story residence with smoke and flames coming from the front window. Firefighters were notified that the occupant was out of the house but there was possibly a dog still inside. Crews quickly made entry to extinguish the fire and search for occupants. The dog was quickly located in the backyard and taken to safety. The fire was contained to the front room and garage. The cause is unknown and there were no injuries reported.

10/27 - Apartment Fire: AFR was dispatched to a possible apartment fire on the 8900 block of Northeastern Blvd. NE in fire district 9. Engine 16 arrived to find heavy black smoke coming from a second-story apartment. Firefighters quickly pulled a hose line into the second-story apartment and found a fire in the kitchen. Firefighters found no occupants inside and were able to rescue a cat. Crews evacuated all adjacent

apartments. The fire was contained to the kitchen. One occupant was treated for smoke inhalation and transported to UNMH by Rescue 9. It appeared that smoke detectors were not operable in the apartment. The apartment below suffered water damage. The occupants of both apartments were displaced but management was able to relocate them to other apartments in the complex. Other than the one female who was transported there were no injuries to occupants or firefighters.

10/31 - Residential Fire: AFR responded to a single story residential home on the 200 block of 55th street NW in fire district 7. Fire crews arrived to find light smoke coming from the home. Swift efforts of firefighters found a female and her infant in the house and quickly got them to safety and transported to the hospital for smoke inhalation, but appeared to be doing ok. They will be displaced from the home. It appears the fire started in the kitchen and the house has significant smoke damage throughout. There were no other injuries to occupants or firefighters. The cause of the fire is unknown.

After her assignment at the Academy, Shanda spent several years at Rescue 19 and then was assigned to Rescue 22 and became Wildland Certified. Shanda has served her fellow firefighters with passion as an Instructor and in the field serving the community as a Paramedic. Thank you Shanda for your dedication to AFR and the community. ALBUQUERQUE FIRE RESCUE STATION 9 UPDATE

New AFR Station 9 is officially open! Crews moved in October 22, 2020 and will be staffed with a Rescue, Engine, and Ladder apparatus. Deputy Chief Adam Eakes and Lt. Shawn Baxman worked closely with the architects and contractors to ensure the standards of AFR were met in every phase of the build. This station incorporates the latest in technology and building materials to improve functionality as well as safety to the firefighters that work here. Ladder 9 is the first ladder truck to be positioned east of Wyoming Blvd. in the history of AFR and will significantly increase response times to areas in the heights and foothills. Thank you to Vigil & Associates, TA Cole and Sons, and Councilor Diane Gibson for your contributions and support! We are honored to be able to serve our community from new Station 9 while providing a safe and functional home for our dedicated firefighters.



FIRE MARSHAL'S OFFICE***FIRE INSPECTIONS***

- Inspections- 561
- COVID Compliance Interactions- 268
- The Fire Marshal's Office has begun to approve permits and conduct inspections for New Mexico's movie industry. It is nice to see this vital industry to our economy begin to resume productions.
- Our office is constantly monitoring changes to the Public Health Order and ensuring that businesses comply. FMO, along with many other city entities, has collaborated over the past two weekends on a city-wide initiative to help mitigate the virus's spread.
- With the cold weather upon us, Albuquerque's restaurants have been looking for ways to continue the use of their temporary outdoor dining. Working with Plans Checking, we've been able to develop guidelines regarding enclosing tents and the use of heating devices. Inspectors are ensuring a safe environment for the public in these locations.

PLANS CHECKING

- Total Inspection – 67
- Total Plans Reviewed – 132
- The Plans Checking Division is working closely with Ben E Keith Foods of New Mexico to open up their 300,000 sq. ft facility on Albuquerque's west side. The new food distribution center has a state-of-the-art ammonia refrigeration system. Plans Checking also performed a final inspection on the Fire Pump and ESFR sprinkler system at this facility. Ben E Keith Foods of New Mexico will be creating 90 new jobs in Albuquerque.
- Outdoor Dining
 - * Due to the upcoming weather change, FMO sent a reminder that enclosed outdoor tents are considered indoor dining. The occupancy percentage is for current Covid-19 guidelines regarding indoor dining. Heating devices with open flames, propane tanks, or any other unapproved devices in or under tents, will not be allowed.



AFR DIVISION UPDATES

ADAPT

- ADAPT has 61 properties in the program, 23 cleared, and 38 are still in the program at various stages. ADAPT continuously monitors the properties to track their compliance with the Nuisance Abatement Agreement.
- There are 58 properties on the Structurally Compromised list. Two new properties were added to the list this month. The list is in Target Solutions file center under the FMO > ADAPT tab.
- The Crime Only Properties Program has made significant progress over the past three months, and one hundred sixty-seven properties qualify. We completed all of the initial program development and Crime Prevention Specialist training. APD Crime Prevention Specialist are diligently working to verify each police report associated with all 167 properties. They have reviewed 49 properties, and 24 meet the program criteria. ADAPT sent letters to the property owners, and three inspections were scheduled.
- On 10/26/2020, ADAPT, Plans Checking, and FMO, assisted Code Enforcement (CED) at 12899 Central Ave. NE, Four Hills Studios, started the process of relocating over 60 residents who did not have heat and were faced with freezing temperatures from the winter storm. Assistance was offered by the City through Hope Works to provide temporary housing, and the property owner was able to secure two hotels. ADAPT and CED are continuing to ensure that all residents, who do not have heat, are relocated until the gas is restored to the property and passes an inspection.
- ADAPT completed an audit of the 420 properties involved since the program started last year. The purpose of the audit was to ensure that we are taking the necessary steps to address the properties' issues and identify properties that do not fit our criteria are referred to the proper City Department.

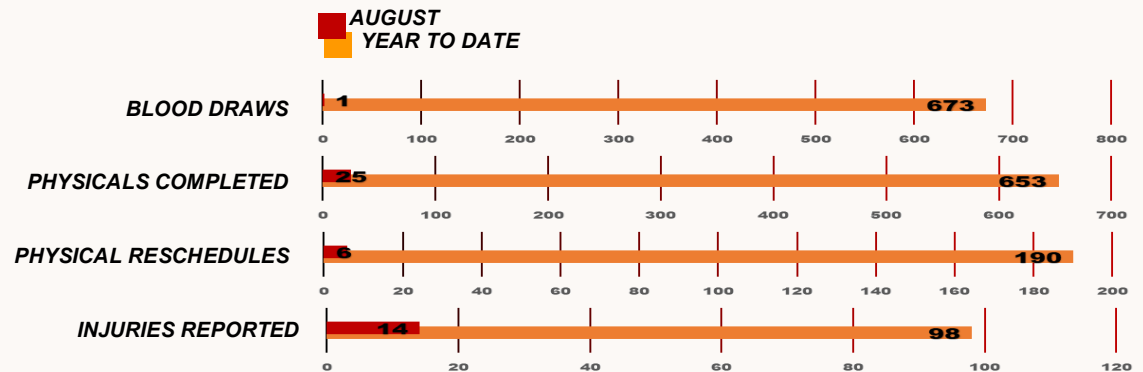
FIRE INVESTIGATIONS DIVISION

Eric performed exceptionally well throughout the exercise, and he learned in a safe and controlled environment.
- We made improvements to the Fire Investigation Division trailer with more tools and a "Rhino" liner floor sealer.
- Lieutenant Schuetze, Investigator Gunderson, and Wheezy attended a Fatal Fire Investigation class in Roswell, NM. Students came from all over New Mexico for the two-day course. Some of the topics included processing a fatal fire scene, photographing the scene, and working with the Office of the Medical Investigator.
- Captain Martinez attended a Zoom meeting with UNM law students to help them prepare for a mock trial based on an arson case. It was a Q&A format that took the place of the scheduled in seat trial due to Covid-19.

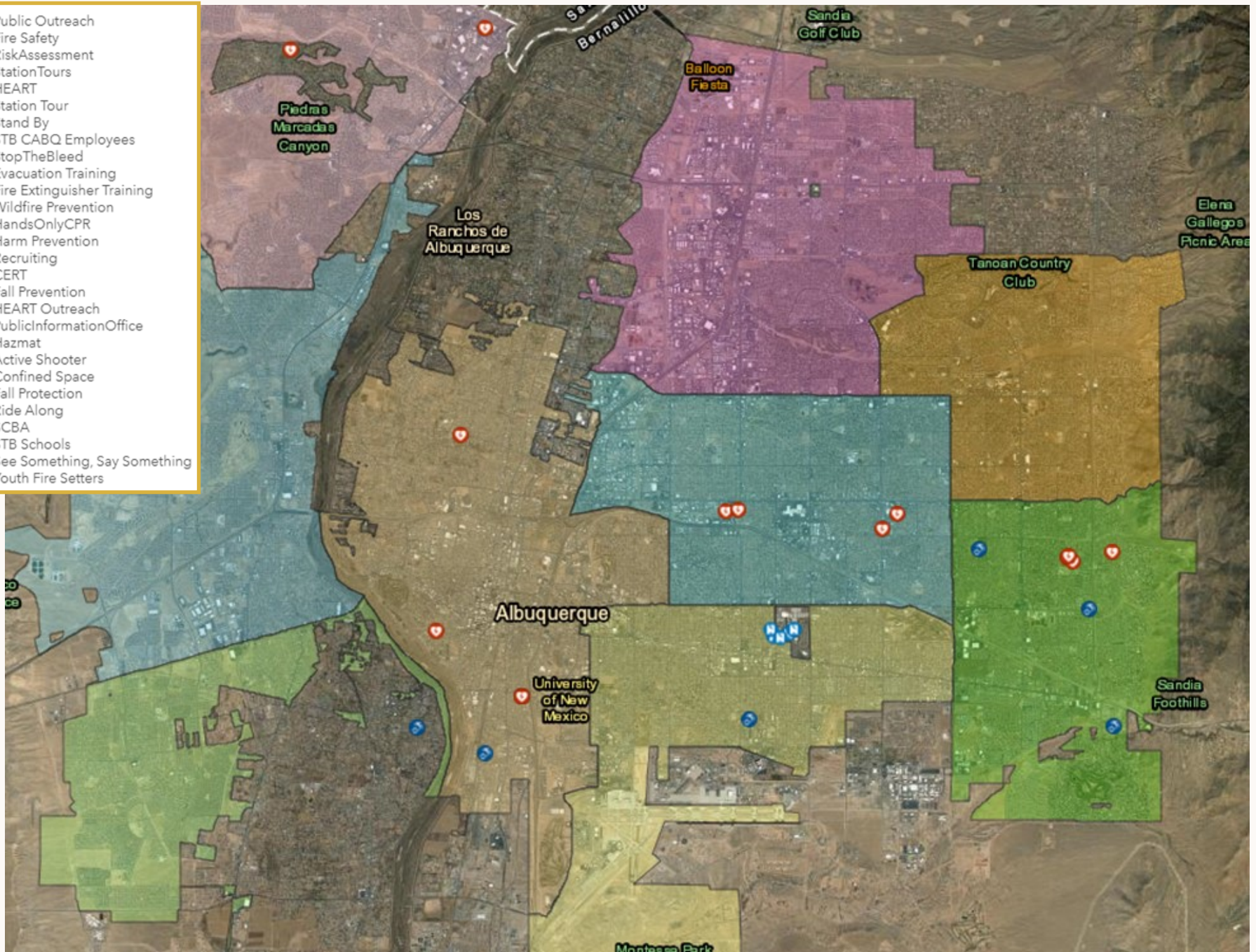

TRAINING AND COMMUNICATIONS

TECH SERVICES DIVISION

- Tech Services distributed cell phones to each AFR frontline unit. The new phones provide our crews with an additional communication tool and assist with daily vehicle/equipment inspections.
- We completed the VOIP Phone upgrade/install and PC Refresh at Station 16 and Station 9. Station 12 will receive the next upgrade.
- The REACT password reset tool is not working correctly. Members needing their password reset can contact Tech Services or City IT directly. City IT will be rolling out a new tool in the next month.
- Tech Services has exchanged over half of the MDTs and sent them back to the factory to address connectivity issues. We plan to have this process completed by the end of the year.

ALARM ROOM

- 84,330 priority responses created January 1, 2020 – October 31, 2020.
- The Alarm Room staff processed a total of 16,212 incoming calls in October.
 - * 8,573 emergency calls received
 - * 7,639 non-emergency calls
- We had a 4,697-incident dispatch reduction for the same time last year.
- 911 calls answered in an average of 6 seconds.
- AFR Dispatch Center has been pre-screening 911 calls for Coronavirus since March 2020.
- 24 Alarm Room personnel were recertified in EMD and EFD.
- New tabs added to MDTs status screen to help eliminate unnecessary radio traffic.
- Keywords are now highlighted to assist field personnel in identifying critical information quickly.
- The Alarm Room Captain is continuing station visits on all three shifts disseminating information from the completed Alarm/Field Questionnaire.

- Instructors from LANL provided AFR members a 5-hour radiation class. The radiation class consisted of an in depth understanding of radiation and hands on training with our new FLIR identiFINDER monitor.

HTR

- The continued COVID distancing is keeping the foothills crews busy with (5) foot hills rescues this month and many more happening in the areas surrounding Albuquerque.
- The current AFR cadet class completed their vehicle extrication course with the HTR program. 16 AFR field crews joined the extrication week completing a refresher and fine-tuning techniques with their equipment such as a 'butterfly' dash roll.
- AFR cadets also completed their flood channel rescue course with crews as they turn down the home stretch of their training.

- AFR assisted with a rolled over semi near Edgewood NM. The extrication involved multiple agencies and took over 5 hours. Crews slowly dismantled the apparatus cab around the conscious occupant and required the heavy lift of the wrecker to enable safe access to the patient.
