




AFR UNITS ABOVE 110% CFAI THRESHOLD

These events are activated by the AFR Dispatch Center as a "Significant Event" based on specific criteria and emailed to media and specific AFR members but does not include all responses by AFR to emergency calls.

- 10/2 Residential Fire: AFR responded to a residential structure fire located at 1817 Paige NE in fire district 8. Upon arrival AFR crews noticed that there was an active fire working in the space between the roof and the house, which made for difficult access. There was a total of 9 units and 22 firefighters needed to fight this fire. There were no injuries to fire fighters or civilians.
- 10/2 Commercial Fire: AFR responded to a commercial structure fire located at 1016 3rd street NW in fire district 4. AFR firefighters from fire station 4 were first on scene and reported smoke and flames coming from the building. Station 4 firefighters had the fire under control within minutes and extinguished the fire completely within 10 minutes. The building was searched and there were no occupants in the structure at the time of the fire.
- 10/3 Residential Fire: AFR responded to a residential structure fire located at 232 Utah NE in fire district 5. The fire was started due to a outside yard fire that eventually spread to the truss and roof space of the home. The occupants of the structure at the time of the fire were not harmed. AFR had 9 units on scene that were able to extinguish the fire and save the home. There were no injuries to firefighters or civilians.
- 10/3 Residential Fire: AFR was dispatched to 525 Mesilla St SE in fire district 5 for a residential structure fire. Upon arrival, Engine 5 declared a working structure fire with smoke showing from the rear of the single story 4-plex. Engine 5 along with Rescue 5 were able to gain access into the structure and perform a simultaneous fire attack and search. Fire was quickly brought under control with minimal damage to the home. Additional units on scene performed ventilation operations and ensured that the fire did not spread to the adjoining apartment. One civilian on scene was evaluated by EMS personnel and declined transport to the hospital. Two cats were later safely found in the house following a secondary search of the apartment. Fire investigators were called to the scene, the cause is not known at this time and is under investigation. No injuries were reported to firefighters.
- 10/11 Commercial Fire: AFR crews were dispatched to 619 Old Coors Rd. SW in fire district 7 for a reported commercial structure fire. Upon arrival fire crews reported smoke coming from a restaurant. Fire was in the area of the electrical panel and was quickly extinguished. There were no injuries to firefighters or civilians.
- 10/12 Commercial Fire: AFR crews were dispatched to 4801 San Mateo Blvd. NE in fire district 19 for reports of a commercial structure fire at a storage facility. Rescue 19 and Engine 13 arrived on scene and reported smoke showing from several of the 10ft x 10ft storage units. Additional fire crews arrived on scene and assisted with fire operations. Firefighters were able to gain access into the 8 total storage units that were affected by smoke and flames and successfully extinguish the fire. The unit of fire origin is a total loss, while the 7 other units were affected by smoke. A total of 13 fire apparatus were on scene to assist with fire control. No injuries were reported to civilians or firefighters, the cause of the fire in unknown.
- 10/20 Commercial Fire: AFR responded to 5010 Cutler Ave NE for reports of a commercial structure fire at a strip mall. Crews forced entry into the business and quickly extinguished a fire where food had been burning on the stove. The property and adjoining businesses sustained no damage due to the fast acting efforts of the eleven units that responded to the event. The property was released back to the care of the owner.
- 10/26 Residential Fire: AFR crews responded to a residential structure fire located at 3023 Aliso Dr NE. Fire crews arrived on scene and reported heavy flames and smoke coming from the structure. Fire crews were able to get the fire under control but the home did have heavy fire and smoke damage. A neighbor across the street called 911 and was able to assist an elderly man out of the home. Both residents that live in the home were safely evacuated but will be displaced due to the damage of the home.
- 10/25 Residential Fire: AFR units were dispatched to a fully involved structure fire at 451 Wisconsin St NE in fire district 5 to a multi-family two story apartment building. The apartment building had four units, two upstairs and down stairs. The fire originated in one of the upstairs units and spread to the other upstairs units. The two upstairs unit were a total loss and the lower units sustained some smoke a water damage. The were no injuries to firefighters or civilians reported on this incident.

- 1. AFR and IAFF Local 244 presented the UNM Pediatric Hematology and Oncology clinic with a check for \$5,000 from money raised during our Childhood Cancer Awareness Month t-shirt sales! We are thankful to have the opportunity to visit with the kids throughout the year and have a small part in making their day a little brighter.
- 2. AFR would like to thank the CEC for allowing E-4 A-Shift to show some tools and equipment to the students in the EMT Basic class.
- 3. Engine and Rescue 14 visited Mary Ann Binford Elementary School trunk-or-treat event on Halloween day and joined other agencies to help pass out candy collected by the school to hundreds of costumed children.
- 4. After a 2 year hiatus due to the pandemic, Albuquerque Fire Rescue Station 3 and UNMH have begun training sessions for the Prehospital ECMO (PECMO) program. PECMO is a heart and lung bypass procedure performed in the field by UNMH critical care physicians using AFR paramedics and EMTs as first assistants. The first of its kind programs mission is to provide better outcomes for patients experiencing sudden cardiac arrest. We are anticipating to go live again in January of 2023.
- 5. AFR firefighters Matt Watkins, Jesse Davis, and Geoffrey Smelser brought home the 2022 Fire Muster first place traveling trophy. Firefighters David Cruz, Brian Fox, Tim Jonas, and Aaron Garcia also placed first in the over 40 division. Congratulations! This IAFF Local 244 event involves fire departments from across New Mexico and raised money for the IAFF 244 Survivor Fund.











FIRE MARSHAL'S OFFICE

INSPECTIONS DIVISION

- The many months, weeks, and days of preparation leading up to the 50th Albuquerque International Balloon Fiesta ended with a successful event. The Fire Marshal's Office had personnel assigned to every session to help ensure a safe event. The weather did create some interesting evenings but only one fireworks display had to be canceled due to wind. This year's increase from 9 to 21 gas mines, steel tubes filled with gasoline which were ignited at each fireworks display, were a huge success. FMO has had numerous meetings with other city agencies to learn from this year's AIBF and continue improving for years to come.

ADAPT

- ADAPT has 152 properties that have been formally brought into the program, 86 have been cleared from the program and 66 are still in the program at different stages. ADAPT continuously monitors the properties that are in the program to track their compliance with the Nuisance Abatement Agreement.
- There are 123 properties on the Unsafe Buildings list. Seven new properties were added to the list this month. The properties are labeled on the First Due application with a white "X" on a red background. In the field these properties are marked with a red spray painted "X" and the letters "AFR" under it.

FIRE INVESTIGATIONS DIVISION

- On October 18th, Fire Investigators responded to a multi-family residential structure fire to determine the origin and cause of the fire. This was a second alarm fire response by AFR crews. Fire crews did an excellent job of containing and extinguishing the fire.
- On October 20th, Fire Investigators responded to a single-family residential structure to determine the origin and cause of the fire. Fire crews reported suspicious findings within the structure. Fire Investigators located multiple burn patterns throughout the home. Samples were collected from the home to test for accelerants. Fire Investigators are working with the Office of Superintendent of Insurance (OSI) during this investigation.
- On October 24th, Fire Investigators responded to a structure fire in the North Valley. A suspect was identified and believed to intentionally set the home on fire. The suspect fled the home and continued on a crime spree throughout the morning. Police activity continued through the morning with same suspect. Fire Investigators contacted BCSO and relayed pertinent information about suspect and possible felony arson charges. The suspect was apprehended later that morning and taken into police custody.
- On October 28th, Fire Investigators responded to a fire adjacent to a commercial structure. According to witnesses, a male subject wearing a safety green jacket, black pants and black hoodie, was seen starting the fire behind the commercial business. An APD marked unit assisted in searching and detaining an individual meeting the description. Upon Fire Investigators arrival, investigators did mirandize and interview this individual while on scene before suspect was taken to PTC for processing by APD.
- Investigator O. Vasquez was accepted into APD's Rifle School which will begin mid-November.

- Attended and hosted BH committee meeting.

HEART

- HEART provided 48 rides with its "Rides with HEART" rideshare service.
- Uber ride service pilot program for the EMS system.
- The HEART Home Modification Program provided 43 home modification installation services. These home installations included grab bar installations and ramp building in order to prevent falls.
- HEART received and processed 56 referrals for service. The patients were processed and moved into one of our many programs.
- In a partnership with the Office of Substance Abuse Prevention HEART provided all AFR Stations with "Leave Behind Narcan Kits" to provide to community members in need.
- Fentanyl Strips to Frontline units has been completed and supply will be ongoing.
- Buprenorphine Program- Inserting information for suboxone treatment in the LBN kits. Individuals will receive access to an app with counseling, cognitive behavioral therapy and contingency mgmt. Plus, monetary rewards for compliance. Will be an ongoing push.
- To date, the HEART BEATS stroke discharge program has received over 260 referrals for service. HEART is currently working with 63 patients in the program.
- Fall Prevention Program presented at the International Round Table on Community Paramedicine in Orlando, Florida.
- HEART BEATS Program presented at the International Round Table on Community Paramedicine in Orlando, Florida.
- Sent two HEART members to the civic plaza for the "Albuquerque Celebrates Recovery on the Plaza".
- Be Brave Fall Prevention Classes taught at Manzano Mesa Community Center Senior Center and at the AFR Fire Academy. Great turnout!
- Provided support fill for frontline units.

RECORDS MANAGEMENT

- Monthly Training: Completing an EMS report in ELITE for patients on Non-EMS dispatches (EFD codes 50-80).
- We are assisting with creating reports for ArcGIS (Esri) to be able to provide real time dashboards, revolving around specific Department measures, to AFR members as well as to the Citizens of Albuquerque.
- Working with BC Lopez on increasing data points being tracked on structure fires (rescues- location of rescue, 360's performed, basements and benchmark times). These metrics will allow AFR to more accurately track data to make evidence base decisions to improve the efficiency and safety of AFR's structure fires responses.
- Working with AFR Tech to have the AFR EMS and Fire Documentation manual and a timer for use on EMS calls (codes, active labor, etc.) on all new MDTs.
- Assisted with an analysis on the efficacy of the ALS expansion pilot at E20 and E14. Looking at response times, time on task, interventions performed, code 3 returns, AFR ALS requests, number of calls, call types, and refusal percentages.
- Provided Bernalillo County's Department of Behavioral Health Services- Harm Reduction (DBHS) with data revolving around Naloxone administration. The efforts are aimed at reducing environmental and public nuisance harms and promote an overall safe community. With the data, DBHS collaborated with the GIS Department to develop a Naloxone response layer to the Needle Mapping page.
- Assisted with updating the City of Albuquerque's Board of Commission meeting agendas and minutes.
- · Updated several EMS guidelines.
- Took over the processing of payments for all EMS transports.
- Assisted with data revolving around key performance indicators for AFR down town response.
- Provided support fill for frontline units.
- Continued conducting RMS station visits educating crew on available resources, how to mitigate common issues with ImageTrend, answering questions, receiving suggestions for improvements and talking about current projects the division is working on.
- Continued to track data revolving around hospital drop time averages, means and 90% to assess the impact on the EMS System.
- Continued to assist with tracking and analyzing data revolving around the Cerebral Oximetry research study AFR is participating in.
- Continuing to trend data revolving around AFR Transports by unit and EMD monthly and YTD.
- Continuing to trend data revolving around Naloxone Administration, Overdoses, and EMS death response.

EMS TRAINING

- The primary focus of our division this month has been wrapping up our Fall
 MOTU training. This is the final in person training this year and covers several
 protocol updates that will be implemented at the beginning of next year. It is
 always a challenge to deliver in person training to every AFR member, but we
 are almost there. Makeups for this training are ongoing and will be completed by
 mid-November.
- The division filmed and edited multiple training, social media, and ECG interpretation and treatment videos this month.
- Work on the new application and recruitment website is continuing and is progressing nicely.
- The Training division worked closely with CNM to get AFR members applications processed for the upcoming Paramedic Degree program. The final selections for that program are happening now, and we should know how many AFR applicants are accepted in the next few weeks.

SPECIAL OPERATIONS

HAZMAT

- AFR Hazardous Materials Coordinator had a large role in the Balloon Fiesta Gas race. The responsibility was attending daily meetings with the Gas Race committee and to ensure safety of operations for launching, scheduling the crews for standby, and keeping AFR up-to-date on status.
- AFR hazmat team was able to be part of the PRND (Preventive Radiological/ Nuclear Detection. AFR teamed up with personnel from different organizations throughout the state and country for radiological detection. There were threewoman/man teams carrying radiological detection, their job was to walk amongst the crows at balloon fiesta and detect if any radiation was in the area. It was huge for AFR to participate, AFR personnel were able to get first hand radiological training from experience personnel.
- Assisted State Fire academy with teaching Hazmat Awareness and Operations to Sandoval Fire Cadets. AFR hazmat coordinator was teaching decontamination operations and procedures as well as hazardous materials vehicle identification.

WILDLAND

- For the month of October, the Wildland Division hosted the Wildland Engine Academy, and the 99th Cadet Class Wildland Week. The Wildland Engine Academy curriculum consists of; S-211, Portable Pumps and Water Use, BL-300 Fire Vehicle Driver Orientation, & N9018 Engine Operator. The Cadet's Wildland week consists of all required training to become an entry-level Wildland Firefighter.
- The Wildland Division also participated in a Wildfire Discussion Panel hosted by The Electric Power Research Institute (EPRI). This Initiative, Climate READi; Power (Resilience and Adaptation initiative) will enable global energy companies, climate scientists, regulators, and other stakeholders to proactively analyze and apply climate data, allowing for the planning, design, and operation of resilient energy systems of the future.





HEAVY TECHNICAL RESCUE

- AFR HTR program along with the academy staff held our Vehicle Extrication course for the cadet class. HTR Instructors, Task force members and academy instructors provided an environment for the upcoming firefighters to safely stabilize, access, and remove victims from vehicle accidents. Alongside the cadets AFR field crews were able to refresh their critical skill sets and learn the limitations of the tools assigned to their trucks. HTR instructors also update crews on changes in vehicle design and manufacturing as they are getting stronger and making it more difficult for our access with our tools. At the same time the new designs from manufactures are making it safer for the occupants involved in the class.
- A team from the HTR task force was able to train and participate in an
 emergency response scenario with Torrance County OEM and Fire department,
 UNMH Lifeguard, and The El Cabo Wind farm. This exercise allowed access
 and training to a unique rescue environment 300' off the ground and in a
 confined space. The wind industry is growing in this area and this exercise
 allowed for joint operations and our members to advance their education and
 training to response anywhere any time.





STAFFING

In December, when the 99th Cadet Class graduates, the rookie firefighters will
enter the field and provide some much-needed staffing relief at the firefighter
rank. In addition to this, as the AFR Driver's Academy graduates more
firefighters certified to drive fire department vehicles, the Field Operations
Center will have more personnel to fill vacancies throughout the ranks.

FOC

- October saw some changes in the AFR Field Operations Center. We began our
 pilot in implementing an officer in one of the FOC positions. Lieutenant Clay
 Vincent was selected to learn the FOC operations. He is tasked with refining our
 current practices to determine where the system has inefficiencies and apply
 more consistency across the board in FOC practices. This will aid in allowing
 members to understand scheduling and pay coding. It also enables the FOC to
 produce and work from job aides that will lessen the potential for errors.
- The month of October was also the beginning of our pilot program to disallow removal of vacations on the calendar inside of 3 days from the projected date. The idea behind this initiative is to create an atmosphere where projecting vacancies and setting the schedule in advance for FOC personnel will be easier with less opportunity for disruption of staffing in the field.

SPECIAL EVENTS

• Balloon Fiesta: AFR provided Fire/Life Safety and EMS for the 50th annual Albuquerque International Balloon Fiesta. Overall, the event was a success. The Fire Marshal's Office provided pre-event and onsite coverage to ensure that vendor operations and spectator safety was paramount. AFR provided Advanced Life Support coverage for EMS throughout each major event at the Fiesta to include standby units during off hours. There were multiple calls for service within the park that ranged from medical emergencies to traumas to coordinating with our police partners in reuniting lost children with their families. The challenge of sudden changes in inclement weather tested the response capabilities of AFR and our partners in a Unified Command Post to react and provide for spectator safety while maintaining composure and EMS responses twice toward the end of the week. AFR looks forward to many more years of successful partnerships at the AIBF. We will continue to collaborate with our public safety partners to provide industry-best practices for large scale outdoor events like this.




