



**9/1 - Apartment Fire:** *At approximately 12:17pm AFR was dispatched to 1515 Columbia Dr SE in fire district 2 for reports of a structure fire at a two-story apartment complex. Engine 2 arrived on scene and reported a working structure fire with heavy smoke and flames coming from the 2nd story of a large apartment building. As additional fire units arrived on scene, E-2 called for an urgent rescue profile as one occupant was on the 2nd floor balcony and was in need of rescue. At that time Rescue 2 along with Engine 2 deployed a 24 foot extension ladder to the balcony and rescued the occupant from the apartment that was quickly filling with smoke. Additional arriving fire crews including Engine 11, Engine 3, and Engine 1 began interior fire attack operations along with a search of the apartment building. One occupant that was suffering from smoke inhalation was taken from the backside of the apartment building and assessed by EMS personnel on scene. As fire crews were conducting fire control and as 40 foot fire flames were visible through the roof, the call was made to switch to a defensive operations. An all clear of the structure was determined and fire crews then proceeded to extinguish the fire utilizing exterior hand-lines. Ladder 5 assisted with fire operations. The apartment building sustained heavy damage as a result of the fire and subsequent smoke from the fire. A total of 24 apartments were affected and 31 occupants have been displaced. There were a total of three patients on scene. One patient was transported to a local hospital for a hand injury, two other patients were evaluated on scene and refused transport to the hospital. A total of 65 fire personnel were on scene to assist with fire operations, no injuries to firefighters were reported.*

**9/1 - Apartment Fire:** *AFR responded to a two story apartment complex, Telegraph Hill Apartments, located at 7000 Louisiana NE in fire district 15. E-20 was first on scene and arrived to find smoke and flames from the north east corner of the apartment complex. Firefighters jumped into action bringing the fire under control within 15-20 minutes of arrival. A 28 year old male was transported to Lovelace Women’s hospital for non-fire related injuries. A 16 year old female was also in the apartment at the time of the fire, she had no injuries and self evacuated. The apartment was a total loss and there was minor fire extension into the neighboring apartment. There were no injuries to firefighters and the cause of the fire is unknown at this time.*

**9/6 - Residential Fire:** *AFR crews were dispatched to a single family residential home on Zearing and 23rd NW in fire district 4. Engine 10 was first on scene to find smoke and flames coming from the abandoned home. Firefighters quickly brought the fire under control within several minutes of arrival. The house was a total loss. Apparently, this home has been boarded up multiple times. There were no occupants inside at the time of the fire and there were no injuries to firefighters.*

**9/6 - Residential Fire:** *At approximately 3:30 am AFR crews were dispatched to a single family residential home located at 2729 Bel Air NE in fire district 13. Engine 13 was first on scene and reported a garage fire that was fully involved. The vehicle in the driveway was also on fire. The second arriving unit, Engine 19, conducted a search of the home and found a dog. Crews quickly got the animal to safety. The homeowner had already self evacuated. Swift efforts from firefighters stopped the fire from entering the home and it was contained to the garage and extinguished within minutes of arrival. The home, however, did sustain heavy smoke damage. According to the occupant, she was awakened by her dog barking and quickly got out of the house. There were no injuries to firefighters, civilians or the canine.*

**9/13 - Residential Fire:** *AFR units were dispatched out to 6605 Lockhaven Ln. NE in fire district 16 to a possible structure fire. Upon arrival, Engine 16 and rescue 16 saw smoke and flames coming from a garage. With a possible extension to a balcony Engine 16 made a quick attack on the fire in the garage and had the fire under control within six minutes. There were no other structures involved. There were no injuries to occupants or firefighters.*

**9/19 - Residential Fire:** *AFR crews were dispatched to a working fire at 6005 Rio Pueblo Dr. NE in fire district 18. AFR crews arrived on scene to a small single story residential structure with heavy black and brown smoke coming from the garage. All occupants self evacuated prior to AFR arrival. Engine 18 made entry into garage and were able to get the fire under control. Rescue 18 obtained an all clear and rescued 1 cat and 1 dog. Ladder 17 driver administered oxygen to both pets and was able to revive at least one of the animals.*

**9/25 - Commercial Fire:** *AFR crews were dispatched to 105 Veranda Rd. NW in fire district 6. A civilian called 911 to report a fire. Upon arrival Engine 4 reported smoke and flames coming from the north side of an attached building to a commercial structure. The fire was brought under control within one hour. Fire crews were able to contain the fire to the attached building and save the commercial structure. There were no reported injuries.*

**9/25 - Residential Fire:** AFR crews were dispatched to 201 Utah St. SE in fire district 5. Reports of a working single-story residential structure fire came in. Ladder five was first on scene and described smoke and flames projecting from the structure. The structure had a basement and it was reported that there were occupants inside. Upon a primary search it was discovered that no one was inside. With precise and aggressive fire fighting, it took crews only 15 minutes to get the fire under control. The structure was abandoned and boarded up. Code enforcement was notified to secure the structure. No injuries to civilians or firefighters were reported.

**9/27 - Residential Fire:** AFR crews responded to a residential structure fire at 5174 Golondrina NW in fire district 18. Upon arrival AFR crews discovered an active structure fire with heavy smoke and flames coming from the home. The fire crews performed a transitional attack and forced entry into the home, it was quickly confirmed that the structures was occupied. AFR crew's performed fire attack while also rescuing an unconscious victim located in the kitchen area of the home. Fire rescue 18 performed CPR on the patient and return of circulation was achieved by rescue crews. The patient was transported and saved due to the brave efforts of AFR crews on scene. The firefighters were able to get the fire under control quickly due to the quick efforts of the twenty two men and women of AFR on scene. There were no firefighters injured.

5. *AFR members visited the UNMH Children's Hospital to help support Childhood Cancer Awareness Month and once again brought smiles to children and adults alike! We appreciate UNMH for allowing us this opportunity to visit.*
6. *AFR Chaplain Lt. David Meyers and Red Shovel Director of Operations Larry Espinoza received a proclamation from Albuquerque City Council that the third Saturday of September will be Imagine, ABQ Day. Imagine, ABQ was spearheaded by David and Larry and encouraged volunteers from all over Albuquerque to help clean up their neighborhoods and business fronts, even offering free cleaning supplies. The Imagine, ABQ team hopes that each year will grow with other initiatives.*

**INSPECTIONS DIVISION**

- In the final preparations for the 50th Balloon Fiesta, FMO has inspected, re-inspected, and permitted for over 120+ food vendors, hospitality, and mercantile tents. FMO inspectors were at the park the last week of September assisting the vendors with proper set up and issuing their permits. All the work leading up to the fiesta will hopefully ensure a safe and fun event.
- September was the National Children's Cancer Awareness month. FMO visited the UNMH's Children's Unit with Sparky, his fire truck, and Hydro. Sparky, who is always the fan favorite, interacted with all the children and staff. He talked with everyone and put a smile on every face. Hydro, our remote-controlled fire hydrant and the Sparky driven fire truck were also big hits with the children. With his lit-up eyes and his siren, Hydro was literally spinning circles around the children and staff. The Sparky drive fire truck drove in and out of each room and put a smile on every child's face.
- FMO worked with Netflix to approve a 8,000 sqft free standing, digital screen wall held up by a vertical truss system. This is similar to a green screen only the image is in real time so the actors see what the audience will see. Currently this is the largest screen of its kind in the world. Working closely with FMO, Albuquerque's movie industry continues to make strides.

The properties are labeled on the First Due application with a white "X" on a red background. In the field these properties are marked with a red spray painted "X" and the letters "AFR" under it.

- Plans Checking would like to congratulate Laura Pavatt on her retirement after 24 years of service with Albuquerque Fire Rescue. We want to wish her all the best on the new chapter of her life. She will be truly missed.
- Plans Checking started preliminary reviews with the architects and engineers of the Albuquerque Sunport major renovation project. The project will begin in January 2023, and is estimated to cost \$85 million. The project is to relocate the TSA screening checkpoint and modernize the Sunport's fire suppression, HVAC, plumbing, mechanical and electrical infrastructure. The team has proposed to sprinker 100% of the Albuquerque Sunport in a phased project.

**FIRE INVESTIGATIONS DIVISION**

- On September 1st, Fire Investigators responded to the Mountain View Apartments to determine origin and cause of a structure fire. This was a second alarm fire and determined to be accidental, which happened when a third-party company was resurfacing the countertops in the apartment of origin.
- On September 4th, Fire Investigators and APD Officers made an arrest in the downtown area in connection to an arson investigation. A suspect was identified and charged with felony arson along with other felony charges. The individual was booked at the Metropolitan Detention Center with multiple felony charges.
- In early September, Investigator Steven Nelson completed a two-week Firearms Instructor Course (FIC) and is now the division's second Firearms Instructor. He will be able to instruct with APD and other law enforcement agencies in the metro area during their firearms training blocks.
- Investigator Oscar Vasquez is a member of AFR's new Ambassador Program. Investigator Vasquez is helping create a bridge for aspiring APS high school students interested in public safety, community service, and potentially a career as an Albuquerque Firefighter.
- Lieutenant David Auge was a contributing member to the 9/11 Memorial Stair Climb Committee. He helped coordinate the 9/11 memorial event held at Civic Plaza.
- The interview and selection process were completed. One Driver was selected to attend the next APD Law Enforcement Academy which begins in December 2022.
- Lieutenant Gunderson provided instruction during the September Lieutenant Certification Course. Topics of instruction included division staffing and resources, call out criteria, expectations of the company officer when on scene of a suspicious fire, and Youth Fire Awareness Program.
- Socktober is underway! AFR partnered with Locker 505 Clothing Bank and delivered Socktober boxes to all AFR fire stations, the Fire Marshal's Office, and Training Academy.

## HEAVY TECHNICAL RESCUE

- HTR assigned members were able to complete a large animal technical rescue course offered to us by our mutual aid partners of Corrales fire department. AFR trained alongside many of our fellow first responders to learn animal behavior and technical rescue systems to help our four legged friends.
- 14 members of AFR completed their rope operations course this month increasing our experience to provide technical rescue in the city and wilderness settings. These trained members will be able to support our mission for search and rescue, industrial rescue, and Wildland fire deployments.



**FOC**

- In the month of September, the FOC welcomed a new member at the rank of Lieutenant. Lieutenant Clayton Vincent was selected after interviews were conducted. This position will maintain FOC responsibilities for C Shift while supervising the entire Field Operations Center. The Lieutenant has been tasked with learning the inner workings of the FOC and determine issues that impact efficiency and the FOC's ability to maintain staffing. This Lieutenant will recommend and implement necessary changes. Direct supervision in this capacity will also ensure consistency between all shifts and in the application of AFR's Staffing Policy and the current Collective Bargaining Agreement. We are excited to see the improvements that come with this change.

**SPECIAL EVENTS**

- The Special Operations division collaborated with State Police and UNMH's Medicine Bow to establish an event plan that provided for the safety of the 2022 NM State Fair's attendees. 
