SIGNIFICANT EVENTS

fire was quickly extinguished and no injuries reported.

11/4 - Commercial Structure Fire: AFR crews responded to the 8000 block of Central NE in fire district 5 to the abandoned Fair and Square building to find the boarded up entrance on fire. Crews extinguished the fire with damage isolated to the entrance and no injuries reported.

11/5 - Mobile Home Fire: AFR was dispatched to a mobile home on fire near Edith and Gomez Av NE in fire district 4. Crews were able to extinguish the fire and prevent damage to adjacent units. No injuries reported.

11/11 - Residential Fire: AFR crews responded to a mutual aid fire on the 10600 block of Corona Ranch SW in fire district County 33 to a residence with smoke showing. Crews entered through the front door and extinguished a fire in the utility room. The family was alerted to the fire from the some alarm and safely evacuated.

11/12 - Residential Fire: In fire district 22, AFR crews were dispatched to a home with reports of flames and smoke. On arrival of a single story residence on the 10500 block of La Paz Dr NW, AFR crews recognized a working fire on the porch extending into the living room. The fire was extinguished and no injuries were reported. The homeowner was alerted by the smoke alarm and evacuated with his dog.

11/1 - Apartment Fire: AFR crews dispatched to 9600 block of Central NW in fire 11/12 - Active Shooter: AFR units were dispatched to reports of shots fired at district 14 and reported light smoke showing from a multifamily dwelling. The the Ben E. Keith Food Warehouse in fire district 2 on the 3200 block of Broadway SE. Three patients were transported to UNMH and were listed two days later in satisfactory condition thanks to the brave efforts of multiple agencies involved.

> 11/14 - Apartment Fire: AFR crews dispatched to the 1300 block of Chelwood Park Blvd NE to a single story four-plex in fire district 8. Crew found heavy flame and smoke that was extinguished. One apartment suffered extensive damage with smoke damage to the adjacent units. Three pets were rescued and no injuries reported other than one patient with minor smoke inhalation.

> 11/15 - MCI MVA: AFR was dispatched to the intersection of Coal and 2nd St SW in fire district 1 for an MVA involving a commercial food truck and a small school bus. 1st glarm medical dispatch was utilized and 12 of 15 patients were transported in stable condition.

> 11/16 - Residential Fire: AFR Engine 17 was dispatched to a two story residence is fire district 10 on the 2400 block of Rose Av NW with heavy smoke and flame showing. Additional resources arrived and the fire was extinguished within ten minutes. The occupancy was vacant and no injuries were reported.

11/18 - Residential Fire: AFR units were dispatched to a multiple vehicle fire that threatened nearby structures at the intersection of Corona and San Pedro NE in fire district 20. Engine 20 made a quick attack and extinguished the fire that damaged three vehicles and one trailer.



Albuquerque Fire Rescue had another busy month working within the community to educate and make a positive difference in our community. The Homeland Security and Emergency Management Division reported reaching 250 citizens with the "Stop the Bleed" program that teaches basic first aid and bleeding control in the event of an emergency. In addition to that, the HSEM also performed "Risk Assessments" to a school and community center this month reaching approximately 350 people. These assessments help institutions identify

threats, vulnerabilities, consequences and mitigation options to various hazards. The **Fire Marshal's Office** reported training 2,125 children and 565 adults this month in fire prevention. This training can include topics such as the use of fire extinguishers and household evacuation plans in the event of a fire.

Over 12 station tours and 5 show-and-tell events were given across the city by our field crews this month. These interactions give our members the opportunity to talk about fire safety and about what we do on our 48 hour shifts as a firefighter serving the community.

ALBUQUERQUE FIRE RESCUE FIRE CHIEF'S MONTHLY REPORT

FIRE CHIEF PAUL W. DOW NOVEMBER | DECEMBER 2018

New Firefighters: On Friday, December 14th, 2018 Albuquerque Fire Rescue graduated our 92nd cadet class. After 20-weeks of Fire/EMS training, we now have eighteen new men and women ready to serve this wonderful community. This additional staffing will help provide some relief to those firefighters working in the field. However, including our new firefighters and the scheduled retirements, we will still start 2019 down over 35 positions.

Open Enrollment Process: From December 20th, 2018 to the end of January 2019, AFR will accept applications for our next Cadet Class. This will be our first open enrollment process that includes several new requirements. These changes include the following; minimum age to apply went from 21 years to 18 years, and a new minimum requirement of 15 college-level credit hours or two years of military service with an honorable discharge. Applicants also need to have a valid CPAT Certification and a current NM or National Registry EMT license.

Marketing & Brand Development: Last week, a comprehensive report was presented to AFR from the University of New Mexico Small Business Institute and Anderson School of Management. The reports intended purpose was to analyze media plans and evaluate the effectiveness of the departments existing recruitment strategies. By implementing the recommendations in this report, we will strengthen our recruitment efforts to attract a more diverse and qualified group of candidates to our department.

IAFF & AFR 2018 Awards: At this year's IAFF Local 244 Christmas Party, we celebrated the accomplishments of several firefighters. On each of the three shifts, Fire Station 5 was selected as the Station of the Year for their outstanding dedication and compassion to the community when they organized and hosted the Station 5 Haunted House & Carnival this past Halloween. H.E.A.R.T. was selected as the Support Division of the Year for their ability to start and operate a successful program in such short period of time. Their efforts have helped reduce the reliance on emergency services from some of our most common 911 callers. This frees up our front line apparatus to respond to emergency calls. Finally, Lieutenant Matthew Blanchfield was recognized as Firefighter of the Year for his incredible leadership and commitment to his fellow firefighters.

Wildland Grant Application: AFR has submitted a pre-disaster Mitigation grant application to NM-DHSEM. This grant will help fund the removal of hazardous fuels, i.e., vegetation, dead/down timber and invasive species within the Bosque. The grant application was for one million dollars, which would allow us to thin 1,000 acres. The priority areas identified in the Bosque are Montano (SW side), Central (all four sides approx. mile each direction), and Bridge (all four sides approx. mile each direction). We plan to use on-call contractors to complete this work. This will still allow each city department to run at full capacity while the project is completed. Receiving this funding and completing these fuel reduction projects will help decrease the risk of catastrophic wildfires in these areas. As a result, this will protect our treasured lands, lessen the danger to values at risk adjacent to these areas, i.e. the Zoo, Botanical Gardens, homes, city parks, schools, water treatment facilities, and roadways. We should know if we will be awarded these funds within the next six months.






CITY COUNCIL DISTRICT FIRE STATIONS

<u>INCIDENT RESPONSES</u> is the number of calls dispatched to a specific station in one of three categories; <u>EMS</u>, <u>FIRE</u>, and <u>OTHER</u>. The total incident responses is the sum of the three categories and not to be confused with the sum of specific apparatus calls. One response may include more than one apparatus. For example: Engine 13, Rescue 13 and Ladder 13 may respond to the same call but will be counted as 1 incident. The next dispatch might only assign Rescue 13 and will be counted as 1 incident. Therefore, the total incident number will be less than the sum of all apparatus calls for the month.


<u>PRIMARY APPARATUS RESPONSE</u> is the amount of calls taken in a specific fire district by that station's apparatus and is represented as the <u>IN DISTRICT</u> percentage (a fire district is defined by the number of the fire station and has a fixed geographical boundary). There are times when the in district apparatus is unavailable and an out of district apparatus must be dispatched, represented by <u>OUT OF DISTRICT</u> percentage. For example, Station 7 responded to 84.60% of the calls located in fire district 7. Apparatus from outside districts responded to 15.40% of the calls located in fire district 7.


















