#### **Hospital Systems Reports**

**Lovelace**- Dr Lahr stated that they are having issues with turnaround times with Albuquerque Ambulance. They also have a new Medical Director for the Heart Hospital. Nurse staffing is an issue continually.

VA- Dr. Khalsa mentioned that their ICU capacity is less because of the nurse storage. The VA has a Tier level of care that they strictly adhere too. He is trying to get people on board with the Stroke/Stemi data collection.

**Presbyterian**- Dr. Medoro concurred that they are seeing increased turnaround times along with staffing issues as well. There volume peaked in July, August and September. There will be a delay in opening another Pres Now until January 2022.

**UNM**- Dr. Habrat echoed the increase turnaround time and staffing issues. She also mentioned the "Crisis Standard of Care."

**EMS Volume and Drop Times communications to Hospital:** Dr. Medoro crafted a letter that was sent to Dr. Pruett, who will direct to the appropriate department heads.

PAC- Deputy Chief Chris Ortiz-mentioned the next meeting is scheduled for November 8, 2021.

**Crisis Standards of Care enactment in NM**-the State EMS should take the lead. That increase in volume and the nursing shortage has caused floors to be closed.

#### **Protocol Updates/Discussion-**

- I. Kirtland Fire First Responders-Dr. Barrett is the Medical Director and first order of business is to get things organized on 1 set of protocols not just using what they inherited from the Air Force.
- II. SANE-Dr. Pruett revamped the Title of the guideline from Trauma Sexual Assault to Sexual Assault and/or Domestic Violence.
- III. Ideas and Suggestions for Annual Guideline Updates-Dr. Pruett stated that the release of updates will be in January 2021. She also mentioned that "Alcohol Withdrawal" has its own guideline.

#### **Research Updates/Discussion**

Massimo Project Update-Dr. Pruett stated that they are under way and gathering numbers for cardiac arrest. They have reported 42 from July-October.

**Mobile ECMO-** Dr. Pruett said that since they went live it has had a stuttering start.

Dr. Lahr said to Dr. Medoro that with the openings of the Pres Now facilities would hopefully alleviate the stress on the main Emergency Rooms.
