| PERMIT APPLICATION: Permit application for fireworks display shall be made not less than 14 days prior to the scheduled date of the display. | F D O R D 5608.2 |
| APPLICATION ELEMENTS: All pertinent information, name, address, phone, email (individual, group, or organization sponsoring outdoor fireworks display), Financial Responsibility, distributor license from State Fire Marshal, ATF license, Date and Time of show with back up date if cancelled, exact location of display, number of assistants, quantity and types of Fireworks, location and means storage prior to delivery, Site Plan clearly depicting size and location in which fireworks will be discharged, spotters locations, security locations, shooter's position, base operations, likely wind direction, location and distances of all buildings, highways, overhead obstruction's, lot lines and clearly identifiable safe audience locations with corresponding barriers. | |
| APPLICATION APPROVAL: Upon approval billing will be generated and sent, referral created and assigned to an inspector, Test Shot scheduled, Permit to be issued at time of test shot. | NFPA 1123 10.3.1 |
| FEES: A \$100.00 Explosives Permit Fee is required. Fire Service Statement with \$55.25 an hr. per inspector (minimum 4hrs.) and a Pumper Fee of \$247.02. | FDORD 8302.4B |
| KEY OR LEGEND: A Key or Legend is required on the Site plan (including Fallout Zone) defining all of the symbols and abbreviations. | NFPA 1123 Annex E. 5.1.1 |

| FALLOUT ZONE: Zone shall be electronically drawn. A color aerial view map (google Maps) with the fallout zone and pertinent information overlaid onto the map is required. | NFPA 1123 5.1.2.2 |

| FIRING AREA: Detailed aerial site plan of firing area, product size and positions, distances from shells to perimeter of fallout zone, distances in relation to each other ie. Racks from cakes etc, North Directional Arrow, predicted wind direction. | NFPA 1123 5.1.2.2 |
| ANGLING OF MORTARS: Any angling of mortars must be specified and fallout zone adjusted accordingly. | NFPA 1123 5.2.1.4 |
| EMERGENCY ACCESS: Shall be clearly defined with in Fallout Zone and shall be clear for access prior, during, and after the event. | NFPA 1123 7.4.2 |
| Wiring Layout: Any wiring crossing emergency access shall be diverted as to not block access. | NFPA 1123 7.4.2 |
| STORAGE / TRANSPORTATION: Type 4 Magazine shall be required for storage on site, shall be out of the fallout zone, and security personnel, not less than 1 competent 21 year old individual shall remain in place 24/7. | NFPA 1123 4.2.1 |
| SPOTTERS: A list consisting of amount of spotters, extinguishers, their respective positions with in fallout zone and confirmation that they will adhere to the PPE requisite (long sleeve cotton shirt, long pants, helmet, eye, ear, and foot protection) is required. | NFPA 1123 3.3.43 |
| BASE OPERATIONS: Shall be depicted on site plan. | |
| FALLOUT ZONE SECURITY: A list of security, their positions, who will be responsible for crowd control, Radio contact with Fireworks Co. | NFPA 1123 Annex E. 6.1 |
