RESOLUTION NO. 2018- (1)

NOTICE REQUIREMENTS FOR MEETINGS OF THE COUNCIL

WHEREAS, the City of Albuquerque ("City") Americans With Disabilities Advisory Council ("Council") met in regular session at the City Council Committee Room, 9th Floor, Suite 9081 of the (City Hall) Albuquerque/Bernalillo County Government Building, One Civic Plaza NW, Albuquerque, NM, ________, at 5:30 p.m., as required by law; and

WHEREAS, Section 10-15-1(B) (NMSA 1978) of the Open Meetings Act states that "[A]ll meetings of a quorum of members of any board, commission, administrative adjudicatory body or other policymaking body of any state agency, any agency or authority of any county, municipality, district or any political subdivision, held for the purpose of formulating public policy, including the development of personnel policy, rules, regulations or ordinances, discussing public business or for the purpose of taking any action within the authority of or the delegated authority of any board, commission or other policymaking body are declared to be public meetings open to the public at all times except as may be otherwise provided in the Constitution of New Mexico, or the provisions of the Open Meetings Act;" and

WHEREAS, any meetings subject to the Open Meetings Act at which the discussion or adoption of any proposed resolution, rule, regulation or formal action occurs shall be held only after reasonable notice to the public; and

WHEREAS, Section 10-15-1(D) of the Open Meetings Act requires the Council to determine annually what constitutes reasonable notice of its public meetings; and

WHEREAS, Section 2-6-1-4(B) (ROA 1994) of the City of Albuquerque Public Boards, Commissions and Committees Ordinance requires that every public board, commission or committee created by the City of Albuquerque must determine what is reasonable notice to the public of its meetings; provided that in no event shall notice be less than the notice required for Albuquerque City Council meetings;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALBUQUERQUE AMERICANS WITH DISABILITIES ADVISORY COUNCIL that:

Section 1. Unless otherwise specified, all meetings of the Board shall be held monthly at the City Council Committee Room, 9th Floor, Suite 9081 of the (City Hall) Albuquerque/Bernalillo County Government Center Building, One Civic Plaza NW; Albuquerque, NM.

Section 2. Unless otherwise specified, regularly scheduled meetings of the Board shall be held on the first Tuesday of every month. Public notice in writing of any other regularly scheduled meetings will be given at least five (5) days in advance of the meeting date. The agenda for a regularly scheduled meeting will be available to the public at least 72 hours (3 days) prior to such meeting. Copies of the agenda will be available to the

public upon request from the Director of the Office of Diversity and Human Rights, whose phone number is 505-768-4712 and whose office is located in the Albuquerque/Bernalillo County Government Center Building at 1 Civic Plaza NW, Albuquerque, NM 87102.

Section 3. Special meetings of the Board may be called by the Chairperson of the Board or by a majority of the Board members upon three (3) days' advance notice. The agenda for a special meeting will be available to the public at least seventy-two (72) hours prior to such special meeting. Copies of the agenda will be available to the public upon request from the Director of the Office of Diversity and Human Rights, whose phone number is 505-768-4712 and whose office is located in the Albuquerque/Bernalillo County Government Center Building at 1 Civic Plaza NW, Albuquerque, NM 87102.

Section 4. Emergency meetings of the Board will be called only under unforeseen circumstances that demand immediate action by the Board to protect the health, safety and property of citizens or to protect the public body from substantial financial loss. The Board will avoid holding emergency meetings whenever possible. Emergency meetings may be called by the Chairperson or a majority of the Board members upon twenty-four (24) hours' notice, unless threat of personal injury or property damage requires less notice. Public notice for an emergency meeting shall include an agenda for the emergency meeting.

Section 5. For all meetings described in this resolution, public notice requirements are met if:

A. A printed notice of the date, time and place of the meeting is posted for public viewing in the following location: in the 1st floor lobby of the Albuquerque/Bernalillo County Government Center (City-County Building) at 1 Civic Plaza NW, Albuquerque, NM 87102.

B. An electronic copy of the notice is posted on the Board web page. Currently, the Board web page address is:

https://www.cabq.gov/americans-with-disabilities-act-advisory-council/?a and this website address may change from time to time as needed by the City or the Board.

C. Notice shall also be sent electronically to those broadcast stations (radio and television) licensed by the Federal Communications Commission (FCC) and newspapers of general circulation in the State of New Mexico that (i) have submitted a written request for notice of public meetings to the Director of the Office of Diversity and Human Rights, whose office is located in the Albuquerque/Bernalillo County Government Center Building at 1 Civic Plaza NW, Albuquerque, NM 87102, and (ii) have provided an electronic mail (e-mail) address to which public notices are to be sent. Currently, the Board finds that the Director has not received any written requests for ongoing notice of all Board meetings from any FCC licensed broadcast stations or from newspapers of general circulation, located in New Mexico or anywhere else.

Section 6. In addition to the information specified above, all public notices shall include the following language:

"NOTICE TO PERSONS WITH DISABILITIES: If you are a person with a disability and require a reasonable accommodation to observe or participate in this meeting, please contact Ms. Nikki Joseph, whose phone number is 505-768-4539 and whose email address is: odhr@cabq.gov as soon as possible. Public documents, including the agenda and minutes, can be provided in various accessible formats. Please contact the office if a summary or other type of accessible format is needed. The meeting will occur in a room that is accessible to persons in wheelchairs, by use of an elevator."

Section 7. Notice of Cancellations of meetings of the Board, and notice of different meeting times and/or dates and/or locations, may be announced at prior meetings of the Board. Sudden cancellations of meetings may occur if a quorum of Board members cannot or unexpectedly fail to attend a previously scheduled meeting time. Different meeting dates and times may be needed if a regularly scheduled meeting date (such as a Monday) is a federal, state or city holiday and City offices are closed that day. And different meeting dates and/or times and/or locations may be needed for a regularly scheduled meeting date if there is inclement weather, or if the meeting location is not available for use, or for other reasons.

Section 8. Notice of committee meetings, if any committees are formed, shall be equal to that specified in Sections 2 and 3 of this resolution.

Section 9. The Board may close a Meeting of the Board to the public only if the subject matter of such discussion or action is exempted from the open to the public meeting requirement under Section 10-15- 1(H) (NMSA 1978) of the Open Meetings Act.

A. If any open meeting is closed during such open meeting, the closure shall be approved by a majority vote of a quorum of the Board taken during the open meeting. The specific provision of law authorizing the closed meeting and the subject(s) to be discussed shall be stated with reasonable specificity in the motion to close the meeting to public observation and the vote of each individual member on the motion to close the meeting shall be recorded in the minutes, in a roll call vote. Only those subjects specified in the motion to close the meeting may be discussed by the Board in the closed meeting.

B. If a closed meeting is conducted when the Board is not in an open meeting, the closed meeting shall not be held until a written public notice of the meeting of the Board, appropriate under the circumstances, stating the specific provision of law authorizing the closed meeting and the subjects to be discussed with reasonable specificity, is given to Board members and to the public.

C. Following completion of any closed meeting, the minutes of the open meeting that was closed, or the minutes of the next open meeting of the Board if the closed meeting was separately scheduled, shall state whether the matters discussed in the closed meeting were limited only to those specified in the motion to close the meeting or the public notice of a closed meeting.

119	D. Except as provided in Section 10-15-1(H) (NMSA 1978) of the Open Meetings
120	Act, any action taken as a result of discussions in a closed meeting shall be made by a
121	public vote of the Board in an open meeting.
122	Section 10. All resolutions, rules or parts of resolutions or rules, inconsistent with
123	this resolution, are hereby repealed only to the extent of such inconsistency. Such implied
124	repeal shall not be construed to revive any resolution, rule or part of any resolution or rule
125	that was previously repealed.
