## **MINUTES**

- I. Call to Order**
  - a. Meeting called to order by Vice Chair Dawn Begay at 2:06 pm.
- II. Approval of Agenda**
  - a. Vincent Galbiati motioned to approve the agenda. Gail Starr seconded the motion. Motion unanimously passed.
- III. Approval of Minutes from January 8, 2020 meeting**
  - a. Jessica Fierro moved to approve the January minutes. Gail Starr seconded the motion. Motion unanimously passed.

#### **IV. Subcommittee Updates**

- a. Vice Chair Dawn Begay reviewed a timeline for the task force and deadlines. The task force will have general meeting for their March, April and May meetings. Vice Chair Dawn Begay informed the task force she is hoping to have subcommittee recommendations for the June 10<sup>th</sup> meeting. Chair & Vice Chair will compile recommendation into a draft report between the June and July task force meetings. The draft report will be shared at the July meeting with the task force for final edits. All final edits will be made by August 12<sup>th</sup>. The final recommendations report will be submitted to the Mayor's office on August 14<sup>th</sup>.
  - i. Collaborations: considering and discussing the following possible recommendations, not finalized yet:
    - a. City sponsoring a clearinghouse/website that is consistently maintained with current information of all resources/best practices?
    - b. City pay a coordinator to be point person for DV?
    - c. Take recommendations from Platicas to the City?
    - d. Ask for City support to duplicate Platicas model with other communities
    - e. Education on DV for businesses/schools people are not at the table
  - ii. Funding: In the process of researching how the city provides funds currently and what gaps need to be filled. Their subcommittee will be meeting the 4<sup>th</sup> Tuesday every month but are still looking for a location.
  - iii. Policy: Broke down their recommendations and which City department they fell under. Inquired how far their recommendations could go and if it is possible to go the federal level. Discussions were redirected to how the City of Albuquerque could improve on domestic violence.

- a. All subcommittees will send notes to the Chair or Vice-Chair of any meetings held between regular scheduled task force meetings.

  - b. Other subcommittees had not set a specific yet for their next meeting.
- c. Task force would like to meet for a longer time during the next general meeting in March. A majority of the March meeting will be dedicated to subcommittee breakout, notes from other subcommittees will be shared but no updates from the subcommittees will be made until April or May.
- d. A budget guest will be asked to attend the April meeting to discuss funds for domestic violence.
