Glossary of Terms Related to Behavioral Health Services

Crisis Intervention Services: Services focused on addressing crisis events and facilitate access to care and try to divert people from hospital emergency departments and the justice system during behavioral crises. Services may include emergency triage, evaluation, and admission, withdrawal management, peer support, brief intervention, counselling, medication, and service navigation and referrals, such as through mobile crisis teams, community engagement teams, behavioral health crisis triage centers.

Intensive Case Management: Higher frequency of contact and may provide longer duration of support than short-term case management.

Intermediate Care After Hospitalization/Sub-Acute Care: Short term care for people who are released from hospitalization but need support to live independently, and is effective to prevent return to hospital services.


Jail Re-Entry: Services to assist people released from MDC to navigate the transition from jail back into society by providing connection to services as needed for substance use, mental health and to attain stable income and housing.

Peer Support: Peer support provides services by trained individuals with lived experience.

Prevention: Prevention includes early intervention programs that build self-regulation skills to reduce substance use, depression, suicidal ideation, and disruptive behavior.

Short-Term Case Management: Develop individualized plans and connection to services to support housing and behavioral health stability.

Supportive Housing: Rental support and case management to connect to services and maintain permanent housing.
