Re: Implementation of National Standards for the Physical Inspection of Real Estate (NSPIRE)

Dear, Name Here,

I'm writing to inform your agency about important updates to the standards required for housing quality. Please read this notice carefully for information about these standards, upcoming training, and deadlines for implementation.

The Department of Housing and Urban Development (HUD) issued Notice PIH 2023-28 regarding the Implementation of National Standards for the Physical Inspection of Real Estate (NSPIRE). The Notice provides guidance and the implementation date to transfer from utilizing the Housing Quality Standards (HQS) method to NSPIRE. The initial date of compliance was October 1, 2024; however, HUD has issued an extension to the compliance date for NSPIRE until October 1, 2025. The City has decided to utilize this extension. During monitoring of its partnering agencies, the City of Albuquerque will continue to inspect properties utilizing HQS until September 30, 2025.

Despite the extension for full implementation of the NSPIRE standards, there are some items that agencies will need to plan to implement earlier, including the following:

- 1) The smoke alarm standard will implement the requirements enacted in the Consolidated Appropriations Act of 2023, for either hard-wired or sealed, 10-year battery smoke alarms. Agencies will be required to be in compliance with this new standard before December 23, 2024, even if they are still under the previously defined HQS standard.
- 2) The standard for Carbon Monoxide Alarms is currently applicable and will apply during this extension, because, it implements Congressional requirements already in effect.

In order to prepare for this change and avoid findings in monitoring reviews occurring after September 30, 2025, it is highly recommended that your agency utilize the HUD developed trainings that includes a combination of PowerPoint presentations, infographics, and instructional videos that are posted on the NSPIRE website at <https://www.hudexchange.info/trainings/nspire-training/>.
