During these challenging times I respect Council's desire to help in so many ways with respect to our city's efforts to cope with the financial hardships associated with the Corona virus pandemic. After careful review of Ordinance R-20-32, I am exercising my authority to veto the legislation. I find it important in this matter to share my objections with this resolution, and to outline a reasonable path forward.

The original legislation was deemed legally deficient by the City's Legal Department due to its clear violation of the City Charter's provisions mandating a separation of powers between the legislative branch (City Council) and the executive branch (Mayor). I do appreciate the serious efforts made by the sponsors to address those fatal defects, and I also appreciate the floor amendments that were intended to address some of those concerns. Unfortunately, the amendment that puts the committee in the position to review all future federal funds reintroduced the same concerns regarding the direct violation of the separation of powers embraced by the City Charter.

The City Council consists of nine people elected to represent nine distinct Council Districts. Each Councilor represents a unique geographic area, and a unique constituency with needs that sometimes match those of the other Districts but that sometimes pertain only to that District. That is why we elect Council members by district, rather than at large.

COVID-19 has affected us all, but not all in the exact same ways. Health inequities, seen in well-documented preexisting conditions such as hypertension, obesity, diabetes, asthma, lack of access to quality health care, and underemployment, are all factors that increase COVID-19 complications. Those factors differ across socioeconomic groups, and across our nine Council Districts. During the floor debate, Councilors raised issues around equity with respect to each Councilor's individual ability to be part of the oversight process, and those issues are of also of major concern to my office. The existing committee structure and budget process accommodates all nine Councilors and strikes a time-tested balance between executive recommendations and legislative appropriation. This Resolution would conflate those issues by mixing legislative and executive authority, and disenfranchising non-appointed Councilors.

Of critical importance given the urgency of our public health emergency, the proposed ordinance would add extensive bureaucracy to a legislative process already pushing against reasonable burdens on timely execution of City actions. It was very apparent from the lengthy debate in Council that the advisory input of three Councilors at the beginning of the process will not expedite consideration of the executive's recommendation on using COVID funding. In fact, that debate suggests that the process will make that proposed process longer and more divisive.

The nine-member City Council body routinely considers the annual budget, and smaller appropriations and budget changes throughout the year, in a manner that enfranchises and treats each District equally and with utmost transparency because the Council looks for solutions to problems faced by the entire City. That is why when there is a need for committee work in the annual budgeting process, the Council sits as a Committee of the Whole.

I have no doubt that all nine Councilors want to do what is best during this health crisis and are willing to work together to find solutions. I agree with the comments of Council President Davis, Committee of the Whole Chair Benton and Councilor Jones about the need to bring transparency to the process, but the creation of an exclusive committee does exactly the opposite. A transparent process must include all Councilors. Rather than the new suggested process, the Administration finds that the Committee of the Whole structure, with Council Study Sessions, will provide transparency and equal representation for the constituents from every Council District, and will ensure the intent of the full Council is honored and achieved.

We look forward to working together through the existing robust budget process and Study Committees going forward.
