Meeting Minutes

- A. Dr. Bonham started the meeting where we had left off from the last meeting with the voting structure of the Committee, including a clarification of official voting members of APD.
- B. Discussion that these Articles in the Draft Bylaws were approved and needed no change:
 - Article 1; Article 2; Article 4; Article 6; Article 7; Article 8; Article 9; Article 10
- C. Changes were made to these Articles:
 - Article 3: Decided 18 members constitute of the Committee; 9 member for a quorum.
 - Article 5: A change to clarify that wherever the terms "Committee" and "Council" appear, these would be changed to "MHRAC." Subcommittee was more clearly defined to avoid confusion with "Committee."
- D. A motion was made whether to add a 19th slot as a member of the voting committee, but the motion did not pass.
- E. These following items were discussed and then decided upon:
 - 1. Does the MHRAC take public input at each meeting?
 - (1) Motion was to make this Article 11 and name it, Public Input.
 - (2) Motion was approved.
 - 2. Do we use names and credentials of the MHRAC members in the minutes of the meeting as distinguished from non-members and members of the public who may wish not to be identified?
 - a) Motion was made to remove credentials.
 - b) Another motion was made to make it as Article 12 and name it, Member Identification.
 - c) Motions were approved.
 - 3. How do we handle alternates for peer MHRAC members?
 - a) Motion was made to add to Bylaws as Article 13 and to add family members.
 - b) Motion was made to name it Alternates for Peer MHRAC Members.
 - c) Motion was made to adopt Bylaws as amended.
 - d) Motions were approved.
- F. The finalized By-Laws will be posted on the City's MHRAC Website

- G. Future Leadership of MHRAC
 - Danny Whatley, Rick Miera, and David Ley offered their names in nomination as co-chairs. David volunteered to withdraw his name in favor of Danny and Rick.
 - Motions on Co-chairs were approved by the Committee that Danny Whatley will be serving 1 year term and Rick Miera will be serving 6months term as co-chairs.

 - If we supply the Police Department with the information, who are they to share the information with?
 - How long is too long to keep information in database?
