# Response to Behavioral Health Incidents

## Types of Behavioral Health Response



1. ECIT Certified Field Services officers: These officers are assigned to Area Commands but have voluntarily received Enhanced Crisis Intervention Team (ECIT) training, which is an 8 hour course that must be refreshed every 2 years. All officers, receive 40 hours of Crisis Intervention Team (CIT) training during their time in the academy and are instructed to request backup from an ECIT certified officer if they determine an encounter has a behavioral health component. As of December 31, 2024, 62%\* of Field Services officers are ECIT certified. \*excludes Police Officers Second Class (P2C) who are not eligible for ECIT training.
2. Crisis Intervention Unit (CIU) Detectives: Detectives specialized in crisis intervention who are assigned cases with individuals suffering from more severe behavioral health issues and may pose a safety risk to themselves or others. They often conduct follow up with community members who were determined to have a behavioral health issue during an initial encounter with APD officers. They facilitate individuals receiving mental health intervention.
3. Civilian Clinicians: Licensed mental health professionals who work in conjunction with CIU detectives and the Mobile Crisis Team. They provide evaluations, complete general psychological assessments, assist in crisis intervention, conduct dangerousness assessments, and make referrals for individuals with behavioral health issues who interact with department personnel.
4. Mobile Crisis Team (MCT): MCT is a two-person unit comprised of one licensed mental health clinician paired with an ECIT trained officer. They respond to high-priority calls with a behavioral health component offering on scene evaluation and triage which often results in mental health transport. They do not conduct criminal investigation.

### **Albuquerque Community Safety (ACS) Update, Walter Adams**

- ACS Event to be held on behalf of the 100,000 call for service since our launch in 2021. The event will be held at 1210 San Mateo Blvd. NE on March 29, 2025 at 12:30.

### **Gateway Center and Health, Housing, & Homelessness Update, Ellen Braden**

- We currently have eight clients in the medical respite unit and can accommodate ten clients monthly until the unit becomes full.
- We opened our emergency winter shelter overflow unit for one or two nights the weekend before last due to Gateway West being at full capacity. We are monitoring the weather this week in case we need to open again.
- We continue our procurement process for FY26 Operations in Gateway men, women, family, first responders, medical sobering, and young adults. In FY26 they expect all those at some point to be operational.
- Gateway Recovery, we expect to be operational late this spring. This is for people who are housed or unhoused with early recovery and who have already been through detox.

### **APD, CIU, and BSS Update**

- We have a coordinator position opening up soon, Detective Ben Melendrez has retired.
- There are applicants for two APD MCT positions
  - One officer from the field will transfer soon
  - Another field Officer will transfer when the field releases him
- CIU has been to the legislature regarding House Bill 12, Extreme Risk Firearm Protection Orders (ERFPO), which has passed the House.
- We will be going again in regards to mental health competency
- Three CIU staff (coordinators) attended the International Association Chief of Police Conference for Officer Safety and Wellness.
- APD CIT 40-hour will be held again on April 27 – May 2, 2025
- eCIT Training is currently being reviewed by the APD Academy. That will be sent off to the State, “hopefully,” to get accredited. The curriculum has been revamped and we started a new basic and a new recertification.
- CIT ECHO and SCION direction- SCION targeted mental health support for our first responders through connecting and sharing stories on coping and other similar topics. We are hoping to get SCION back online soon.

### **Training and Infoshare Sub-Committee Update**

- We had a very successful, informational, and productive meeting with the Solid Waste Department on how they are approaching encampments, etc.
- We will be sending a formal request to ACOA Carla Martinez who is in the Mayor’s office to receive Solid Waste quarterly data regarding encampments. Co-chair Ryan Delaware was asked to draft some language to get to ACOA Carla Martinez
