Q&A

- Question: Is there a reason Iron is not included on the Subject Area map but is included in the Railroad MR Area Map?
 - o Response: This is a drawing error. The exhibit will be updated to include Iron.
- Question: Will third party market studies purchased by Respondents that are included in the proposal be released to the public?
 - Response: Any information included in a Respondent's Proposal may be made public.
- Question: How long will the selection process take?
 - Response: It is estimated that it will take 3 to 4 months for the selection to be made and advanced to the ADC.
- Question: Will Respondents not selected to receive funding be notified why their response was not selected?
 - Response: The cumulative scoring tally from the Selection Committee will be made available to Respondents.

Staff Clarifications

- **Financial Statement.** Respondents may elect to provide a narrative descriptive of the Developer's financial statements in their Proposal, and a statement that the Proposer will make full financial statements available for separate review by MRA or MRA's contracted 3rd party advisors
- **Multiple Projects.** MRA Anticipates funding multiple projects, and encourages projects both large and small.
- **Financial Assistance.** Assistance is based on financial need, determined by underwriting completed by MRA or MRA's contracted 3rd party advisors.
- **Conceptual Design.** Designs should be conceptual only. Full architectural drawings and renderings are not necessary to be considered for award.
