## Introduction

This report documents the speed study analysis on Constitution Avenue from Juan Tabo Boulevard to Morris Street in Albuquerque, New Mexico. The purpose of this project is to collect and analyze the traffic volumes, speed, and safety of Constitution Avenue, a two-way street, from Juan Tabo Boulevard to Morris Street to determine if it meets the traffic calming criterion described in the *City of Albuquerque (COA) Neighborhood Traffic Management Program (NTMP)*, October 2020, and the *Institute of Transportation Engineers (ITE) Traffic Engineering Handbook*, 6<sup>th</sup> Edition.

## Project Area and Background

The Constitution Avenue project is located in Albuquerque, New Mexico and is a two-lane, undivided major collector that runs east-west between Juan Tabo Boulevard and Morris Street. Juan Tabo Boulevard is a six-lane, divided principal arterial that runs north-south and intersects the east end of Constitution Avenue at a signalized intersection. Morris Street is a two-lane, undivided major collector that runs north-south and intersects the west end of Constitution Avenue at a four-way stop-controlled intersection. 


Figure 1: Project Area and Existing Traffic Volumes

A request has been made to the City of Albuquerque to determine if traffic calming is appropriate for this location. Wilson & Company was tasked by the City of Albuquerque to determine if Constitution Avenue warrants traffic calming measures.

## Existing Conditions

### Traffic Conditions

Constitution Avenue is an urban major collector with an Average Daily Traffic (ADT) of 4,598 vehicles and an existing speed limit of 30 mph. Existing tube count data (volume, speed, and class) was collected for 48-hours on Wednesday, October 14, 2020 and Thursday, October 15, 2020. The full traffic count data can be found in [Appendix A](#).

### Safety

#### Crash Data

Historical crash data was provided by the City of Albuquerque. Five years of crash data (2019, 2018, 2017, 2016, and 2015) were obtained to evaluate the existing safety condition of Constitution Avenue. See [Table 1](#) for crash summary.

### Crash Analysis

The following observations were concluded from the review of the five years (2019, 2018, 2017, 2016, and 2015) of crash data (28 total crashes). See [Appendix B](#) for crash reports.

- All 28 crashes occurred in clear conditions;
- All 28 crashes resulted in property damage;
- Out of the total crashes, 21 crashes occurred during the day.
- Out of the total crashes, four crashes involved excessive speed and could have possibly be fixed with traffic calming.

## Speed

Speed data was collected on Constitution Avenue for a 48-hour period on Wednesday, October 14, 2020 and Thursday, October 15, 2020. See [Table 2](#) for the percentage of vehicles exceeding the speed limit by 5 mph and 7 mph.

Speed data can be found in the traffic counts located in [Appendix A](#). At least 41% of vehicle speeds exceed the posted speed limit (30 mph) by 5 mph or more at Counter 1 and 59% at Counter 2. For Counter 1, at least 25% of vehicle speeds exceed the posted speed limit (30 mph) by 7 mph or more and 44% at Counter 2.

## Typical Sections

Constitution Avenue is a 44-ft wide asphalt roadway, which includes 4-ft bicycle lanes and 6-ft on-street parking. The roadway section has curb and gutter, and 4-ft wide sidewalks. 


Figure 5: Constitution Avenue Existing Typical Section

## NTMP Traffic Calming Criteria

In order to meet the traffic calming criterion described in the *COA NTMP*, one or more of the following threshold criteria must be met:

1. Over a twenty-four-hour period, 15% of the vehicles traveling in the study area exceeded 7 miles per hour over the speed limit.
2. Three reported crashes in a 5-year period where the police report identified speed as either a primary or contributing cause of the crash.
3. A crash involving a pedestrian or cyclist in a school zone in a five-year period.
4. Over a twenty-four-hour period more than 800 vehicles were counted traveling through the study area and 15% of the vehicles traveling in the study area exceeded 5 miles per hour over the speed limit.
5. Over a twenty-four-hour period, 15% of the vehicles traveling in the study area exceeded 5 miles per hour over the speed limit and there was at least one reported crash in a 5-year period where the police report identified speed as either a primary or contributing cause of the crash.
6. Over a twenty-four-hour period, 15% of the vehicles traveling in the study area exceeded 5 miles per hour over the speed limit and a field survey conducted by the Traffic Engineering Division determined that 25% of the peak hour traffic was cut-through traffic.
7. Over a twenty-four-hour period more than 800 vehicles were counted traveling through the study area and there was at least one reported crash in a 5-year period where the police report identified speed as either a primary or contributing cause of the crash.
8. Over a twenty-four-hour period more than 800 vehicles were counted traveling through the study area and a field survey conducted by the Traffic Engineering Division determined that 25% of the peak hour traffic was cut-through traffic.
9. A field survey conducted by the Traffic Engineering Division determined that 25% of the peak hour traffic was cut-through traffic and there was at least one reported crash in 5 years where the police report identified speed as either a primary or contributing cause of the crash.

## Summary of Results

Out of the 28 crashes that were reported in the past five years, four (4) could possibly have been corrected with traffic calming. The daily traffic volumes for Constitution Avenue were more than 800

vehicles. Over 15% of vehicle speeds exceeded the posted speed limit by 5 mph and by 7 mph. See [Table 3](#) for the summary of results for Constitution Avenue.

## Recommendations

After analyzing the crash, volume, and speed data, it was determined that Constitution Avenue does meet five of the nine (9) thresholds and, therefore, **does** meet the minimum traffic calming criterion as described in the COA NTMP.
