Bernalillo County Public Works Division is pleased to inform you that a master plan for a multi-use trail is in the initial stages of development for the Alameda Drain corridor. The master plan, when it begins, will apply the input gained from future neighborhood meetings to develop viable alternatives that will provide a trail, landscaping, water harvesting and rest areas along the Alameda Drain. All these alternatives will take the Middle Rio Grande Conservancy District's maintenance needs into account and utilize the principles of Crime Prevention Through Environmental Design. The master plan will offer design alternatives and suggestions for the Alameda Drain corridor from I-40 north to the Sandia Pueblo Boundary.

Once the master plan is finalized, a smaller portion of the project will move into the design and construction phases. The design phase will fine tune the concepts and generate a plan set that will be utilized for construction.

Your previous participation in public meetings regarding the North Valley has identified you as a stakeholder. As we move forward with the master plan effort we will reach out to you, additional stakeholders, residents, and commercial property owners to set up informational meetings where you will have the opportunity to share your ideas, comments and concerns. The meetings have not been scheduled yet but you will be notified as soon as they are.

MASTER PLAN EFFORT – June 2015 - January 2016

FINAL DESIGN – January 2016 - April 2016

CONSTRUCTION – July 2017

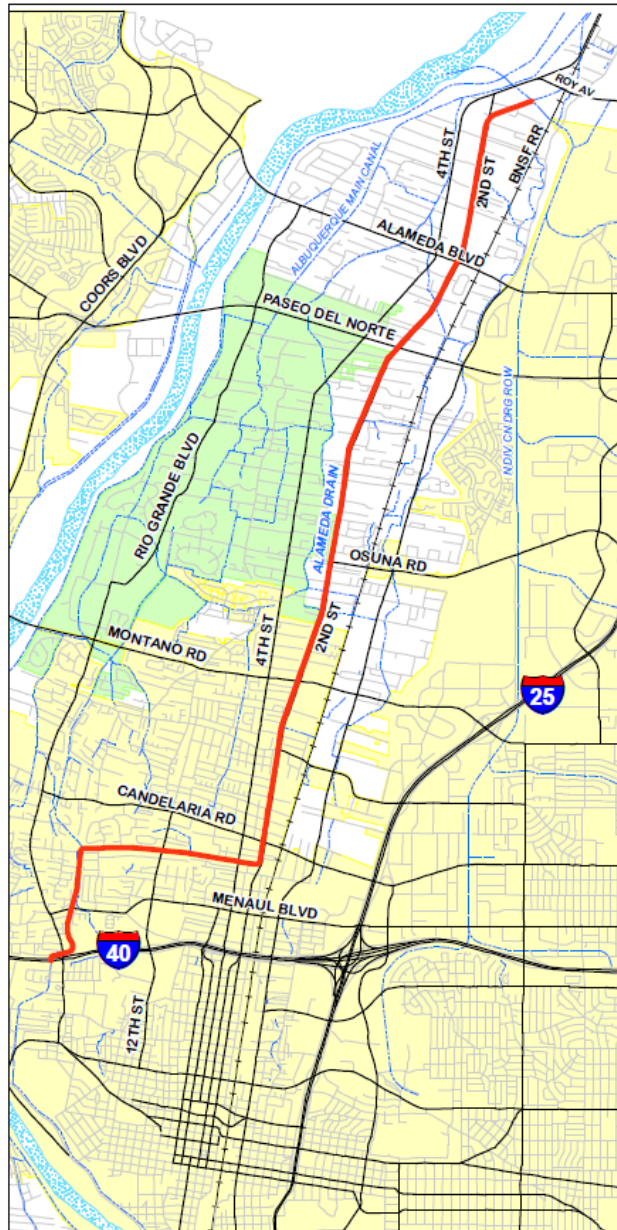
FINAL DESIGN – January 2016 - April 2016
